HOUSE CONCURRENT RESOLUTION NO. 3017

1	A concurrent resolution urging Congress to modify the Indian reservation system by vesting the
2	states with the ability to engage in relations with Native American tribes and with the
3	responsibility of developing plans to improve the failed Indian reservation system, advance and
4	elevate the quality of life on Indian reservations, promote and increase literacy on Indian
5	reservations, and help Indian reservations to achieve economic stability and independence.
6	WHEREAS, Section 8 of Article I of the United States Constitution vests Congress with the
7	authority to engage in relations with Native American tribes, thereby firmly placing tribes within
8	the constitutional fabric of the United States; and
9	WHEREAS, the term "Indian reservation" refers to the ancestral territory given over to a
10	Native American nation and there are approximately 565 federally recognized tribes and 326
11	Indian reservations in the United States; and
12	WHEREAS, the 1851 Indian Appropriations Act, which created the reservation system,
13	forced Native Americans to move to and live on reservations; and
14	WHEREAS, the purpose of the Indian reservation system, for the most part, was to remove
15	land from the Native Americans and segregate Native Americans from American settlers; and
16	WHEREAS, in 1934 Congress passed the Indian Reorganization Act to restore to Native
17	Americans management of their assets, to build a sound economic foundation for the people of
18	the reservations, and to return to the Native Americans local self-government on a tribal basis;

20	WHEREAS, the Indian Civil Rights Act of 1968 launched a new era of Indian self-
21	determination and generally aimed at facilitating tribal sovereignty or self-rule; and
22	WHEREAS, under the management of the federal Bureau of Indian Affairs, Indian
23	reservations continue to be among the poorest communities in the United States; and

1 WHEREAS, Native American communities suffer from high rates of poverty, unemployment, 2 youth suicide, and many Native Americans receive inadequate health care and live in 3 overcrowded and poor-quality homes; and 4 WHEREAS, the current Indian reservation system has become flawed and obsolete; 5 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF 6 NORTH DAKOTA, THE SENATE CONCURRING THEREIN: 7 That the Sixty-fifth Legislative Assembly urges Congress to modify the Indian reservation 8 system by vesting the states with the ability to engage in relations with Native American tribes 9 and with the responsibility of developing plans to improve the failed Indian reservation system, 10 advance and elevate the quality of life on Indian reservations, promote and increase literacy on 11 Indian reservations, and help Indian reservations to achieve economic stability and 12 independence; and 13 **BE IT FURTHER RESOLVED**, that the Secretary of State forward copies of this resolution
