- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the public service
- 2 commission; to amend and reenact section 49-01-05 of the North Dakota Century Code,
- 3 relating to the salary of public service commissioners; to provide for a legislative management
- 4 study; and to authorize a transfer.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds 7 as may be necessary, are appropriated out of any moneys in the general fund in the state 8 treasury, not otherwise appropriated, and from special funds derived from federal funds and 9 other income, to the public service commission for the purpose of defraying the expenses of 10 that agency, for the biennium beginning July 1, 2011, and ending June 30, 2013, as follows:

15	The annual salary of a commissioner is eighty-fivenir	<u>nety-two</u> thousand eigh	t hundred			
16	thirtytwenty-six dollars through June 30, 20102012, and ninetyninety-five thousand onesix					
17	hundred twenty-twoeleven dollars thereafter. All fees received or charged by any commissioner					
18	for any act or service rendered in any official capacity must be accounted for and paid over by					
19	the commissioner monthly to the state treasurer and must be credited to the general fund of the					
20	state.					
21	SECTION 4. TRANSFER AND REPAYMENT - BEG	INNING FARMER REV	OLVING LOAN

- 2 include all pipeline activity and address the jurisdiction of pipelines in the state in consultation
- 3 with the public service commission, industrial commission, and North Dakota one call. The
- 4 legislative management shall report its findings and recommendations, together with any
- 5 legislation required to implement the recommendations, to the sixty-third legislative assembly.
