- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the state board for
- 2 career and technical education; to provide for a report to the budget section; and to provide
- 3 borrowing authority to Williston state college.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds 6 as may be necessary, are appropriated out of any moneys in the general fund in the state 7 treasury, not otherwise appropriated, and from special funds derived from federal funds and 8 other income, to the state board for career and technical education for the purpose of defraying 9 the expenses of the state board for career and technical education, for the biennium beginning 10 July 1, 2013, and ending June 30, 2015, as follows:

1	SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO				
2	SIXTY-FOURTH LEGISLATIVE ASSEMBLY. The following amounts reflect the one-time				
3	funding items approved by the sixty-second legislative assembly for the 2011-13 biennium and				
4	the 2013-15 one-time funding items included in the appropriation in section 1 of this Act:

8	The 2013-15 one-time funding amounts are not a part of the entity's base budget for the				
9	2015-17 biennium. The state board for career and technical education shall report to the				
10	appropriations committees of the sixty-fourth legislative assembly on the use of this one-time				
11	funding for the biennium beginning July 1, 2013, and ending June 30, 2015.				
12	SECTION 3. REPORT TO BUDGET SECTION. The department of career and technical				
13	education shall report performance measures of the science, technology, engineering, and				
14	mathematics program to the budget section during the 2013-14 interim, including the increase				
15	of science, technology, engineering, and mathematics programs available to students; the				
16	increase in enrollment in science, technology, engineering, and mathematics programming at				
17	the secondary and postsecondary level; and the business partnerships created by the				
18	expansion of the science, technology, engineering, and mathematics programs.				
19	SECTION 4. SCIENCE, TECHNOLOGY, ENGINEERING, AND MATHEMATICS				
20	PROGRAM GRANTS - MATCHING REQUIREMENT. The grants - postsecondary line item in				
21	section 1 of this Act includes the sum of \$150,000 from the general fund for science, technology,				
22	engineering, and mathematics grants. Prior to awarding a grant from these funds, the state				
23	board for career and technical education shall verify that the grant recipient has available				
24	matching funds from private industry grants equal to the state grant award, for the biennium				
25	beginning July 1, 2013, and ending June 30, 2015.				
26	SECTION 5. WORKFORCE TRAINING GRANTS - I	MATCHING REQUIREMEN	T. The		
27	workforce training line item in section 1 of this Act includes the sum of \$1,000,000 from the				
28	general fund for workforce training grants to the trainND program for the purchase of				
29	appropriate equipment specific to each of the four quadrant's workforce training needs. Prior to				
30	awarding a grant from these funds, the state board for career and technical education shall

- 1 verify that the grant recipient has available matching funds from private industry equal to the
- 2 state grant award, for the biennium beginning July 1, 2013, and ending June 30, 2015.

3 SECTION 6. BORROWING AUTHORITY - APPROPRIATION - WILLISTON STATE

4 **COLLEGE - WORKFORCE TRAINING PROJECT.** Williston state college may borrow the sum

5 of \$2,500,000, or so much of the sum as may be necessary, from the Bank of North Dakota,

6 under the terms and conditions as determined by the Bank of North Dakota, for the workforce

- 7 training facility project, for the biennium beginning July 1, 2013, and ending June 30, 2015. The
- 8 proceeds of the loan authorized in this section are appropriated to Williston state college for the
- 9 purpose of constructing a workforce training facility for the biennium beginning July 1, 2013, and
- 10 ending June 30, 2015.
