- 1 A BILL for an Act to create and enact two new sections to chapter 6-09 of the North Dakota
- 2 Century Code, relating to the development and implementation of a skilled workforce student
- 3 loan repayment program; to provide a continuing appropriation; to provide for a transfer; to
- 4 provide an expiration date; and to declare an emergency.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1.** A new section to chapter 6-09 of the North Dakota Century Code is created

7 and enacted as follows:

8 Skilled workforce student loan repayment program - Development and

9 <u>implementation.</u>

- 10 <u>1.</u> <u>The Bank of North Dakota shall adopt rules to develop, implement, promote, and</u>
- 11 administer a skilled workforce student loan repayment program in conjunction with the
- 12 North Dakota university system and the North Dakota workforce development council
- with the intent of attracting and retaining individuals for professional or technical skills
 in high demand in this state.
- <u>The North Dakota workforce development council in cooperation with job service North</u>
 <u>Dakota shall use available labor market information to determine annually the eligible</u>
 high-demand and emerging occupations in this state.
- 18 <u>3.</u> The North Dakota workforce development council shall compile a list of qualifying
- educational programs by April first of each year. Qualifying educational programs may
 include degree or certificate programs.
- 21 <u>4.</u> <u>Graduates of qualifying educational programs from institutions or entities in this state</u>

may apply for the skilled workforce student loan repayment program. To be eligible to
 receive student loan repayment grants under the program, the applicant:

13		bala	ances for eligible applicants. The maximum annual student loan repayment grant

21	<u>8.</u>	<u>The</u>	e skilled workforce student loan repayment program must be a joint public and
22		priv	ate effort. The Bank of North Dakota shall provide one dollar of funding for each
23		one	e dollar of funding raised from the private sector.
24	<u>9.</u>	<u>The</u>	North Dakota university system in cooperation with the North Dakota workforce
25		<u>dev</u>	elopment council shall seek private matching funds for the skilled workforce
26		<u>stua</u>	dent loan repayment program. Any matching funds received must be deposited in
27		<u>the</u>	skilled workforce student loan repayment program fund.
28	SECTION 2. A new section to chapter 6-09 of the North Dakota Century Code is created		
29	and enacted as follows:

1 Skilled workforce student loan repayment program fund established - Continuing

- 2 <u>appropriation</u>.
- 3 The skilled workforce student loan repayment program fund is established as a revolving
- 4 <u>fund. All moneys deposited or transferred into the fund and interest earned on moneys in the</u>
- 5 fund are appropriated for the purposes of section 1 of this Act.

6 SECTION 3. TRANSFER - BANK OF NORTH DAKOTA - SKILLED WORKFORCE

7 STUDENT LOAN REPAYMENT PROGRAM FUND. The Bank of North Dakota shall transfer

- 8 the sum of \$5,000,000, or so much of the sum as may be necessary, from the Bank's current
- 9 earnings and undivided profits to the skilled workforce student loan repayment program fund
- 10 during the period beginning with the effective date of this Act, and ending June 30, 2021.
- 11 SECTION 4. EXPIRATION DATE. Section 2 of this Act is effective through June 30, 2021,
- 12 and after that date is ineffective.
- 13 **SECTION 5. EMERGENCY.** This Act is declared to be an emergency measure.
