1 A BILL for an Act to provide an appropriation for defraying the expenses of the commissioner of

2 university and school lands; to provide for transfers; to provide for distributions from permanent

3 funds; and to provide an exemption.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds 6 as may be necessary, are appropriated from special funds derived from the state lands 7 maintenance fund, the strategic investment and improvements fund, and the oil and gas impact 8 grant fund in the state treasury, to the commissioner of university and school lands for the 9 purpose of defraying the expenses of the commissioner of university and school lands, for the 10 biennium beginning July 1, 2017, and ending June 30, 2019, as follows:

21 SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO

22 SIXTY-SIXTH LEGISLATIVE ASSEMBLY. The following amounts reflect the one-time funding

23 items approved by the sixty-fourth legislative assembly for the 2015-17 biennium and the

24 2017-19 one-time funding items included in the appropriation in section 1 of this Act:

- SECTION 3. APPROPRIATION LINE ITEM TRANSFERS. Upon approval of the board of
 university and school lands, the commissioner of university and school lands may transfer
 between the various line items in section 1 of this Act, including transfers from the contingencies
 line item to all other line items. The commissioner shall notify the office of management and
 budget of each transfer made pursuant to this section.

SECTION 4. EXEMPTION - USE OF OIL AND GAS IMPACT GRANT FUND.

16 Notwithstanding any other provisions of law, the energy infrastructure and impact office line item 17 in section 1 of this Act includes \$221,735, or so much of the sum as may be necessary, from the 18 oil and gas impact grant fund for administrative costs associated with the fund.

19 SECTION 5. DISTRIBUTIONS TO STATE INSTITUTIONS. Pursuant to section 1 of

20 article IX of the Constitution of North Dakota, the board of university and school lands shall

21 distribute during the biennium beginning July 1, 2017, and ending June 30, 2019, the following

22 amounts, from the permanent funds managed for the benefit of the following entities:

7 SECTION 6. ONE-TIME ADJUSTMENT TO CERTAIN STATE INSTITUTION

- 8 **DISTRIBUTIONS.** The board of university and school lands shall make the following
- 9 adjustments to the distributions outlined in section 5 of this Act as a result of the misallocation of
- 10 mineral revenues between certain permanent funds. The proposed distribution adjustments
- 11 shall be one-time adjustments and represent the historic over or under payment to trust
- 12 beneficiaries that resulted from the misallocation of mineral revenues.

22 SECTION 7. STRATEGIC INVESTMENT AND IMPROVEMENTS FUND - GRANTS TO

- 23 AIRPORTS. The grants line item in section 1 of this Act includes the sum of \$24,100,000 from
- 24 the strategic investment and improvements fund for grants to airports impacted by oil and gas
- 25 development, for the biennium beginning July 1, 2017, and ending June 30, 2019. The
- 26 department of trust lands shall adopt grant procedures and requirements necessary for the
- 27 distribution of grants under this section.
