- 1 A BILL for an Act to amend and reenact section 14-09-10 of the North Dakota Century Code,
- 2 relating to familial duty to support for health services; to repeal section 50-01-19 of the North
- 3 Dakota Century Code, relating to familial duty to support for county welfare; to provide for
- 4 application; and to declare an emergency.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Section 14-09-10 of the North Dakota Century Code is
7 amended and reenacted as follows:

15	<u>2.</u>	Except as provided under subsection 3, a creditor may not recover under this duty of

17		<u>a.</u>	Recovery sought by a creditor is for the furnishing of necessary health services,		
18			which may include medical and long-term care services;		
19		<u>b.</u>	Recovery sought is from a parent or adult child who received a direct benefit from		
20			a disqualifying transfer of an asset under section 50-06.2-07 or 50-24.1-02.8;		
21		<u>C.</u>	Recovery being sought from this parent or adult child does not exceed the fair		
22			market gain resulting from the disqualifying transfer; and		
23		<u>d.</u>	Disqualifying transfer occurred within five years of the receipt of the necessary		
24			health services.

2		<u>a.</u>	Recovery is sought from a parent or adult child who acted in bad faith by		
3			misappropriating, misusing, or diverting income or assets of the other adult to		
4			prevent or avoid payment for necessary health services, which may include		
5			medical and long-term care services; and		
6		<u>b.</u>	The bad faith action occurred within five years of the receipt of the necessary		
7			health services.		
8	8 <b>SECTION 2. REPEAL.</b> Section 50-01-19 of the North Dakota Century Code is repealed.				
9	SEC		N 3. APPLICATION. This Act applies to a collection action to enforce liability for		
10	furnishing necessaries which occurs on and after the effective date of this Act.				
11	SEC		N 4. EMERGENCY. This Act is declared to be an emergency measure.
