- 1 A BILL for an Act to create and enact four new sections to chapter 15-10 of the North Dakota
- 2 Century Code, relating to the creation of the North Dakota commission on higher education
- 3 funding; to provide an expiration date; and to declare an emergency.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** A new section to chapter 15-10 of the North Dakota Century Code is created

6 and enacted as follows:

- 7 North Dakota commission on higher education funding Membership.
- 8 The North Dakota commission on higher education funding consists of:
- 91.a.The governor or an individual designated by the governor, who shall serve as the10chairman;
- 11 <u>b.</u> <u>The commissioner of higher education;</u>
- 12 <u>c.</u> <u>Two members of the state board of higher education, selected by the state board;</u>
- 13 <u>d.</u> <u>The chairman of the senate education committee or the chairman's designee;</u>
- 14 e. The chairman of the house education committee or the chairman's designee;
- 15 <u>f.</u> <u>The minority leader of the senate or the leader's designee;</u>
- 16 g. The minority leader of the house of representatives or the leader's designee;
- 17 <u>h.</u> <u>One legislator appointed by the majority leader of the senate; and</u>
- 18 <u>i.</u> <u>Two legislators appointed by the majority leader of the house of representatives;</u>

3	<u>1.</u>	Members of the North Dakota commission on higher education funding are entitled to						
4		reimbursement for actual and necessary expenses incurred in the same manner as						
5		state officials.						
6	<u>2.</u>	In addition, members of the legislative assembly who serve on the commission and						
7		the individual who is the owner or manager of a business located in this state are						
8		entitled to receive per diem compensation, in the amount provided for in section						
9		54-03-20, if they are attending meetings or performing duties directed by the						
10		commission.						
11	<u>3.</u>	The commissioner of higher education shall use up to forty thousand dollars from						
12		moneys appropriated in the system governance line item in the appropriation bill for						
13		the North Dakota university system office, as approved by the legislative assembly, to						
14		provide the compensation and reimbursements required by this section.

18	<u>1.</u>	In order to ensure the continued delivery and financing of a quality system of higher						
19		education in this state, the North Dakota commission on higher education funding shall						
20		examine alternative methods for funding higher education, including any funding						
21		method that is developed by the state board of higher education or others and which						
22		will reward:						
23		a. Specifically identified outcomes such as:						
24		(1) Increases in the number of degrees awarded;						
25		(2) Increases in the number of on-time graduations;						
26		(3) The number of degrees awarded to low-income students; and						
27		(4) Increases in the number of students retained beyond their first year; and						
28		b. Any other outcome considered desirable by the commission.						
29	<u>2.</u>	The North Dakota commission on higher education funding may:						
30		a. Examine a funding methodology that is based on the actual cost of delivering a						
31		quality education to the various cost categories of enrolled students, as						

1			determined by the commission, including online students, students whose		
2			programs require laboratory access, and graduate students, as well as any other		
3			categories of students;		
4		<u>b.</u>	Develop a system of weighted student costs, one of which could include the size		
5			of the educating institution; and		
6		<u>C.</u>	Assume that historic spending levels are the initial indicator of the actual cost of		
7			educating students.		
8	<u>3.</u>	<u>The</u>	North Dakota commission on higher education funding shall provide reports to the		
9		<u>legi</u>	slative management and the state board of higher education during the 2011-12		
10		<u>inte</u>	rim and the 2013-14 interim.		
11	11 SECTION 5. EXPIRATION DATE. This Act is effective through December 31, 2014, and				
12	after that date is ineffective.				

13 **SECTION 6. EMERGENCY.** This Act is declared to be an emergency measure.
