- 1 A BILL for an Act to amend and reenact subsection 7 of section 6-08.1-03, sections 12.1-31-07,
- 2 12.1-31-07.1, and 12.1-31-07.2, and subdivision f of subsection 1 of section 19-03.1-22.2 of the
- 3 North Dakota Century Code, relating to the definition and endangerment or exploitation of an
- 4 eligible adult; and to provide a penalty.

#### 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Subsection 7 of section 6-08.1-03 of the North Dakota Century
7 Code is amended and reenacted as follows:

- 8 7. For purposes of reporting suspected exploitation of a disabled adult or vulnerable-
- 9 elderly an eligible adult as defined by section 12.1-31-07. Nothing in this subsection
- 10 may be construed to impose upon a financial institution a duty to investigate an
- 11 alleged or suspected exploitation of a disabled adult or vulnerable elderlyan eligible
- adult or to make <u>anya</u> report to a governmental agency or law enforcement agency.
- 13 SECTION 2. AMENDMENT. Section 12.1-31-07 of the North Dakota Century Code is
- 14 amended and reenacted as follows:

#### 15 **12.1-31-07. Endangering** a vulnerable an eligible adult - Penalty.

- 16 1. In this chapter, unless the context otherwise requires:
- 17a."Caregiver" means a person who is responsible for the care of a disabled adult or18vulnerable elderlyan eligibleadult as a result of a familial or legal relationship, or19a person who has assumed responsibility for the care of a disabled adult or20vulnerable elderlyan eligible20vulnerable elderlyan eligible21care provider who is acting within the provider's legal scope of practice in22providing appropriate care or assistance to a disabled adult or vulnerable elderly-23an eligible adult who is the patient or client of the licensed health care provider.

2			a condition of physical or mental incapacitation due to a developmental disability		
3			or organic brain damage or mental illness or who has one or more physical or		
4			mental limitations that restrict the person's ability to perform the normal activities		
5			of daily living.		
6		<del>C.</del>	"Vulnerable elderly adult" means a person sixty years of age or older who is		
7			suffering from a disease or infirmity associated with advanced age and		
8			manifested by physical, mental, or emotional dysfunctioning to the extent that the		
9			person is incapable of adequately providing for the person's own health or		
10			personal care.		
11			"Eligible adult" means an individual who is at least sixty years old or a vulnerable		
12			adult as defined in section 50-25.2-01.		
13		<u>C.</u>	"Undue influence" means the use of a position of trust and confidence with an		
14			eligible adult to exploit or take advantage of that eligible adult through actions or		
15			tactics, including emotional, psychological, or legal manipulation.		
16	2.	Except as provided for by chapters 23-06.5 and 30.1-30, a caregiver who knowingly			
17		perf	orms an act that causes <del>a disabled adult's or vulnerable elderlyan eligible</del> adult's		
18		life t	to be endangered, health to be injured, or pre-existing physical or mental condition		
19		to de	eteriorate, or a caregiver who fails to perform acts that the caregiver knows are		
20		nece	essary to maintain or preserve the life or health of the disabled adult or vulnerable-		
21		elde	erlyeligible adult and the failure causes the disabled adult's or vulnerable elderly-		
22		eligible adult's life to be endangered, health to be injured, or pre-existing physical or			
23		men	tal condition to deteriorate, is guilty of a class B felony.		
24	SECTION 3. AMENDMENT. Section 12.1-31-07.1 of the North Dakota Century Code is

26	12.1-31-07.1. Exploitation of a vulnerablean eligible adult - Penalty.				
27	1.	A pe	erson is guilty of exploitation of a disabled adult or vulnerable elderlyan eligible		
28		adul	It if:		
29		a.	The person stands in a position of trust and confidence or has a business		
30			relationship with the disabled adult or vulnerable elderlyeligible adult and		
31			knowingly, by deception-or, intimidation, or undue influence, obtains or uses, or		

1			attempts to obtain or use, the disabled adult's or vulnerable elderlyeligible adult's
2			funds, assets, or property with the intent to temporarily or permanently deprive
3			the disabled adult or vulnerable elderlyeligible adult of the use, benefit, or
4			possession of the property, for the benefit of someone other than the disabled-
5			adult or vulnerable elderlyeligible adult; or
6		b.	The person knows that the disabled adult or vulnerable elderlyeligible adult lacks
7			the capacity to consent, and obtains or uses, or attempts to obtain or use, or
8			assists another in obtaining or using or attempting to obtain or use, the disabled
9			adult's or vulnerable elderlyeligible adult's funds, assets, or property with the
10			intent to temporarily or permanently deprive the disabled adult or vulnerable-
11			elderlyeligible adult of the use, benefit, or possession of the property for the
12			benefit of someone other than the disabled adult or vulnerable elderlyeligible
13			adult.
14	2.	Expl	loitation of a disabled adult or vulnerable elderlyan eligible adult is:
15		a.	A class A felony if the value of the exploited funds, assets, or property exceeds
16			fifty thousand dollars.
17		b.	A class B felony if the value of the exploited funds, assets, or property exceeds
18			ten thousand dollars but does not exceed fifty thousand dollars.
19		C.	A class C felony if the value of the exploited funds, assets, or property is in
20			excess of one thousand dollars but does not exceed ten thousand dollars.
21		d.	A class A misdemeanor if the value of the exploited funds, assets, or property
22			does not exceed one thousand dollars.
23	3.	It is	not a defense to a prosecution of a violation of this section that the accused did
24		not ł	know the age of the victim.
25	4.	This	section does not impose criminal liability on a person who has:
26		a.	Managed the disabled adult's or vulnerable elderlyeligible adult's funds, assets,
27			or property in a manner that clearly gives primacy to the needs and welfare of
28			that person or is consistent with any explicit written authorization; or
29		b.	Made a good-faith effort to assist in the management of the disabled adult's or-
30			vulnerable elderlyeligible adult's funds, assets, or property.

## 3 12.1-31-07.2. Criminal proceeding involving a vulnerable an eligible adult - Speedy 4 trial.

5 In a criminal proceeding in which a disabled adult or vulnerable elderlyan eligible adult is a 6 victim, the court and state's attorney shall take appropriate action to ensure a speedy trial to 7 minimize the length of time the disabled adult or vulnerable elderly eligible adult must endure the 8 stress of involvement in the proceedings. In ruling on anya motion or other request for a delay 9 or a continuance of proceedings, the court shall consider and give weight to any adverse impact 10 the delay or continuance may have on the well-being of the disabled adult or vulnerable-11 elderlyeligible adult. 12 SECTION 5. AMENDMENT. Subdivision f of subsection 1 of section 19-03.1-22.2 of the 13 North Dakota Century Code is amended and reenacted as follows:

f. "Vulnerable adult" means either a disabled adult or vulnerable elderly adult as
 those terms are the term is defined in section 12.1-31-0750-25.2-01.
