LB 716 amends provisions of the State Electrical Act by removing references to specific fees for licenses and renewals. The bill allows the State Electrical Board to set reasonable fees for examination, issuance, and renewal of licenses and registrations issued under the Act. The amounts set shall be enough to cover the costs incurred by the State electrical Division and the board in administering the Act. In addition, the fees shall be set in a manner that avoids unnecessary surpluses.

The State Electrical Division estimates no fiscal impact. Any fiscal impact to the Agency would occur if the Board decides to change any current fees due to the provisions of the bill.
