- 2 Revised Statutes of Nebraska; to change provisions relating to
- 3 participation in school-sponsored athletic activities; and to repeal

- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 79-2,136, Reissue Revised Statutes of Nebraska,

2 is amended to read:

3 79-2,136 (1) Each school board shall allow the part-time enrollment 4 of students who are residents of the school district pursuant to 5 subsections (1) and (2) of section 79-215 and who are also enrolled in a private, denominational, or parochial school or in a school which elects 6 7 pursuant to section 79-1601 not to meet accreditation or approval requirements and shall establish policies and procedures for such part-8 9 time enrollment. Such policies and procedures may include provisions permitting the part-time enrollment of such students who are not 10 residents of such school districts and may require part-time students to 11 follow school policies that apply to other students at any time the part-12 13 time student is present on school grounds or at a school-sponsored activity or athletic event. Part-time enrollment shall not entitle a 14 student to transportation or transportation reimbursements pursuant to 15 16 section 79-611. Nothing in this <u>subsection</u> section section to 17 exempt any student from the compulsory attendance provisions of sections 18 79-201 to 79-210 <del>79-207</del>.

(2) Each school board shall establish policies and procedures to 19 allow the participation of any student from a school which elects 20 pursuant to section 79-1601 not to meet accreditation or approval 21 22 requirements described in subsection (1) of this section in any extracurricular activities and events as defined in section 79-2,126 to 23 24 the same extent and subject to the same requirements, conditions, and procedures as students enrolled in the public school governed by such 25 board. Such policies and procedures may require such students 26 participating in extracurricular activities pursuant to this section to 27 28 enroll in no more than one course offered for credit by such school and 29 may require them to follow school policies that apply to other students when present on school grounds or at a school-sponsored activity or 30 athletic event. Participation in such extracurricular activities pursuant 31

- 1 to this section shall not entitle a student to transportation, except to
- 2 and from practices and events to the same extent as public school
- 3 students participating in such activities, or transportation
- 4 <u>reimbursements pursuant to section 79-611. Nothing in this subsection</u>
- 5 <u>shall be construed to exempt any student from the compulsory attendance</u>
- 6 provisions of sections 79-201 to 79-210.

- 8 Nebraska, is repealed.
