1 Section 1. Section 71-401, Revised Statutes Supplement,

- 2 2013, is amended to read:
- 3 71-401 Sections 71-401 to 71-469 <u>and sections 2 and 3 of</u>
- 4 this act shall be known and may be cited as the Health Care Facility
- 5 Licensure Act.
- 6 Sec. 2. (1) Any health care facility in which abortions,
- 7 other than abortions necessary to prevent the death of the woman, are
- 8 performed shall conspicuously post a sign, in a location specified in
- 9 subsection (3) of this section so as to be clearly visible to
- 10 patients, which reads:
- 11 Notice: It is against the law for anyone, regardless of
- 12 his or her relationship to you, to force you to have an abortion. By
- 13 law, we cannot perform an abortion on you unless we have your freely
- 14 given and voluntary consent. It is against the law to perform an
- 15 abortion on you against your will. You have the right to contact any
- 16 local or state law enforcement agency to receive protection from any
- 17 <u>actual or threatened physical abuse or violence.</u>
- 18 (2) The sign required pursuant to this section shall be
- 19 printed with lettering that is legible and shall be at least three-
- 20 quarters of an inch boldface type.
- 21 (3) A health care facility in which abortions are
- 22 performed that is a freestanding surgical outpatient clinic shall
- 23 post the required sign in each patient waiting room and patient
- 24 consultation room used by patients on whom abortions are performed. A
- 25 hospital or any other health care facility in which abortions are

1 performed that is not a private office or freestanding surgical

- 2 outpatient clinic shall post the required sign in each patient
- 3 admission area used by patients on whom abortions are performed.
- 4 (4) Any health care facility that fails to post a
- 5 required sign in knowing, reckless, or negligent violation of this
- 6 section shall be assessed a fine of ten thousand dollars. Each day on
- 7 which an abortion, other than an abortion necessary to prevent the
- 8 death of the woman, is performed in any health care facility during
- 9 which the required sign is not posted during a portion of business
- 10 hours when patients or prospective patients are present is a separate
- 11 violation.
- 12 (5) The sanctions provided in this section do not
- displace any sanction applicable under other law.
- Sec. 3. (1) Any health care practitioner facility in
- 15 which abortions, other than abortions necessary to prevent the death
- 16 of the woman, are performed shall conspicuously post a sign, in a
- 17 location specified in subsection (3) of this section so as to be
- 18 <u>clearly visible to patients, which reads:</u>
- 19 Notice: It is against the law for anyone, regardless of
- 20 his or her relationship to you, to force you to have an abortion. By
- 21 law, we cannot perform an abortion on you unless we have your freely
- 22 given and voluntary consent. It is against the law to perform an
- 23 abortion on you against your will. You have the right to contact any
- 24 local or state law enforcement agency to receive protection from any
- 25 <u>actual or threatened physical abuse or violence.</u>

1 (2) The sign required pursuant to this section shall be

- 2 printed with lettering that is legible and shall be at least three-
- 3 quarters of an inch boldface type.
- 4 (3) A health care practitioner facility in which
- 5 abortions are performed shall post the required sign in each patient
- 6 waiting room and patient consultation room used by patients on whom
- 7 <u>abortions are performed.</u>
- 8 (4) Any health care practitioner facility that fails to
- 9 post a required sign in knowing, reckless, or negligent violation of
- 10 this section shall be assessed a fine of ten thousand dollars. Each
- 11 day on which an abortion, other than an abortion necessary to prevent
- 12 the death of the woman, is performed in any health care practitioner
- 13 facility during which the required sign is not posted during a
- 14 portion of business hours when patients or prospective patients are
- 15 present is a separate violation.
- 16 (5) The sanctions provided in this section do not
- 17 displace any sanction applicable under other law.
- 18 Sec. 4. If any section in this act or any part of any
- 19 section is declared invalid or unconstitutional, the declaration
- 20 shall not affect the validity or constitutionality of the remaining
- 21 portions.
