- 1 A BILL FOR AN ACT relating to juveniles; to amend sections 29-2257, 29-2258, 43-246.01, 43-247, 43-254.01, 43-255, 43-256, 43-258, 2 3 43-272.01, and 43-284, Reissue Revised Statutes of Nebraska, and 4 sections 29-1816, 43-247.02, 43-248, 43-250, 43-251.01, 43-253, 43-254, and 43-281, Revised Statutes Cumulative Supplement, 2022; to 5 6 change provisions relating to filing deadlines; to eliminate 7 obsolete provisions; to reorganize and harmonize provisions; to 8 provide duties for the Revisor of Statutes; to repeal the original 9 sections; and to outright repeal section 43-247.04, Revised Statutes Cumulative Supplement, 2022. 10
- 11 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 29-1816, Revised Statutes Cumulative Supplement,
- 2 2022, is amended to read:
- 3 29-1816 (1)(a) The accused may be arraigned in county court or
- 4 district court:
- 5 (i) If the accused was eighteen years of age or older when the
- 6 alleged offense was committed;
- 7 (ii) If the accused was younger than eighteen years of age and was
- 8 fourteen years of age or older when an alleged offense punishable as a
- 9 Class I, IA, IB, IC, ID, II, or IIA felony was committed; or
- 10 (iii) If the alleged offense is a traffic offense as defined in
- 11 section 43-245<u>.</u>; or
- 12 (iv) Until January 1, 2017, if the accused was seventeen years of
- 13 age when an alleged offense described in subdivision (1) of section
- 14 43-247 was committed.
- 15 (b) Arraignment in county court or district court shall be by
- 16 reading to the accused the complaint or information, unless the reading
- 17 is waived by the accused when the nature of the charge is made known to
- 18 him or her. The accused shall then be asked whether he or she is guilty
- 19 or not guilty of the offense charged. If the accused appears in person
- 20 and by counsel and goes to trial before a jury regularly impaneled and
- 21 sworn, he or she shall be deemed to have waived arraignment and a plea of
- 22 not guilty shall be deemed to have been made.
- 23 (2) At the time of the arraignment, the county court or district
- 24 court shall advise the accused, if the accused was younger than eighteen
- 25 years of age at the time the alleged offense was committed, that the
- 26 accused may move the county court or district court at any time not later
- 27 than thirty days after arraignment, unless otherwise permitted by the
- 28 court for good cause shown, to waive jurisdiction in such case to the
- 29 juvenile court for further proceedings under the Nebraska Juvenile Code.
- 30 This subsection does not apply if the case was transferred to county
- 31 court or district court from juvenile court.

1 (3) For motions to transfer a case from the county court or district 2 court to juvenile court:

- 3 (a) The county court or district court shall schedule a hearing on such motion within fifteen days. The customary rules of evidence shall 4 5 not be followed at such hearing. The accused shall be represented by an attorney. The criteria set forth in section 43-276 shall be considered at 6 7 such hearing. After considering all the evidence and reasons presented by both parties, the case shall be transferred to juvenile court unless a 8 9 sound basis exists for retaining the case in county court or district court; and 10
- (b) The county court or district court shall make a decision on such 11 motion within thirty days after the hearing and shall set forth findings 12 for the reason for its decision. If the county court or district court 13 determines that the accused should be transferred to the juvenile court, 14 the complete file in the county court or district court shall be 15 16 transferred to the juvenile court and the complaint, indictment, or information may be used in place of a petition therein. The county court 17 or district court making a transfer shall order the accused to be taken 18 forthwith to the juvenile court and designate where the juvenile shall be 19 kept pending determination by the juvenile court. The juvenile court 20 shall then proceed as provided in the Nebraska Juvenile Code. 21
- (4) (c) An order granting or denying transfer of the case from 22 county or district court to juvenile court shall be considered a final 23 24 order for the purposes of appeal. Upon entry of an order, any party may appeal to the Court of Appeals within ten days. Such review shall be 25 advanced on the court docket without an extension of time granted to any 26 party except upon a showing of exceptional cause. Appeals shall be 27 submitted, assigned, and scheduled for oral argument as soon as the 28 appellee's brief is due to be filed. The Court of Appeals shall conduct 29 its review in an expedited manner and shall render the judgment and 30 opinion, if any, as speedily as possible. During the pendency of an 31

- 1 appeal from an order transferring the case to juvenile court, the
- 2 juvenile court may enter temporary orders in the best interests of the
- 3 juvenile.
- 4 (5) (4) When the accused was younger than eighteen years of age when
- 5 an alleged offense was committed, the county attorney or city attorney
- 6 shall proceed under section 43-274.
- 7 Sec. 2. Section 29-2257, Reissue Revised Statutes of Nebraska, is
- 8 amended to read:
- 9 29-2257 The Nebraska Probation System is established which shall
- 10 consist of the probation administrator, chief probation officers,
- 11 probation officers, and support staff. The system shall be responsible
- 12 for juvenile intake services, for preadjudication juvenile supervision
- 13 services under section 43-254-beginning October 1, 2013, for presentence
- 14 and other probation investigations, for the direct supervision of persons
- 15 placed on probation, and for non-probation-based programs and services
- 16 authorized by an interlocal agreement pursuant to subdivision (16) of
- 17 section 29-2252. The system shall be sufficient in size to assure that no
- 18 probation officer carries a caseload larger than is compatible with
- 19 adequate probation investigation or supervision. Probation officers shall
- 20 be compensated with salaries substantially equal to other state employees

- 6 43-250 (1) A peace officer who takes a juvenile into temporary
- 7 custody under section 29-401 or subdivision (1), (2), (3), or (7),
- 8 (5), or (8) of section 43-248 shall immediately take reasonable measures
- 9 to notify the juvenile's parent, guardian, custodian, or relative and
- 10 shall proceed as follows:
- 11 (a) The peace officer may release a juvenile taken into temporary
- 12 custody under section 29-401 or subdivision (1), (2), or (7) (4), or (8)
- 13 of section 43-248;
- 14 (b) The peace officer may require a juvenile taken into temporary
- 15 custody under section 29-401 or subdivision (1) or (2) (4) of section

- 29 juvenile and ascertaining his or her health and well-being and for
- 30 safekeeping while awaiting transport to an appropriate juvenile placement
