**LEGISLATIVE BILL 109**

Introduced by Blood, 3.

Committee:

- 1 A BILL FOR AN ACT relating to schools; to amend section 79-813, Reissue
- 2 Revised Statutes of Nebraska; to provide for issuance of a temporary
- 3 certificate or permit to the spouse of a military member based on
- 4 reciprocity as prescribed; to repeal the original section; and to
- 5 declare an emergency.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 79-813, Reissue Revised Statutes of Nebraska, is  
2 amended to read:

3 79-813 (1) The board may authorize the issuance of certificates or  
4 permits to applicants who hold a valid certificate or permit currently in  
5 force in a state other than Nebraska if the requirements for the  
6 certificate or permit held by the applicant are comparable and equivalent  
7 to those required for a similar type of certificate or permit issued  
8 under sections 79-806 to 79-815.

9 (2)(a) The board shall issue a temporary certificate or permit to a  
10 military spouse who complies with and meets the requirements of this  
11 subsection pending issuance of the certificate or permit under subsection  
12 (1) of this section.

13 (b) A military spouse shall submit the following with his or her  
14 application for the certificate or permit under subsection (1) of this  
15 section:

16 (i) A copy of his or her military dependent identification card  
17 which identifies him or her as the spouse of an active duty member of the  
18 United States Armed Forces;

19 (ii) A copy of his or her spouse's military orders reflecting an  
20 active-duty assignment in Nebraska;

21 (iii) A copy of his or her certificate or permit from another  
22 jurisdiction and the applicable statutes, rules, and regulations  
23 governing the certificate or permit;

24 (iv) A copy of his or her fingerprints for a criminal background  
25 check if required under section 79-808; and

26 (v) The fee required for the certificate or permit and the temporary  
27 certificate or permit under section 79-810.

28 (c) If the board determines that the applicant is a resident of  
29 Nebraska, is the spouse of an active duty member of the United States  
30 Armed Forces who is assigned to a duty station in Nebraska, holds a valid  
31 certificate or permit in another jurisdiction which has comparable and

1 equivalent requirements for the certificate or permit, has submitted  
2 fingerprints for a criminal background check if required under section  
3 79-808, and has paid the applicable fee, the board shall issue a  
4 temporary certificate or permit to the applicant.

5 (d) A temporary certificate or permit issued under this subsection  
6 shall be valid for six months and may not be renewed.

7 Sec. 2. Original section 79-813, Reissue Revised Statutes of  
8 Nebraska, is repealed.

9 Sec. 3. Since an emergency exists, this act takes effect when  
10 passed and approved according to law.
