- 1 A BILL FOR AN ACT relating to health and human services; to amend
- 2 sections 38-151 and 71-8701, Reissue Revised Statutes of Nebraska;
- 3 to provide additional fees for certain credentials; to provide for a
- 4 termination date; to create a fund; to harmonize provisions; to
- 5 provide an operative date; and to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 38-151, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 38-151 (1) It is the intent of the Legislature that the revenue to
- 4 cover the cost of the credentialing system administered by the department
- 5 is to be derived from General Funds, cash funds, federal funds, gifts,
- 6 grants, or fees from individuals or businesses seeking credentials. The
- 7 credentialing system includes the totality of the credentialing
- 8 infrastructure and the process of issuance and renewal of credentials,
- 9 examinations, inspections, investigations, continuing competency,
- 10 compliance assurance, the periodic review under section 38-128, and the
- 11 activities conducted under the Nebraska Regulation of Health Professions
- 12 Act, for individuals and businesses that provide health services, health-
- 13 related services, and environmental services.
- 14 (2) The department shall determine the cost of the credentialing
- 15 system for such individuals and businesses by calculating the total of
- 16 the base costs, the variable costs, and any adjustments as provided in
- 17 sections 38-152 to 38-154.
- 18 (3) When fees are to be established pursuant to section 38-155 for
- 19 individuals or businesses other than individuals in the practice of
- 20 constructing or decommissioning water wells and installing water well
- 21 pumps and pumping equipment, the department, with the recommendation of
- 22 the appropriate board if applicable, shall base the fees on the cost of
- 23 the credentialing system and shall include usual and customary cost
- 24 increases, a reasonable reserve, and the cost of any new or additional
- 25 credentialing activities. For individuals in the practice of constructing
- 26 or decommissioning water wells and installing water well pumps and
- 27 pumping equipment, the Water Well Standards and Contractors' Licensing
- 28 Board shall establish the fees as otherwise provided in this subsection.
- 29 All such fees shall be used as provided in section 38-157.
- 30 (4) In addition to the fees established under section 38-155, each
- 31 applicant for the initial issuance and renewal of a credential to

- 1 practice as a physician, osteopathic physician, or physician assistant
- 2 <u>under the Medicine and Surgery Practice Act, as a nurse under the Nurse</u>
- 3 Practice Act, as an occupational therapist under the Occupational Therapy
- 4 Practice Act, as a pharmacist under the Pharmacy Practice Act, or as a
- 5 physical therapist under the Physical Therapy Practice Act shall also be
- 6 charged an annual patient safety fee of ten dollars. Revenue from such
- 7 fee shall be remitted to the State Treasurer for credit to the Patient
- 8 Safety Cash Fund. The patient safety fee shall terminate on January 1,
- 9 <u>2025</u>, unless extended by the Legislature.
- 10 Sec. 2. Section 71-8701, Reissue Revised Statutes of Nebraska, is
- 11 amended to read:
- 12 71-8701 Sections 71-8701 to 71-8721 <u>and section 3 of this act</u> shall
- 13 be known and may be cited as the Patient Safety Improvement Act.
- 14 Sec. 3. The Patient Safety Cash Fund is created. The Patient Safety
- 15 Cash Fund shall only be used to support the activities of a patient
- 16 safety organization. Any money in the fund available for investment shall
- 17 be invested by the state investment officer pursuant to the Nebraska
- 18 Capital Expansion Act and the Nebraska State Funds Investment Act.
- 19 Sec. 4. This act becomes operative on January 1, 2019.
- 20 Sec. 5. Original sections 38-151 and 71-8701, Reissue Revised
- 21 Statutes of Nebraska, are repealed.
