1 A BILL FOR AN ACT relating to economic development; to amend sections 2 58-703 and 58-706, Reissue Revised Statutes of Nebraska, and section 3 81-1210.04, Revised Statutes Cumulative Supplement, 2022; to create 4 the Transforming Cities and Villages Program and provide for grants as prescribed; to change provisions of the Affordable Housing Trust 5 6 Fund; to change provisions of and transfer money from the Intern 7 Nebraska Cash Fund; to eliminate obsolete provisions; to harmonize 8 provisions; to repeal the original sections; and to declare an 9 emergency.

10 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) For purposes of this section:
- 2 (a) Department means the Department of Economic Development; and
- 3 (b) Eligible applicant means any city or village with a community
- 4 development financial institution.
- 5 (2) The department shall create the Transforming Cities and Villages
- 6 Program to award grants for a specified purpose described in subsection
- 7 (3) of this section to any eligible applicant.
- 8 (3) An eligible applicant may apply to the department for a grant
- 9 under the Transforming Cities and Villages Program. Any grant received by
- 10 an eligible applicant shall be used for the purpose of constructing
- 11 <u>housing to address affordable housing needs in cities and villages. The</u>
- 12 <u>department shall award up to ten million dollars of available grant money</u>
- 13 for such purpose. Any eligible applicant that receives a grant under this
- 14 section may work with a community development financial institution to
- 15 implement and complete the purpose for which the grant was received.
- 16 (4) The department may adopt and promulgate rules and regulations to
- 17 carry out this section.
- 18 (5) It is the intent of the Legislature to appropriate ten million
- 19 dollars for fiscal year 2024-25 for the purposes of this section.
- Sec. 2. Section 58-703, Reissue Revised Statutes of Nebraska, is
- 21 amended to read:
- 22 58-703 (1) The Affordable Housing Trust Fund is created. The fund
- 23 shall receive money pursuant to section 76-903 and may include revenue
- 24 from sources recommended by the housing advisory committee established in
- 25 section 58-704, appropriations from the Legislature, transfers authorized
- 26 by the Legislature, grants, private contributions, repayment of loans,
- 27 and all other sources.
- 28 <u>(2)</u> The Department of Economic Development <u>shall administer the</u>
- 29 Affordable Housing Trust Fund for the following purposes:
- 30 (a) As as part of its comprehensive housing affordability strategy;
- 31 and shall administer the Affordable Housing Trust Fund.

- 1 (b) Providing grants under section 1 of this act.
- 2 (3) Transfers may be made from the Affordable Housing Trust Fund to
- 3 the General Fund, the Behavioral Health Services Fund, the Lead-Based
- 4 Paint Hazard Control Cash Fund, the Rural Workforce Housing Investment
- 5 Fund, and the Site and Building Development Fund at the direction of the
- 6 Legislature.
- 7 The State Treasurer shall transfer fifty-eight thousand one hundred
- 8 eighty-eight dollars from the Affordable Housing Trust Fund to the
- 9 General Fund on or before September 15, 2019, on such date as directed by
- 10 the budget administrator of the budget division of the Department of
- 11 Administrative Services.
- 12 Sec. 3. Section 58-706, Reissue Revised Statutes of Nebraska, is
- 13 amended to read:
- 14 58-706 The following activities are eligible for assistance from the
- 15 Affordable Housing Trust Fund:
- 16 (1) New construction, rehabilitation, or acquisition of housing to
- 17 assist low-income and very low-income families;
- 18 (2) Matching funds for new construction, rehabilitation, or
- 19 acquisition of housing units to assist low-income and very low-income
- 20 families;
- 21 (3) Technical assistance, design and finance services, and
- 22 consultation for eligible nonprofit community or neighborhood-based
- 23 organizations involved in the creation of affordable housing;
- 24 (4) Matching funds for operating costs for housing assistance groups
- 25 or organizations when such grant or loan will substantially increase the
- 26 recipient's ability to produce affordable housing;
- 27 (5) Mortgage insurance guarantees for eligible projects;
- 28 (6) Acquisition of housing units for the purpose of preservation of
- 29 housing to assist low-income or very low-income families;
- 30 (7) Projects making affordable housing more accessible to families
- 31 with elderly members or members who have disabilities;

- 1 (8) Projects providing housing in areas determined by the Department
- 2 of Economic Development to be of critical importance for the continued
- 3 economic development and economic well-being of the community and where,
- 4 as determined by the department, a shortage of affordable housing exists;
- 5 (9) Infrastructure projects necessary for the development of
- 6 affordable housing;
- 7 (10) Downpayment and closing cost assistance;
- 8 (11) Demolition of existing vacant, condemned, or obsolete housing
- 9 or industrial buildings or infrastructure;
- 10 (12) Housing education programs developed in conjunction with
- 11 affordable housing projects. The education programs must be directed
- 12 toward:
- 13 (a) Preparing potential home buyers to purchase affordable housing
- 14 and postpurchase education;
- 15 (b) Target audiences eligible to utilize the services of housing
- 16 assistance groups or organizations; and
- 17 (c) Developers interested in the rehabilitation, acquisition, or
- 18 construction of affordable housing;
- 19 (13) Support for efforts to improve programs benefiting homeless
- 20 youth;
- 21 (14) Vocational training in the housing and construction trades
- 22 industries by nonprofit groups; and
- 23 (15) Weatherization and solar or other energy improvements to make
- 24 utilities for housing more affordable; and -
- 25 (16) Providing grants to community development financial
- 26 <u>institutions</u>.
- 27 Sec. 4. Section 81-1210.04, Revised Statutes Cumulative Supplement,
- 28 2022, is amended to read:
- 29 81-1210.04 (1) The Intern Nebraska Cash Fund is created. The fund
- 30 shall be used to carry out sections 81-1210.01 to 81-1210.03. The fund
- 31 shall consist of money transferred to the fund by the Legislature and

- 1 money donated as gifts, bequests, or other contributions from public or
- 2 private entities. Any money in the fund available for investment shall be
- 3 invested by the state investment officer pursuant to the Nebraska Capital
- 4 Expansion Act and the Nebraska State Funds Investment Act.
- 5 (2) Transfers may be made from the Intern Nebraska Cash Fund to the
- 6 Affordable Housing Trust Fund.
- 7 (3) (2) The Department of Economic Development, or any entity with
- 8 which the department contracts for such purpose, may use up to five
- 9 percent of any appropriation to carry out sections 81-1210.01 to
- 10 81-1210.03 for administrative services.
- 11 (4) The State Treasurer shall transfer ten million dollars from the
- 12 Intern Nebraska Cash Fund to the Affordable Housing Trust Fund as soon as
- 13 <u>administratively possible, on such dates and in such amounts as directed</u>
- 14 by the budget administrator of the budget division of the Department of
- 15 Administrative Services.
- 16 Sec. 5. Original sections 58-703 and 58-706, Reissue Revised
- 17 Statutes of Nebraska, and section 81-1210.04, Revised Statutes Cumulative
- 18 Supplement, 2022, are repealed.
- 19 Sec. 6. Since an emergency exists, this act takes effect when
- 20 passed and approved according to law.
