1 Section 1. Section 37-438, Revised Statutes Cumulative Supplement,

- 2 2022, is amended to read:
- 37-438 (1) The commission shall devise annual, temporary, 3 and
- 4 disabled veteran, and active-duty military permits.
- 5 (2) The annual permit may be purchased by any person and shall be
- valid through December 31 in the year for which the permit is issued. The 6
- 7 fee for the annual permit for a resident motor vehicle shall be not more
- than thirty-five dollars per permit. The fee for the annual permit for a 8
- 9 nonresident motor vehicle shall be two times the fee for a resident motor
- vehicle or sixty dollars, whichever is greater. The commission shall 10
- establish such fees by the adoption and promulgation of rules and 11
- regulations. 12
- 13 (3) A temporary permit may be purchased by any person and shall be
- valid until noon of the day following the date of issue. The fee for the 14
- temporary permit for a resident motor vehicle shall be not more than 15
- 16 seven dollars. The fee for the temporary permit for a nonresident motor
- vehicle shall be two times the fee for a resident motor vehicle or twelve 17
- dollars, whichever is greater. The commission shall establish such fees 18
- 19 by the adoption and promulgation of rules and regulations. The commission
- may issue temporary permits which are either valid for any area or valid 20
- 21 for a single area.
- 22 (4)(a) A veteran who is a resident of Nebraska shall, upon
- application and without payment of any fee, be issued one disabled 23
- 24 veteran permit for a resident motor vehicle if the veteran:
- 25 (i) Was discharged or separated with a characterization of honorable
- or general (under honorable conditions); and 26
- (ii)(A) Is rated by the United States Department of Veterans Affairs 27
- as fifty percent or more disabled as a result of service in the armed 28
- forces of the United States; or 29
- (B) Is receiving a pension from the United States Department of 30
- Veterans Affairs as a result of total and permanent disability, which 31

- 1 disability was not incurred in the line of duty in the military service.
- 2 (b) All disabled veteran permits issued pursuant to this subsection
- 3 shall be perpetual and shall become void only upon termination of
- 4 eligibility as provided in this subsection.
- 5 (c) The commission may adopt and promulgate rules and regulations
- 6 necessary to carry out this subsection.
- 7 <u>(5) An active-duty military permit may be purchased by any</u>
- 8 individual who is active-duty military and shall be valid through
- 9 <u>December 31 in the year for which the permit is issued. The fee for the</u>
- 10 <u>veteran permit is five dollars, regardless of residence. To qualify for</u>
- 11 <u>an active-duty military permit, the individual shall present:</u>
- 12 <u>(a) Such individual's military identification card; or</u>
- 13 (b) A copy of such individual's DD Form 214.
- 14 (6) (5) The commission may offer permits or combinations of permits
- 15 at temporarily reduced rates for specific events or during specified
- 16 timeframes.
