LEGISLATIVE BILL 184

- 1 A BILL FOR AN ACT relating to retirement; to amend section 84-1601,
- 2 Reissue Revised Statutes of Nebraska, and sections 81-2025 and
- 3 81-2032, Revised Statutes Cumulative Supplement, 2020; to provide
- 4 for a premium deduction for certain retired Nebraska State Patrol
- 5 employees as prescribed; and to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 81-2025, Revised Statutes Cumulative Supplement,
- 2 2020, is amended to read:
- 3 81-2025 (1) Every officer who has been in the employ of the state as
- 4 such and who becomes disabled and physically unfit to perform the duties
- 5 of an officer shall be entitled to retire and receive an annuity as
- 6 provided by law.
- 7 (2) Every officer who has been in the employ of the state as such
- 8 for ten years or more, as calculated in section 81-2033, and has attained
- 9 the age of fifty years or more shall be entitled to retire and receive an
- 10 annuity as provided by law. The right to retire at the age of fifty years
- 11 shall be at the option of the officer but such retirement shall be
- 12 mandatory upon the officer attaining the age of sixty years.
- 13 (3) Any officer who has attained the age of sixty years upon his or
- 14 her separation from state service but who has not been in the employ of
- 15 the state for ten years as such shall be entitled to the annuity as
- 16 provided for in the Nebraska State Patrol Retirement Act.
- 17 (4) Every officer who has been in the employ of the state as such
- 18 for twenty-five years or more, as calculated in section 81-2033, and has
- 19 attained the age of fifty years shall be entitled to retire and receive
- 20 an annuity as provided by law. The right to retire at the age of fifty
- 21 years with twenty-five years or more of creditable service shall be at
- 22 the option of the officer but such retirement shall be mandatory upon the
- 23 officer attaining the age of sixty years.
- 24 (5) Every officer who has been in the employ of the state as such
- 25 for thirty years or more, as calculated in section 81-2033, shall be
- 26 entitled to retire and receive an annuity as provided by law. The right
- 27 to retire with thirty years or more of creditable service shall be at the
- 28 option of the officer but such retirement shall be mandatory upon the
- 29 officer attaining the age of sixty years.
- 30 (6) Payment of any benefit provided under the act shall not be
- 31 deferred later than the required beginning date.

- 1 (7) The effective date of retirement payments shall be the first day
- 2 of the month following (a) the date a member qualifies for retirement as
- 3 provided in this section or (b) the date upon which a member's request
- 4 for retirement is received on an application form provided by the system,
- 5 whichever is later. An application may be filed no more than one hundred
- 6 twenty days in advance of qualifying for retirement.
- 7 (8) The board shall make reasonable efforts to locate the officer or
- 8 the officer's beneficiary and distribute benefits by the required
- 9 beginning date. If the board is unable to make such a distribution, the
- 10 account shall be distributed pursuant to the Uniform Disposition of
- 11 Unclaimed Property Act and no amounts may be applied to increase the
- 12 benefits any officer would otherwise receive under the Nebraska State
- 13 Patrol Retirement Act.
- 14 (9) Pursuant to 26 U.S.C. 402(1), employees who separate from
- 15 service by reason of disability or by attainment of the normal retirement
- 16 age may elect under subsection (4) of section 84-1601 to deduct insurance
- 17 premium costs, including the state's share, the employee's share, and the
- 18 administrative fee, from the employee's retirement annuity provided for
- 19 by the Nebraska State Patrol Retirement Act.
- 20 Sec. 2. Section 81-2032, Revised Statutes Cumulative Supplement,
- 21 2020, is amended to read:
- 22 81-2032 (1) All annuities or benefits which any person shall be
- 23 entitled to receive under the Nebraska State Patrol Retirement Act shall
- 24 not be subject to garnishment, attachment, levy, the operation of
- 25 bankruptcy or insolvency laws, or any other process of law whatsoever and
- 26 shall not be assignable except to the extent that such annuities or
- 27 benefits are subject to a qualified domestic relations order under the
- 28 Spousal Pension Rights Act.
- 29 (2) Pursuant to 26 U.S.C. 402(1), insurance premium costs, including
- 30 the state's share, the employee's share, and the administrative fee, may
- 31 be deducted from the annuity or benefit after an election is made under

- 1 subsection (4) of section 84-1601.
- 2 Sec. 3. Section 84-1601, Reissue Revised Statutes of Nebraska, is
- 3 amended to read:
- 4 84-1601 (1) There is hereby established a program of group life and
- 5 health insurance for all permanent employees of this state who work one-
- 6 half or more of the regularly scheduled hours during each pay period,
- 7 excluding employees of the University of Nebraska, the state colleges,
- 8 and the community colleges. Such program shall be known as the Nebraska
- 9 State Insurance Program and shall replace any current program of such
- 10 insurance in effect in any agency and funded in whole or in part by state
- 11 contributions.
- 12 (2) Temporary employees of the state who have a work assignment of
- 13 at least six months' duration and who work at least twenty hours per week
- 14 may purchase health insurance through the Nebraska State Insurance
- 15 Program. The state shall pay the same proportion of the insurance premium
- 16 for temporary employees as is established through the collective
- 17 bargaining process for permanent employees. For purposes of this
- 18 subsection, temporary employees means individuals (a) employed in the
- 19 Temporary Employee Pool as described in subdivision (6) of section
- 20 81-1307 and (b) hired directly by state agencies. In no event shall a
- 21 temporary employee mean an individual hired through a private employment
- 22 agency.
- 23 (3) For purposes of sections 84-1601 to 84-1615, health insurance
- 24 may be construed to include coverage for disability and dental health
- 25 care services.
- 26 (4) Any commissioned employee of the Nebraska State Patrol who on or
- 27 after July 17, 1986, has reached fifty-one years of age or becomes
- 28 medically disabled and who will not receive benefits from the federal
- 29 social security program shall be afforded the opportunity to remain
- 30 enrolled in the state employees group health insurance program until age
- 31 sixty-five. Employees electing this option shall be responsible for the

- 1 entire premium cost, including the state's share, the employee's share,
- 2 and an administrative fee consistent with that allowed by federal
- 3 guidelines for continuation of health insurance. Pursuant to 26 U.S.C.
- 4 402(1), as such section existed on January 1, 2021, employees who
- 5 <u>separate from service by reason of disability or by attainment of the</u>
- 6 <u>normal retirement age may further elect to deduct insurance premium</u>
- 7 costs, including the state's share, the employee's share, and the
- 8 <u>administrative fee, from the employee's retirement annuity provided for</u>
- 9 <u>by the Nebraska State Patrol Retirement Act.</u>
- 10 Sec. 4. Original section 84-1601, Reissue Revised Statutes of
- 11 Nebraska, and sections 81-2025 and 81-2032, Revised Statutes Cumulative
- 12 Supplement, 2020, are repealed.
