- FOR AN ACT relating to utility-type vehicles; to amend sections

  60-135.01, 60-358.01, and 60-6,355, Revised Statutes

  Cumulative Supplement, 2012; to redefine terms; and to repeal the original sections.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-135.01, Revised Statutes Cumulative

- 2 Supplement, 2012, is amended to read:
- 3 60-135.01 (1) Utility-type vehicle means any motorized
- 4 off-highway device which (a) is not less than forty-eight inches nor
- 5 more than seventy-four inches in width, (b) is not more than one
- 6 hundred thirty five eighty inches, including the bumper, in length,
- 7 (c) has a dry weight of not less than nine hundred pounds nor more
- 8 than two thousand pounds, (d) travels on four or more low-pressure
- 9 tires, and (e) is equipped with a steering wheel and bench or bucket-
- 10 type seating designed for at least two people to sit side-by-side.
- 11 (2) Utility-type vehicle does not include golf car
- 12 vehicles or low-speed vehicles.

- 6 weight of nine hundred pounds or less, (iii) travels on three or more
- 7 low-pressure tires, (iv) is designed for operator use only with no
- 8 passengers or is specifically designed by the original manufacturer
- 9 for the operator and one passenger, (v) has a seat or saddle designed
- 10 to be straddled by the operator, and (vi) has handlebars or any other
- 11 steering assembly for steering control; and
- 12 (b)(i) Utility-type vehicle means any motorized off-
- 13 highway vehicle which (A) is not less than forty-eight inches nor
- 14 more than seventy-four inches in width, (B) is not more than one
- 15 hundred thirty-five eighty inches, including the bumper, in length,
- 16 (C) has a dry weight of not less than nine hundred pounds nor more
- 17 than two thousand pounds, (D) travels on four or more low-pressure
- 18 tires, and (E) is equipped with a steering wheel and bench or bucket-
- 19 type seating designed for at least two people to sit side-by-side.
- 20 (ii) Utility-type vehicle does not include golf car
- 21 vehicles or low-speed vehicles.
- 22 (2) All-terrain vehicles and utility-type vehicles which
- 23 have been modified to include additional equipment not required by
- 24 sections 60-6,357 and 60-6,358 shall not be required to be registered
- 25 under the Motor Vehicle Registration Act.
