- 1 Section 1. There is hereby appropriated (1) \$294,833 from the
- 2 General Fund for FY2023-24 and (2) \$131,577 from the General Fund for
- 3 FY2024-25 to the State Department of Education, for Program 25, to aid in
- 4 carrying out the provisions of Legislative Bill 243, One Hundred Eighth
- 5 <u>Legislature</u>, First Session, 2023.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$68,310
- 8 for FY2023-24 or \$72,409 for FY2024-25.
- 9 Sec. 2. There is hereby appropriated (1) \$-0- from the Community
- 10 College Future Fund for FY2023-24 and (2) \$246,499,886 from the Community
- 11 College Future Fund for FY2024-25 to Agency 83, Aid to Community
- 12 Colleges, for Program 152, to aid in carrying out the provisions of
- 13 Legislative Bill 243, One Hundred Eighth Legislature, First Session,
- 14 <u>2023.</u>
- 15 There is included in the appropriation to this program for FY2023-24
- 16 \$-0- Cash Funds for state aid, which shall only be used for such purpose.
- 17 There is included in the appropriation to this program for FY2024-25
- 18 \$246,499,886 Cash Funds for state aid, which shall only be used for such
- 19 <u>purpose</u>.
- 20 <u>No expenditures for permanent and temporary salaries and per diems</u>
- 21 for state employees shall be made from funds appropriated in this
- 22 section.
- Sec. 3. There is hereby appropriated (1) \$384,542 from the General
- 24 Fund for FY2023-24 and (2) \$387,302 from the General Fund for FY2024-25
- 25 to the Tax Equalization and Review Commission, for Program 115, to aid in
- 26 <u>carrying out the provisions of Legislative Bill 243, One Hundred Eighth</u>
- 27 Legislature, First Session, 2023.
- 28 Total expenditures for permanent and temporary salaries and per
- 29 diems from funds appropriated in this section shall not exceed \$312,271
- 30 <u>for FY2023-24 or \$312,271 for FY2024-25.</u>
- 31 Sec. 4. Since an emergency exists, this act takes effect when

1 passed and approved according to law.
