- 1 A BILL FOR AN ACT relating to the Dairy Industry Development Act; to
- 2 amend sections 2-3949, 2-3957, and 2-3959, Reissue Revised Statutes
- of Nebraska; to define a term; to eliminate provisions relating to
- 4 refunds; to change powers and duties; to harmonize provisions; and
- 5 to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 2-3949, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 2-3949 For purposes of the Dairy Industry Development Act:
- (1) Board shall mean the Nebraska Dairy Industry Development Board; 4
- 5 (2) Commercial use shall mean sale for retail consumption or sale
- 6 for resale, for manufacture for resale, or for processing for resale;
- 7 (3) First purchaser of milk shall mean a person who buys milk from a
- producer and resells to another person the milk or products manufactured 8
- 9 or processed from the milk;
- 10 (4) Milk shall mean any class of cow's milk produced in the State of
- Nebraska; 11
- (5) Milk production unit shall mean any producer licensed by the 12
- 13 Department of Agriculture;
- (6) Producer shall mean any person engaged in the production of milk 14
- 15 for commercial use;
- (7) Producer-processor shall mean a producer who processes and 16
- 17 markets the producer's own milk; and
- (8) Qualified program shall mean any state or regional dairy product 18
- 19 promotion, research, or nutrition education program which is certified
- pursuant to 7 C.F.R. 1150.153, as amended. Such program shall: (a) 20
- Conduct activities as defined in 7 C.F.R. 1150.114, 1150.115, and 21
- 22 1150.116 intended to increase consumption of milk and dairy products
- 23 generally; (b) except for programs operated under the laws of the United
- 24 States or any state, have been active and ongoing before November 29,
- 1983; (c) be financed primarily by producers, either individually or 25
- through cooperative associations; (d) not use any private brand or trade 26
- name in advertising and promotion of dairy products unless the National 27
- Dairy Promotion and Research Board established pursuant to 7 C.F.R. 28
- 1150.131 and the United States Secretary of Agriculture concur that such 29
- requirement should not apply; (e) certify to the United States Secretary 30
- of Agriculture that any request from a producer for a refund under the 31

- 1 program will be honored by forwarding that portion of such refund equal
- 2 to the amount of credit that otherwise would be applicable to the program
- 3 pursuant to 7 C.F.R. 1150.152(a + e)(3) to either the National Dairy
- 4 Promotion and Research Board or a qualified program designated by the
- 5 producer; and (f) not use program funds for the purpose of influencing
- 6 governmental policy or action; and -
- 7 (9) Refund shall mean a refund of a producer's assessment required
- 8 to be issued pursuant to the federal Dairy Promotion and Research Order,
- 9 7 C.F.R. Part 1150, and shall not refer to assessments described under 7
- 10 C.F.R. 1150.152.
- 11 Sec. 2. Section 2-3957, Reissue Revised Statutes of Nebraska, is
- 12 amended to read:
- 13 2-3957 The board shall:
- 14 (1) Arrange or contract for administrative and audit services which
- 15 are necessary for the proper operation of the Dairy Industry Development
- 16 Act;
- 17 (2) Procure and evaluate data and information necessary for the
- 18 appropriate distribution of funds collected;
- 19 (3) Direct the distribution of funds collected;
- 20 (4) Prepare and approve a yearly budget;
- 21 (5) Adopt and promulgate rules and regulations to carry out the act;
- 22 (6) Establish a means by which all producers are informed annually
- 23 on board members, policy, expenditures, and programs for the preceding
- 24 year;
- 25 (7) Authorize the expenditure of funds to conduct activities
- 26 provided for by the act;
- 27 (8) Bond such persons as necessary to ensure adequate protection of
- 28 funds;
- 29 (9) Make refunds to other qualified programs in other states and
- 30 disburse as directed by producers pursuant to subdivision (8)(e) of
- 31 section 2-3949;

- 1 (9 10) Require that all books and records which clearly reflect all
- 2 the transactions of its funded qualified programs be made available for
- 3 audit by the board;
- 4 (10 11) Initiate appropriate enforcement of the act and the rules,
- 5 regulations, and orders promulgated under the act;
- 6 (11 12) Accept remittances or credits and apply for and accept
- 7 advances, grants, contributions, and any other forms of assistance from
- 8 the federal government, the state, or any public or private source for
- 9 administering the act and execute contracts or agreements in connection
- 10 therewith;
- 11 $(\underline{12} \ \underline{13})$ When necessary, appoint committees and advisory committees,
- 12 the membership of which reflects the different funding regions of the
- 13 United States and of the State of Nebraska in which milk is produced and
- 14 delegate to such committees the authority reasonably necessary to
- 15 administer the act under the direction of the board and within the
- 16 policies determined by the board; and
- 17 <u>(13) Forward a producer's assessments prescribed in section 2-3958</u>
- 18 to the National Dairy Promotion and Research Board or to a qualified
- 19 program in another state if the producer requested that the assessments
- 20 <u>be so transferred prior to January 1, 2015; and</u>
- 21 (14) Exercise all incidental powers useful or necessary to carry out
- 22 the act.
- 23 Sec. 3. Section 2-3959, Reissue Revised Statutes of Nebraska, is
- 24 amended to read:
- 25 2-3959 The assessment prescribed in section 2-3958 shall be paid by
- 26 producers at the time of first sale or delivery of milk for commercial
- 27 use and shall be collected by the first purchaser of milk except as
- 28 provided in this section. The first purchaser of milk shall remit the
- 29 assessment to the board when the first purchaser of milk issues the milk
- 30 payroll to producers. When milk is sold by producers to nonresident first
- 31 purchasers of milk, the nonresident first purchaser of milk shall remit

- 1 the assessments to the board. Producer-processors shall remit the
- 2 assessments to the board. All assessments shall be remitted to the board
- 3 not later than the last day of the month following the month in which the
- 4 milk was commercially used, and a report shall be filed by the person
- 5 responsible for remitting the assessment at the time that the assessment
- 6 is remitted. The board shall make proper refunds to producers pursuant to
- 7 subdivision (8)(e) of section 2-3949 at least quarterly. The board shall
- 8 promulgate rules and regulations concerning the payment, remittance,
- 10 shall be remitted to the State Treasurer for credit to the Nebraska Dairy
- 11 Industry Development Fund.
- 12 Sec. 4. Original sections 2-3949, 2-3957, and 2-3959, Reissue
- 13 Revised Statutes of Nebraska, are repealed.
