## **LEGISLATIVE BILL 264**

Introduced by Stinner, 48.

### Committee:

- 1 A BILL FOR AN ACT relating to the Nebraska Arts Council; to amend
- 2 sections 82-312, 82-313, and 82-334, Revised Statutes Cumulative
- 3 Supplement, 2020; to state intent for the Legislature to appropriate
- 4 funds for and to change provisions relating to the competitive grant
- 5 program; and to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 82-312, Revised Statutes Cumulative Supplement,
- 2 2020, is amended to read:
- 3 82-312 The duties of the council shall be:
- 4 (1) To stimulate and encourage throughout the state the study and
- 5 presentation of the performing and fine arts and public interest and
- 6 participation therein;
- 7 (2) To make such surveys as may be deemed advisable of public and
- 8 private institutions within the state engaged in artistic and cultural
- 9 activities, including, but not limited to, music, theatre, dance,
- 10 painting, sculpture, architecture, and allied arts and crafts, and to
- 11 make recommendations concerning appropriate methods to encourage
- 12 participation in and appreciation of the arts to meet the legitimate
- 13 needs and aspirations of persons in all parts of the state;
- 14 (3) To take such steps as may be necessary and appropriate to
- 15 encourage public interest in the cultural heritage of our state and to
- 16 expand the state's cultural resources;
- 17 (4) To encourage and assist freedom of artistic expression essential
- 18 for the well-being of the arts; and
- 19 (5) To recommend to the Legislature a plan to divide the state into
- 20 <u>cultural</u> <del>creative</del> districts and certify them based on geographically
- 21 contiguous area, artistic or cultural activities or facilities, promotion
- 22 and preservation of artistic or cultural sites or events, educational
- 23 uses of artistic or cultural activities or sites, and unique or niche
- 24 areas, activities, events, facilities, or sites.
- 25 Sec. 2. Section 82-313, Revised Statutes Cumulative Supplement,
- 26 2020, is amended to read:
- 27 82-313 (1) The Nebraska Arts Council may:
- 28 (a) Hold public and private hearings;
- 29 (b) Enter into contracts, within the limit of funds available
- 30 therefor, with individuals, organizations, and institutions for services
- 31 furthering the educational objectives of the council's programs;

- 1 (c) Enter into contracts, within the limit of funds available
- 2 therefor, with local and regional associations for cooperative endeavors
- 3 furthering the educational objectives of the council's programs;
- 4 (d) Accept gifts, contributions, and bequests of unrestricted funds
- 5 from individuals, foundations, corporations, and other organizations or
- 6 institutions for the purpose of furthering the educational objectives of
- 7 the council's programs;
- 8 (e) Distribute funds appropriated by the Legislature to any
- 9 organization which has been designated as the state affiliate of the
- 10 National Endowment for the Humanities for the period covered by the
- 11 appropriation;
- 12 (f) Make and sign any agreements and do and perform any acts that
- may be necessary to carry out the purposes of sections 82-309 to 82-316;
- (g) Enter into contracts, make and sign any agreements, and perform
- 15 any acts that may be necessary to stabilize funding for the arts and
- 16 humanities and to carry out the intent of sections 82-330 to 82-333;
- 17 (h) Prepare <u>and implement</u> a plan that would permit, to the extent
- 18 that funds are available, the establishment of a competitive grant
- 19 program to award a grant to any <u>cultural</u> <del>creative</del> district that is
- 20 certified pursuant to the plan adopted by the Legislature under
- 21 subdivision (5) of section 82-312 and that meets the criteria for the
- 22 competitive grant, including eligibility criteria, application and appeal
- 23 processes, conditions on receipt of a grant, and consequences of failure
- 24 to meet the conditions. It is the intent of the Legislature to
- 25 appropriate one hundred thousand dollars each fiscal year from the
- 26 <u>General Fund for carrying out the purposes of the competitive grant</u>
- 27 <u>program</u>; and
- 28 (i) Adopt and promulgate rules and regulations to carry out its
- 29 powers and duties.
- 30 (2) The council may request from any department, division, board,
- 31 bureau, commission, or agency of the state such assistance and data as

- 1 will enable it properly to carry out its powers and duties.
- 2 Sec. 3. Section 82-334, Revised Statutes Cumulative Supplement,
- 3 2020, is amended to read:
- 4 82-334 (1) The Support the Arts Cash Fund is created. The fund shall
- 5 consist of all money credited to the fund pursuant to section 60-3,252.
- 6 The Nebraska Arts Council shall administer and distribute the Support the
- 7 Arts Cash Fund. The fund shall be expended by the Nebraska Arts Council
- 8 to provide aid to communities that designate a focus area of the city for
- 9 arts and cultural development, to provide money for a competitive grant
- 10 program that awards a grant to any <u>cultural creative</u> district that meets
- 11 the criteria for the competitive grant, if such program exists, and to
- 12 defray costs directly related to the administration of the fund.
- 13 (2) Any money in the fund available for investment shall be invested
- 14 by the state investment officer pursuant to the Nebraska Capital
- 15 Expansion Act and the Nebraska State Funds Investment Act.
- 16 Sec. 4. Original sections 82-312, 82-313, and 82-334, Revised
- 17 Statutes Cumulative Supplement, 2020, are repealed.
