Committee:

- 1 A BILL FOR AN ACT relating to the Child and Maternal Death Review Act; to
- 2 amend section 71-3407, Revised Statutes Cumulative Supplement, 2016;
- 3 to provide duties for the State Child and Maternal Death Review
- 4 Team; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 71-3407, Revised Statutes Cumulative Supplement,
- 2 2016, is amended to read:
- 3 71-3407 (1) The purposes of the team shall be to (a) develop an
- 4 understanding of the causes and incidence of child or maternal deaths in
- 5 this state, (b) develop recommendations for changes within relevant
- 6 agencies and organizations which may serve to prevent child or maternal
- 7 deaths, and (c) advise the Governor, the Legislature, and the public on
- 8 changes to law, policy, and practice which will prevent child or maternal
- 9 deaths.
- 10 (2) The team shall:
- 11 (a) Undertake annual statistical studies of the causes and incidence
- of child or maternal deaths in this state. The studies shall include, but
- 13 not be limited to, an analysis of the records of community, public, and
- 14 private agency involvement with the children, the pregnant or postpartum
- 15 women, and their families prior to and subsequent to the child or
- 16 maternal deaths;
- 17 (b) Develop a protocol for retrospective investigation of child or
- 18 maternal deaths by the team;
- 19 (c) Develop a protocol for collection of data regarding child or
- 20 maternal deaths by the team;
- 21 (d) Consider training needs, including cross-agency training, and
- 22 service gaps;
- 23 (e) Include in its annual report recommended changes to any law,
- 24 rule, regulation, or policy needed to decrease the incidence of
- 25 preventable child or maternal deaths;
- 26 (f) Educate the public regarding the incidence and causes of child
- 27 or maternal deaths, the public role in preventing child or maternal
- 28 deaths, and specific steps the public can undertake to prevent child or
- 29 maternal deaths. The team may enlist the support of civic, philanthropic,
- 30 and public service organizations in the performance of its educational
- 31 duties;

- 1 (g) Provide the Governor, the Legislature, and the public with
- 2 annual reports which shall include the team's findings and
- 3 recommendations for each of its duties. For 2013 and 2014, the team shall
- 4 also provide the report to the Health and Human Services Committee of the
- 5 Legislature on or before September 15. The reports submitted to the
- 6 Legislature shall be submitted electronically; and
- 7 (h) When appropriate, make referrals to those agencies as required
- 8 in section 28-711 or as otherwise required by state law.
- 9 (3) The team may enter into consultation agreements with relevant
- 10 experts to evaluate the information and records collected by the team.
- 11 All of the confidentiality provisions of section 71-3411 shall apply to
- 12 the activities of a consulting expert.
- 13 (4) The team may enter into written agreements with qualified
- 14 <u>entities to provide for the secure storage of electronic data based on</u>
- 15 <u>information</u> and records collected by the team, including data that
- 16 contain personal or incident identifiers. Such agreements shall provide
- 17 for the protection of the security and confidentiality of the content of
- 18 the information, including access limitations, storage of the
- 19 <u>information</u>, <u>destruction</u> of the <u>information</u>, <u>and use of the information</u>
- 20 by the qualified entity.
- 21 <u>(5) (4)</u> The team may enter into agreements with a local public
- 22 health department as defined in section 71-1626 to act as the agent of
- 23 the team in conducting all information gathering and investigation
- 24 necessary for the purposes of the Child and Maternal Death Review Act.
- 25 All of the confidentiality provisions of section 71-3411 shall apply to
- 26 the activities of the agent.
