LEGISLATIVE BILL 304

Committee:

- 1 A BILL FOR AN ACT relating to the Nebraska Pure Food Act; to amend
- 2 section 81-2,245.01, Revised Statutes Cumulative Supplement, 2018;
- 3 to exempt certain operations from the definition of a food
- 4 establishment as prescribed; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 81-2,245.01, Revised Statutes Cumulative
- 2 Supplement, 2018, is amended to read:
- 3 81-2,245.01 Food establishment shall mean an operation that stores,
- 4 prepares, packages, serves, sells, vends, delivers, or otherwise provides
- 5 food for human consumption. The term does not include:
- 6 (1) An establishment or vending machine operation that offers only
- 7 prepackaged soft drinks, carbonated or noncarbonated; canned or bottled
- 8 fruit and vegetable juices; prepackaged ice; candy; chewing gum; potato
- 9 or corn chips; pretzels; cheese puffs and curls; crackers; popped
- 10 popcorn; nuts and edible seeds; and cookies, cakes, pies, and other
- 11 pastries, that are not time/temperature control for safety foods;
- 12 (2) A produce stand that only offers whole, uncut fresh fruits and
- 13 vegetables;
- 14 (3) A food processing plant;
- 15 (4) A salvage operation;
- 16 (5) A private home where food is prepared or served for personal
- 17 use, a small day care in the home, or a hunting lodge, guest ranch, or
- 18 other operation where no more than ten paying guests eat meals in the
- 19 home;
- 20 (6) A private home or other area where food that is not time/
- 21 temperature control for safety food is prepared:
- 22 (a) For sale or service at a religious, charitable, or fraternal
- 23 organization's bake sale or similar function; or
- 24 (b) For for sale directly to the consumer including, but not limited
- 25 to, (i) at a farmers market, fair, festival, craft show, or other public
- 26 <u>event or (ii) for pick up at or delivery from such private home or other</u>
- 27 <u>area,</u> if: the
- 28 (A) The consumer is informed by a clearly visible notification (I)
- 29 placard at the sale location for sales conducted under subdivision (6)(b)
- 30 (i) of this section or (II) at such private home or other area, on the
- 31 web site of the producer if such web site exists, and in any print,

- 1 radio, television, or Internet advertisement for sales conducted under
- 2 <u>subdivision (6)(b)(ii) of this section</u> that the food was prepared in a
- 3 kitchen that is not subject to regulation and inspection by the
- 4 regulatory authority and may contain allergens;
- 5 <u>(B) The name and address of the producer is provided to the consumer</u>
- 6 on the package or container label;
- 7 (C) Product delivery must be directly from the producer to the
- 8 <u>actual customer in a person-to-person transaction or by United States</u>
- 9 <u>mail or a commercial mail delivery service; and</u>
- 10 (D) The producer follows any food safety and handling guidelines for
- 11 <u>sale at a farmers market, fair, festival, craft show, or other public</u>
- 12 event required by the county where the food is sold;
- 13 (7) A private home or other area where food is prepared for
- 14 distribution at a fundraising event for a charitable purpose if the
- 15 consumer is informed by a clearly visible placard at the serving location
- 16 that the food was prepared in a kitchen that is not subject to regulation
- 17 and inspection by the regulatory authority. This subdivision does not
- 18 apply to a caterer or other establishment providing food for the event if
- 19 the caterer or establishment receives compensation for providing the
- 20 food;
- 21 (8) The location where food prepared by a caterer is served so long
- 22 as the caterer only minimally handles the food at the serving location;
- 23 (9) Educational institutions, health care facilities, nursing homes,
- 24 and governmental organizations which are inspected by a state agency or a
- 25 political subdivision other than the regulatory authority for sanitation
- 26 in the food preparation areas;
- 27 (10) A pharmacy as defined in section 71-425 if the pharmacy only
- 28 sells prepackaged pharmaceutical, medicinal, or health supplement foods
- 29 that are not time/temperature control for safety or foods described in
- 30 subdivision (1) of this section; and
- 31 (11) An establishment which is not a commercial food establishment
