1 Section 1. Section 66-821, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 66-821 For purposes of sections 66-821 to 66-824: -
- 4 unless the context otherwise requires:
- 5 (1) Department means the Department of Roads; and
- 6 (1) Gasohol shall mean (2) E15 means gasoline which
- 7 contains a minimum of ten percent fifteen-percent blend of an
- 8 agricultural ethyl alcohol whose purity shall be at least ninety-nine
- 9 percent alcohol, excluding denaturant, produced from <del>cereal grains or</del>
- 10 domestic agricultural commodities. ; and
- 11 (2) Department shall mean the Department of Roads.
- 12 Sec. 2. Section 66-822, Reissue Revised Statutes of
- 13 Nebraska, is amended to read:
- 14 66-822 The Department of Roads department shall, not
- 15 later than July 1, 1980, January 1, 2014, implement a program of
- 16 using gasohol <u>E15</u> as fuel in motor vehicles owned or operated by the
- 17 department which are designed to operate on such fuel.
- 18 Sec. 3. Section 66-823, Reissue Revised Statutes of
- 19 Nebraska, is amended to read:
- 20 66-823 The department shall provide storage and
- 21 dispensing facilities at various sites in the state which will make
- 22 gasohol <u>E15</u> reasonably accessible to all department vehicles equipped
- 23 for its use.
- Sec. 4. Section 66-824, Reissue Revised Statutes of
- 25 Nebraska, is amended to read:

1 66-824 The department shall be required to comply with

- 2 sections 66-821 to 66-824 only to the extent that  $\frac{\text{gasohol}}{\text{E15}}$
- 3 supplies are available. The department shall purchase gasohol E15 for
- 4 use in its motor vehicles only if, and to the extent that, the cost
- 5 of the gasohol\_E15 does not exceed the cost of the fuel otherwise
- 6 used in such vehicle by more than ten five percent.
- 7 Sec. 5. Original sections 66-821, 66-822, 66-823, and
- 8 66-824, Reissue Revised Statutes of Nebraska, are repealed.
