- 2 Reissue Revised Statutes of Nebraska; to eliminate daylight saving
- 3 time; to harmonize provisions; to provide an operative date; to
- 4 repeal the original sections; and to outright repeal section
- 5 49-1302, Reissue Revised Statutes of Nebraska.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 32-908, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 32-908 (1) At all elections in the area of this state lying within
- 4 the Mountain Standard or Mountain Daylight time zone, the polls shall
- 5 open at 7 a.m. and close at 7 p.m. of the same day, and in the area lying
- 6 within the Central Standard or Central Daylight time zone, the polls
- 7 shall open at 8 a.m. and close at 8 p.m. of the same day.
- 8 (2) If the judges and clerks of election are not present at the
- 9 polls at the required hour, the polls may be opened by those placed in
- 10 charge of the polling place at any time before the time required for
- 11 closing the polls on election day.
- 12 (3) If at the hour of closing there are any persons desiring to vote
- 13 who are in the polling place or in a line at the polling place and who
- 14 have not been able to vote since appearing at the polling place, the
- 15 polls shall be kept open reasonably long enough after the hour for
- 16 closing to allow those present at that hour to vote. No person arriving
- 17 after the hour when the polls have officially closed shall be entitled to
- 18 vote.
- 19 Sec. 2. Section 49-1301, Reissue Revised Statutes of Nebraska, is
- 20 amended to read:
- 21 49-1301 The standard time of the State of Nebraska shall be the time
- 22 established by the Uniform Time Act of 1966 in both the Central and Rocky
- 23 Mountain time zones, except that the State of Nebraska shall not observe
- 24 daylight saving time and shall be exempt from the provisions of 15 U.S.C.
- 25 260a(a) providing for the advancement of time.
- Sec. 3. This act becomes operative on January 1, 2018.
- Sec. 4. Original sections 32-908 and 49-1301, Reissue Revised
- 28 Statutes of Nebraska, are repealed.
- 29 Sec. 5. The following section is outright repealed: Section
- 30 49-1302, Reissue Revised Statutes of Nebraska.
