# **LEGISLATIVE BILL 332**

## Committee:

- A BILL FOR AN ACT relating to cities of the metropolitan class; to amend sections 14-201, 14-201.03, 32-536, and 32-553, Reissue Revised Statutes of Nebraska, and section 32-539, Revised Statutes Cumulative Supplement, 2020; to change provisions relating to elections, districts, terms, number of city council members, and redistricting procedures; to harmonize provisions; and to repeal the original sections.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 14-201, Reissue Revised Statutes of Nebraska, is

- 3 14-201 In any city of the metropolitan class, city seven council
- 4 members shall be elected to the city council as provided in section
- 5 32-536. The general city election for the election of elective officers
- 6 of cities of the metropolitan class shall be held on the first Tuesday
- 7 after the second Monday in May 1993 and every four years thereafter. The
- 8 terms of office of such city council members shall commence on the fourth
- 9 Monday after such election.
- 10 Sec. 2. Section 14-201.03, Reissue Revised Statutes of Nebraska, is
- 11 amended to read:
- 12 14-201.03 (1) Except as provided in subsections (2) and (3) of this
- 13 <u>section</u>, the The election commissioner in any county in which is situated
- 14 a city of the metropolitan class shall divide the city into seven city
- 15 council districts of compact and contiguous territory. Such districts
- shall be numbered consecutively from one to seven.
- 17 (2) Beginning with the general city election in 2025, the election
- 18 <u>commissioner in any county in which is situated a city</u> of the
- 19 metropolitan class shall divide the city into nine city council districts
- 20 <u>of compact and contiguous territory. Such districts shall be numbered</u>
- 21 consecutively from one to nine.
- 22 (3) One city council member shall be elected from each district,
- 23 except that the city council members elected or appointed to serve the
- 24 <u>districts created under subsection (1) of this section shall continue to</u>
- 25 serve such districts until the terms of office of the city council
- 26 <u>members elected to serve the districts created under subsection (2) of</u>
- 27 <u>this section commence pursuant to section 14-201</u>. The city council shall
- 28 be responsible for redrawing the city council district boundaries
- 29 pursuant to section 32-553.
- 30 Sec. 3. Section 32-536, Reissue Revised Statutes of Nebraska, is
- 31 amended to read:

- 1 32-536 (1) In a city of the metropolitan class, until the general
- 2 <u>city election in 2025,</u> seven <u>city</u> council members shall be elected to the
- 3 city council for terms of four years at the general city election in 1993
- 4 pursuant to section 14-201.
- 5 (2) Beginning with the general city election in 2025, nine city
- 6 council members shall be elected to the city council for terms of four
- 7 years pursuant to section 14-201.
- 8 (3) One <u>city</u> council member shall be nominated and elected from each
- 9 of the districts into which the city is divided pursuant to section
- 10 14-201.03. The city council members shall meet the qualifications found
- 11 in sections 14-204 and 14-230.
- 12 Sec. 4. Section 32-539, Revised Statutes Cumulative Supplement,
- 13 2020, is amended to read:
- 14 32-539 (1) In a city which adopts the commission plan of government
- 15 pursuant to the Municipal Commission Plan of Government Act, the number
- of city council members shall be determined by the class and population
- 17 of the city. In cities having two thousand or more but not more than
- 18 forty thousand inhabitants as determined by the most recent federal
- 19 decennial census or the most recent revised certified count by the United
- 20 States Bureau of the Census, there shall be five members, in cities of
- 21 the primary class, there shall be five members, and in cities of the
- 22 metropolitan class, there shall be <u>nine</u> seven members. Council members
- 23 shall be elected from the city at large. Nomination and election of all
- 24 council members shall be by nonpartisan ballot. The mayor shall be
- 25 elected for a four-year term.
- 26 (2) If a city elects to adopt the commission plan of government, the
- 27 council member elected as the commissioner of the department of public
- 28 works and the council member elected as the commissioner of the
- 29 department of public accounts and finances shall each serve a term of
- 30 four years and the council member elected as the commissioner of the
- 31 department of streets, public improvements, and public property and the

- 1 council member elected as the commissioner of the department of parks and
- 2 recreation shall each serve a term of two years. Upon the expiration of
- 3 such terms, all council members shall serve terms of four years and until
- 4 their successors are elected and qualified.
- 5 (3) Commencing with the statewide primary election in 2000, and
- 6 every two years thereafter, candidates shall be nominated at the
- 7 statewide primary election and elected at the statewide general election
- 8 except as otherwise provided in section 19-405.
- 9 Sec. 5. Section 32-553, Reissue Revised Statutes of Nebraska, is
- 10 amended to read:
- 11 32-553 (1) When any political subdivision except a public power
- 12 district nominates or elects members of the governing board by districts,
- 13 such districts shall be substantially equal in population as determined
- 14 by the most recent federal decennial census. Any such political
- 15 subdivision which has districts in place on the date the census figures
- 16 used in drawing district boundaries for the Legislature are required to
- 17 be submitted to the state by the United States Department of Commerce,
- 18 Bureau of the Census, shall, if necessary to maintain substantial
- 19 population equality as required by this subsection, have new district
- 20 boundaries drawn within six months after the passage and approval of the
- 21 legislative bill providing for reestablishing legislative districts. Any
- 22 such political subdivision in existence on the date the census figures
- 23 used in drawing district boundaries for the Legislature are required to
- 24 be submitted to the state by the United States Department of Commerce,
- 25 Bureau of the Census, and which has not established any district
- 26 boundaries shall establish district boundaries pursuant to this section
- 27 within six months after such date. If the deadline for drawing or
- 28 redrawing district boundary lines imposed by this section is not met, the
- 29 procedures set forth in section 32-555 shall be followed.
- 30 (2) Except as otherwise provided in section 14-201.03, the The
- 31 governing board of each such political subdivision shall be responsible

- 1 for drawing its own district boundaries and shall, as nearly as possible,
- 2 follow the precinct lines created by the election commissioner or county
- 3 clerk after each federal decennial census, except that the election
- 4 commissioner of any county in which a Class IV or V school district is
- 5 located shall draw district boundaries for such school district as
- 6 provided in this section and section 32-552.
- 7 Sec. 6. Original sections 14-201, 14-201.03, 32-536, and 32-553,
- 8 Reissue Revised Statutes of Nebraska, and section 32-539, Revised
- 9 Statutes Cumulative Supplement, 2020, are repealed.
