1	A BILL FOR AN ACT relating to telecommunications and technology; to amend
2	sections 86-330 and 86-1102, Revised Statutes Cumulative Supplement,
3	2020; to change provisions relating to universal service funding for
4	unserved or underserved exchanges; to provide for community-based
5	plans as prescribed; to provide duties for the Public Service
6	Commission; to harmonize provisions; and to repeal the original
7	sections.

1 Section 1. Section 86-330, Revised Statutes Cumulative Supplement,

2 2020, is amended to read:

3 86-330 (1) Based on consumer complaints or upon its own motion, the 4 Public Service Commission may open a docket to consider the 5 implementation and operation of a funding redirection reverse auction program that awards funding to broadband Internet service providers to 6 7 support high-speed Internet infrastructure deployment projects unserved or underserved exchanges within the State of Nebraska. The 8 9 commission may, in its discretion, withhold funding from the Nebraska 10 Telecommunications Universal Service Fund to any telecommunications company that has not served, to the commission's satisfaction, those 11 12 areas with service that meets the criteria for successful investment of funding from the Nebraska Telecommunications Universal Service Fund. 13

(2) The commission shall adopt and promulgate rules and regulations 14 that establish standards governing the withholding of funding from the 15 Nebraska Telecommunications Universal Service Fund from any recipient, 16 including the provision of notice and the right to a hearing prior to the 17 issuance of an order withdrawing such funding. If the commission 18 19 withdraws funding from the Nebraska Telecommunications Universal Service Fund from any telecommunications company, the commission may redirect use 20 the funding that is withdrawn to <u>another eligible telecommunications</u> 21 22 company implement and operate a reverse auction program, except that any 23 funding that is withdrawn shall be utilized in the exchange area for 24 which the funding was originally granted. The commission shall have wide discretion in the design, implementation, and operation of a funding 25 redirection reverse auction program but may use as a guide the reverse 26 auction program designed by the Federal Communications Commission in its 27 Connect America Fund Phase II Auction process. 28

(3)(a) For purposes of this subsection, community-based plans means a proposal for redirecting support under subsection (2) of this section made by residential and business users of telecommunications and

- 8 <u>following scoring criteria:</u>
- 9 (i) The history of the participating eligible telecommunications
- 10 company in providing quality and affordable telecommunications and
- 11 <u>broadband services in rural areas;</u>
- 12 (ii) The capability of the eligible telecommunications company to
- 13 <u>use the proposed technology to provide broadband services to every</u>
- 14 <u>location in the exchange area on a reasonably comparable basis;</u>
- 15 (iii) The support of local businesses, hospitals, schools, colleges,
- 16 agricultural producers, and residents;
- 17 (iv) Other sources of funding;
- 18 <u>(v) Partnerships and other cooperative arrangements with local</u>
- 19 <u>public power providers;</u>
- 20 <u>(vi) Partnerships and other cooperative arrangements with local</u>
- 21 <u>wireless Internet service providers; and</u>
- 22 (vii) Cooperation by the incumbent local exchange carrier from which
- 23 support has been withheld.
- 24 (d) In entering an order redirecting support, the commission shall
- 25 establish a timeline for deployment that includes periodic milestones for
- 26 <u>ensuring timely deployment and shall require the eligible</u>
- 27 <u>telecommunications company to file reports sufficient to assess</u>
- 28 compliance with deployment milestones.

2 86-1102 (1) The Rural Broadband Task Force is hereby created. Task force members shall include the chairperson of the Transportation and 3 4 Telecommunications Committee of the Legislature and a member of the 5 Legislature selected by the Executive Board of the Legislative Council who shall both serve as nonvoting, ex officio members, a member of the 6 7 Public Service Commission who shall be selected by the chairperson of such commission, the chairperson of the Nebraska Information Technology 8 9 Commission or his or her designee who shall act as chairperson of the task force, the Director of Economic Development or his or her designee, 10 the Director of Agriculture or his or her designee, and the following 11 members to be appointed by the Governor: A representative of the 12 13 agribusiness community, a representative of the Nebraska business 14 community, a representative of the regulated wireline telecommunications industry, a representative of the wireless telecommunications industry, a 15 16 representative of the public power industry, a representative of health 17 care providers, a representative of Nebraska postsecondary educational institutions, and a representative of rural schools offering kindergarten 18 19 through grade twelve. The members appointed by the Governor shall serve for a term of two years and may be reappointed. 20

- (2) The task force may appoint advisory groups to assist the task 21 force in providing technical expertise and advice on any issue. The 22 advisory groups may be composed of representatives of stakeholder groups 23 24 which may include, but not necessarily be limited to, representatives from small and large wireline companies, wireless companies, public power 25 districts, electric cooperative corporations, cable television companies, 26 Internet service providers, low-income telecommunications and electric 27 28 utility customers, health care providers, and representatives educational sectors. No compensation or expense reimbursement shall be 29 provided to any member of any advisory group appointed by the task force. 30
 - (3) The Nebraska Information Technology Commission shall provide

- 1 staff assistance to the task force in consultation with staff from the
- 2 Public Service Commission and other interested parties. The task force
- 3 may hire consultants to assist in carrying out its duties. The task force
- 4 shall review issues relating to availability, adoption, and affordability
- 5 of broadband services in rural areas of Nebraska. In particular, the task
- 6 force shall:
- 7 (a) Determine how Nebraska rural areas compare to neighboring states
- 8 and the rest of the nation in average download and upload speeds and in
- 9 subscription rates to higher speed tiers, when available;
- 10 (b) Examine the role of the Nebraska Telecommunications Universal
- 11 Service Fund in bringing comparable and affordable broadband services to
- 12 rural residents and any effect of the fund in deterring or delaying
- 13 capital formation, broadband competition, and broadband deployment;
- 14 (c) Review the feasibility of alternative technologies and providers
- in accelerating access to faster and more reliable broadband service for
- 16 rural residents;
- 17 (d) Examine alternatives for deployment of broadband services to
- 18 areas that remain unserved or underserved, such as funding redirection
- 19 reverse auction programs described in section 86-330, public-private
- 20 partnerships, funding for competitive deployment, and other measures, and
- 21 make recommendations to the Public Service Commission to encourage
- 22 deployment in such areas;
- 23 (e) Recommend state policies to effectively utilize state universal
- 24 service fund dollars to leverage federal universal service fund support
- 25 and other federal funding;
- 26 (f) Make recommendations to the Governor and Legislature as to the
- 27 most effective and efficient ways that federal broadband rural
- 28 infrastructure funds received after July 1, 2018, should be expended if
- 29 such funds become available; and
- 30 (g) Determine other issues that may be pertinent to the purpose of
- 31 the task force.

- 1 (4) Task force members shall serve on the task force without 2 compensation but shall be entitled to receive reimbursement for expenses 3 incurred for such service as provided in sections 81-1174 to 81-1177.
- 4 (5) The task force shall meet at the call of the chairperson and 5 shall present its findings in a report to the Executive Board of the 6 Legislative Council no later than November 1, 2019, and by November 1 7 every odd-numbered year thereafter. The report shall be submitted 8 electronically.
- 9 (6) For purposes of this section, broadband services means high10 speed telecommunications capability at a minimum download speed of
 11 twenty-five megabits per second and a minimum upload speed of three
 12 megabits per second, and that enables users to originate and receive
 13 high-quality voice, data, and video telecommunications using any
 14 technology.
