1 Section 1. Section 32-101, Revised Statutes Cumulative

- 4 <u>act</u> shall be known and may be cited as the Election Act.
- 5 Sec. 2. Any person engaged in or pursuing a write-in
- 6 campaign for the office of President of the United States shall file
- 7 <u>with the Secretary of State a notarized affidavit of his or her</u>
- 8 <u>intent together with an application containing:</u>
- 9 (1) The name of the person pursuing the write-in
- 10 <u>campaign;</u>
- 11 (2) The written consent of the designated vice-
- 12 presidential candidate; and
- 13 (3) The names and addresses of the persons who will
- 14 represent the applicant as presidential elector candidates together
- 15 with the written consent of such persons to become candidates.
- 16 Sec. 3. Section 32-620, Reissue Revised Statutes of
- 17 Nebraska, is amended to read:
- 18 32-620 (1) Partisan candidates for the offices of

- 20 election ballot shall be certified to the Governor and Secretary of

- 15 clear, intelligible mark, the vote shall be valid and the ballot
- 16 shall be counted. Except as provided in section 32-1007, a write-in
- 17 vote for a person who is not engaged in or pursuing a write-in
- 18 campaign pursuant to section 32-615 or section 2 of this act shall
- 19 not be counted.
- Sec. 5. Section 32-1007, Reissue Revised Statutes of
- 21 Nebraska, is amended to read:
- 32-1007 (1) For members of a village board of trustees,
- 23 township officers, or members of the school board of Class I or II
- 24 school districts, if a first or generally recognized name and last
- 25 name of a person is filled in on a line provided for that purpose and

the square or oval opposite such line has been marked with a cross or

2 other clear, intelligible mark, the vote shall be valid and the 3 ballot shall be counted. If only the last name of a person is in the 4 write-in space on the ballot and there is more than one person in the 5 county having the same last name, the counting board shall reject the ballot for that office unless the last name is reasonably close to 6 7 the proper spelling of the last name of a candidate engaged in or 8 pursuing a write-in campaign pursuant to section 32-615. The counting 9 board shall make the following notation on the rejected ballot: 10 Rejected for the office of, no first or generally recognized name. 11 12 (2) For President and Vice President, if a first or 13 generally recognized name and last name of a person is filled in on 14 the lines provided for that purpose and the square or oval opposite 15 such line has been marked with a cross or other clear, intelligible 16 mark, the vote shall be valid and the ballot shall be counted. If 17 only the last name of a person is in the write in space on the ballot 18 and there is no generally recognized candidate for President or Vice 19 President with that name, the counting board shall reject the ballot. 20 The counting board shall make the following notation on the rejected 21 ballot: Rejected for the office of President and Vice President, no 22 first or generally recognized name. 23 Sec. 6. Section 32-1008, Reissue Revised Statutes of Nebraska, is amended to read: 24

32-1008 If the write-in vote in the county for any

1 particular office referred to in section 32-1007 or for a person

- 2 pursuing a write-in campaign pursuant to section 32-615 or section 2
- 3 of this act totals less than five percent of the vote for such office
- 4 in the county and the election commissioner or county clerk believes
- 5 that such vote will not impact the outcome of the election, the
- 6 number of write-in votes for that office may be counted and listed
- 7 together as one total.
