LEGISLATIVE BILL 357

Committee:

- 1 A BILL FOR AN ACT relating to vehicles; to amend sections 60-154 and
- 2 60-301, Revised Statutes Cumulative Supplement, 2016; to increase
- 3 original certificate of title fees for vehicles transferred to
- 4 Nebraska from another state; to provide for distribution of such
- 5 fees; to provide for a voluntary contribution for programs for
- 6 persons suffering from a brain injury when registering a vehicle; to
- 7 harmonize provisions; and to repeal the original sections.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-154, Revised Statutes Cumulative Supplement,
2 2016, is amended to read:

3 60-154 (1)(a) Except as provided in subdivision (1)(b) of this
4 section, for ~~For~~ each original certificate of title issued by a county
5 for a motor vehicle or trailer, the fee shall be ten dollars. Three
6 dollars and twenty-five cents shall be retained by the county. Four
7 dollars shall be remitted to the State Treasurer for credit to the
8 Department of Motor Vehicles Cash Fund. Two dollars shall be remitted to
9 the State Treasurer for credit to the General Fund. Seventy-five cents
10 shall be remitted to the State Treasurer for credit as follows: Twenty
11 cents to the Motor Vehicle Fraud Cash Fund; forty-five cents to the
12 Nebraska State Patrol Cash Fund; and ten cents to the Nebraska Motor
13 Vehicle Industry Licensing Fund.

14 (b) For the first original certificate of title issued annually to a
15 person by a county for a motor vehicle or trailer being titled in
16 Nebraska from another state or country, the fee shall be as prescribed in
17 subdivision (1)(a) of this section. For each subsequent original
18 certificate of title issued to such person by a county for a motor
19 vehicle or trailer being titled in Nebraska from another state or
20 country, the fee shall be twenty-five dollars. Twelve dollars and fifty
21 cents shall be retained by the county. Six dollars shall be remitted to
22 the State Treasurer for credit to the Department of Motor Vehicles Cash
23 Fund. Four dollars and fifty cents shall be remitted to the State
24 Treasurer for credit to the General Fund. One dollar shall be remitted to
25 the State Treasurer for credit to the State Department of Education Cash
26 Fund for use by the State Department of Education for programs for
27 persons suffering from a brain injury. One dollar shall be remitted to
28 the State Treasurer for credit as follows: Twenty-five cents to the Motor
29 Vehicle Fraud Cash Fund; sixty-five cents to the Nebraska State Patrol
30 Cash Fund; and ten cents to the Nebraska Motor Vehicle Industry Licensing
31 Fund.

1 (2)(a) Except as provided in subdivision (2)(b) of this section, for
2 ~~(b) For~~ each original certificate of title issued by a county for an all-
3 terrain vehicle, a utility-type vehicle, or a minibike, the fee shall be
4 ten dollars. Three dollars and twenty-five cents shall be retained by the
5 county. Four dollars shall be remitted to the State Treasurer for credit
6 to the Department of Motor Vehicles Cash Fund. Two dollars shall be
7 remitted to the State Treasurer for credit to the General Fund. Seventy-
8 five cents shall be remitted to the State Treasurer for credit as
9 follows: Twenty cents to the Motor Vehicle Fraud Cash Fund; and fifty-
10 five cents to the Nebraska State Patrol Cash Fund.

11 (b) For the first original certificate of title issued annually to a
12 person by a county for an all-terrain vehicle, a utility-type vehicle, or
13 a minibike being titled in Nebraska from another state or country, the
14 fee shall be as prescribed in subdivision (2)(a) of this section. For
15 each subsequent original certificate of title issued to such person by a
16 county for an all-terrain vehicle, a utility-type vehicle, or a minibike
17 being titled in Nebraska from another state or country, the fee shall be
18 twenty-five dollars. Twelve dollars and fifty cents shall be retained by
19 the county. Six dollars shall be remitted to the State Treasurer for
20 credit to the Department of Motor Vehicles Cash Fund. Four dollars and
21 fifty cents shall be remitted to the State Treasurer for credit to the
22 General Fund. One dollar shall be remitted to the State Treasurer for
23 credit to the State Department of Education Cash Fund for use by the
24 State Department of Education for programs for persons suffering from a
25 brain injury. One dollar shall be remitted to the State Treasurer for
26 credit as follows: Twenty-five cents to the Motor Vehicle Fraud Cash
27 Fund; and seventy-five cents to the Nebraska State Patrol Cash Fund.

28 (3)(a) Except as provided in subdivision (3)(b) of this section and
29 in section 60-159.01, for ~~(2) For~~ each original certificate of title
30 issued by the Department of Motor Vehicles ~~department~~ for a vehicle
31 ~~except as provided in section 60-159.01,~~ the fee shall be ten dollars.

1 Four dollars shall be remitted to the State Treasurer for credit to the
2 Department of Motor Vehicles Cash Fund. Six dollars shall be remitted to
3 the State Treasurer for credit to the Motor Carrier Division Cash Fund.

4 (b) For the first original certificate of title issued annually to a
5 person by the department for a vehicle titled in Nebraska from another
6 state or country, the fee shall be as prescribed in subdivision (3)(a) of
7 this section. For each subsequent original certificate of title issued to
8 such person by the department for a vehicle titled in Nebraska from
9 another state or country, the fee shall be twenty-five dollars. Ten
10 dollars shall be remitted to the State Treasurer for credit to the
11 Department of Motor Vehicles Cash Fund. Fourteen dollars shall be
12 remitted to the State Treasurer for credit to the Motor Carrier Division
13 Cash Fund. One dollar shall be remitted to the State Treasurer for credit
14 to the State Department of Education Cash Fund for use by the State
15 Department of Education for programs for persons suffering from a brain
16 injury.

17 Sec. 2. Section 60-301, Revised Statutes Cumulative Supplement,
18 2016, is amended to read:

19 60-301 Sections 60-301 to 60-3,231 and section 3 of this act shall
20 be known and may be cited as the Motor Vehicle Registration Act.

21 Sec. 3. In addition to the fees required under the Motor Vehicle
22 Registration Act, a voluntary contribution of two dollars may be made if
23 the registrant indicates an intention to donate such contribution for
24 programs for persons suffering from a brain injury. Such contribution
25 shall be remitted to the State Treasurer for credit to the State
26 Department of Education Cash Fund for use by the State Department of
27 Education for programs for persons suffering from a brain injury.

29 Cumulative Supplement, 2016, are repealed.
