Committee:

- A BILL FOR AN ACT relating to vehicles; to amend sections 60-154 and 60-301, Revised Statutes Cumulative Supplement, 2016; to increase original certificate of title fees for vehicles transferred to Nebraska from another state; to provide for distribution of such fees; to provide for a voluntary contribution for programs for persons suffering from a brain injury when registering a vehicle; to harmonize provisions; and to repeal the original sections.
- 8 Be it enacted by the people of the State of Nebraska,

Section 1. Section 60-154, Revised Statutes Cumulative Supplement,

2 2016, is amended to read:

60-154 (1)(a) Except as provided in subdivision (1)(b) of this 3 4 section, for For each original certificate of title issued by a county for a motor vehicle or trailer, the fee shall be ten dollars. Three 5 dollars and twenty-five cents shall be retained by the county. Four 6 7 dollars shall be remitted to the State Treasurer for credit to the Department of Motor Vehicles Cash Fund. Two dollars shall be remitted to 8 9 the State Treasurer for credit to the General Fund. Seventy-five cents shall be remitted to the State Treasurer for credit as follows: Twenty 10 cents to the Motor Vehicle Fraud Cash Fund; forty-five cents to the 11 Nebraska State Patrol Cash Fund; and ten cents to the Nebraska Motor 12 13 Vehicle Industry Licensing Fund.

(b) For the first original certificate of title issued annually to a 14 person by a county for a motor vehicle or trailer being titled in 15 Nebraska from another state or country, the fee shall be as prescribed in 16 17 subdivision (1)(a) of this section. For each subsequent original certificate of title issued to such person by a county for a motor 18 vehicle or trailer being titled in Nebraska from another state or 19 country, the fee shall be twenty-five dollars. Twelve dollars and fifty 20 cents shall be retained by the county. Six dollars shall be remitted to 21 the State Treasurer for credit to the Department of Motor Vehicles Cash 22 23 Fund. Four dollars and fifty cents shall be remitted to the State 24 Treasurer for credit to the General Fund. One dollar shall be remitted to 25 the State Treasurer for credit to the State Department of Education Cash Fund for use by the State Department of Education for programs for 26 27 persons suffering from a brain injury. One dollar shall be remitted to 28 the State Treasurer for credit as follows: Twenty-five cents to the Motor 29 <u>Vehicle Fraud Cash Fund; sixty-five cents to the Nebraska State Patrol</u> Cash Fund; and ten cents to the Nebraska Motor Vehicle Industry Licensing 30 Fund. 31

1 (2)(a) Except as provided in subdivision (2)(b) of this section, for 2 (b) For each original certificate of title issued by a county for an allterrain vehicle, a utility-type vehicle, or a minibike, the fee shall be 3 4 ten dollars. Three dollars and twenty-five cents shall be retained by the 5 county. Four dollars shall be remitted to the State Treasurer for credit to the Department of Motor Vehicles Cash Fund. Two dollars shall be 6 remitted to the State Treasurer for credit to the General Fund. Seventy-7 five cents shall be remitted to the State Treasurer for credit as 8 9 follows: Twenty cents to the Motor Vehicle Fraud Cash Fund; and fifty-10 five cents to the Nebraska State Patrol Cash Fund.

11 (b) For the first original certificate of title issued annually to a person by a county for an all-terrain vehicle, a utility-type vehicle, or 12 13 a minibike being titled in Nebraska from another state or country, the fee shall be as prescribed in subdivision (2)(a) of this section. For 14 each subsequent original certificate of title issued to such person by a 15 16 county for an all-terrain vehicle, a utility-type vehicle, or a minibike 17 being titled in Nebraska from another state or country, the fee shall be twenty-five dollars. Twelve dollars and fifty cents shall be retained by 18 the county. Six dollars shall be remitted to the State Treasurer for 19 credit to the Department of Motor Vehicles Cash Fund. Four dollars and 20 fifty cents shall be remitted to the State Treasurer for credit to the 21 22 General Fund. One dollar shall be remitted to the State Treasurer for credit to the State Department of Education Cash Fund for use by the 23 24 State Department of Education for programs for persons suffering from a brain injury. One dollar shall be remitted to the State Treasurer for 25 credit as follows: Twenty-five cents to the Motor Vehicle Fraud Cash 26 Fund; and seventy-five cents to the Nebraska State Patrol Cash Fund. 27

(3)(a) Except as provided in subdivision (3)(b) of this section and in section 60-159.01, for (2) For each original certificate of title issued by the Department of Motor Vehicles department for a vehicle except as provided in section 60-159.01, the fee shall be ten dollars.

- 22 Registration Act, a voluntary contribution of two dollars may be made if
- 23 the registrant indicates an intention to donate such contribution for
- 24 programs for persons suffering from a brain injury. Such contribution
- 25 shall be remitted to the State Treasurer for credit to the State
- 26 <u>Department of Education Cash Fund for use by the State Department of</u>
- 27 <u>Education for programs for persons suffering from a brain injury.</u>
