A BILL

FOR AN ACT relating to public safety; to amend section 81-829.40, 2 Reissue Revised Statutes of Nebraska, and sections 28-1204.04 and 81-829.42, Revised Statutes Cumulative Supplement, 2012; to change provisions relating to unlawful possession of a firearm at a school; to change 5 the Governor's powers relating to firearms and increase 6 7 the authorized expenditure amount for aerial fire 8 suppression or hazardous material response under the 9 Emergency Management Act; and to repeal the original 10 sections.

11 Be it enacted by the people of the State of Nebraska,

Section 1. Section 28-1204.04, Revised Statutes

Cumulative Supplement, 2012, is amended to read:

3 28-1204.04 (1) Any person who possesses a firearm in a school, on school grounds, in a school-owned vehicle, or at a school-4 5 sponsored activity or athletic event is guilty of the offense of unlawful possession of a firearm at a school. Unlawful possession of 6 7 a firearm at a school is a Class IV felony. This subsection shall not 8 apply to (a) the issuance of firearms to or possession by members of the armed forces of the United States, active or reserve, National 9 Guard of this state, or Reserve Officers Training Corps or peace 10 officers or other duly authorized law enforcement officers when on 11 12 duty or training, (b) the possession of firearms by peace officers or 13 other duly authorized law enforcement officers when contracted by a 14 school to provide school security or school event control services, 15 (c) firearms which may lawfully be possessed by the person receiving instruction, for instruction under the immediate supervision of an 16 adult instructor, (d) firearms which may lawfully be possessed by a 17 18 member of a college or university rifle team, within the scope of such person's duties as a member of the team, (e) firearms which may 19 20 lawfully be possessed by a person employed by a college or university 21 in this state as part of an agriculture or a natural resources program of such college or university, within the scope of such 22 23 person's employment, (f) firearms contained within a private vehicle operated by a nonstudent adult which are not loaded and (i) are 24 encased or (ii) are in a locked firearm rack that is on a motor 25

vehicle, (q) firearms which may lawfully be possessed by a person for

the purpose of using them, with the approval of the school, in a

3 historical reenactment, in a hunter education program, or as part of 4 an honor quard, or (g) (h) a handgun carried as a concealed handgun 5 by a valid holder of a permit issued under the Concealed Handgun Permit Act in a vehicle or on his or her person while riding in or on 6 7 a vehicle into or onto any parking area, which is open to the public 8 and used by a school if, prior to exiting the vehicle, the handgun is 9 locked inside the glove box, trunk, or other compartment of the 10 vehicle, a storage box securely attached to the vehicle, or, if the vehicle is a motorcycle, a hardened compartment securely attached to 11 12 the motorcycle while the vehicle is in or on such parking area, 13 except as prohibited by federal law. For purposes of this subsection, encased means enclosed in a case that is expressly made for the 14 15 purpose of containing a firearm and that is completely zipped, 16 snapped, buckled, tied, or otherwise fastened with no part of the firearm exposed. 17 (2) Any firearm possessed in violation of subsection (1) 18 of this section shall be confiscated without warrant by a peace 19 20 officer or may be confiscated without warrant by school 21 administrative or teaching personnel. Any firearm confiscated by 22 school administrative or teaching personnel shall be delivered to a 23 peace officer as soon as practicable. (3) Any firearm confiscated by or given to a peace 24 25 officer pursuant to subsection (2) of this section shall be declared

a common nuisance and shall be held by the peace officer prior to his or her delivery of the firearm to the property division of the law enforcement agency which employs the peace officer. The property division of such law enforcement agency shall hold such firearm for as long as the firearm is needed as evidence. After the firearm is no longer needed as evidence, it shall be destroyed in such manner as

the court may direct.

(4) Whenever a firearm is confiscated and held pursuant 8 to this section or section 28-1204.02, the peace officer who received 9 such firearm shall cause to be filed within ten days after the 10 confiscation a petition for destruction of such firearm. The petition 11 12 shall be filed in the district court of the county in which the 13 confiscation is made. The petition shall describe the firearm held, state the name of the owner, if known, allege the essential elements 14 15 of the violation which caused the confiscation, and conclude with a 16 prayer for disposition and destruction in such manner as the court may direct. At any time after the confiscation of the firearm and 17 prior to court disposition, the owner of the firearm seized may 18 19 petition the district court of the county in which the confiscation 20 was made for possession of the firearm. The court shall release the firearm to such owner only if the claim of ownership can reasonably 21 22 be shown to be true and either (a) the owner of the firearm can show 23 that the firearm was taken from his or her property or place of 24 business unlawfully or without the knowledge and consent of the owner 25 and that such property or place of business is different from that of

1 the person from whom the firearm was confiscated or (b) the owner of

- 2 the firearm is acquitted of the charge of unlawful possession of a
- 3 handgun in violation of section 28-1204, unlawful transfer of a
- 4 firearm to a juvenile, or unlawful possession of a firearm at a
- 5 school. No firearm having significant antique value or historical
- 6 significance as determined by the Nebraska State Historical Society
- 7 shall be destroyed. If a firearm has significant antique value or
- 8 historical significance, it shall be sold at auction and the proceeds
- 9 shall be remitted to the State Treasurer for distribution in
- 10 accordance with Article VII, section 5, of the Constitution of
- 11 Nebraska.
- 12 Sec. 2. Section 81-829.40, Reissue Revised Statutes of
- 13 Nebraska, is amended to read:
- 14 81-829.40 (1) The Governor shall be responsible for
- 15 meeting the dangers to the state and people presented by disasters,
- 16 emergencies, and civil defense emergencies, and in the event of
- 17 disaster, emergency, or civil defense emergency beyond local control,
- 18 he or she may assume direct operational control over all or any part
- 19 of the emergency management functions within this state. He or she
- 20 shall have general direction and control of emergency management and
- 21 the Nebraska Emergency Management Agency and shall be responsible for
- 22 carrying out the provisions of the Emergency Management Act.
- 23 (2) In order to effect the policy and purposes of the
- 24 act, the Governor may issue proclamations and make, amend, and
- 25 rescind the necessary orders, rules, and regulations to carry out the

1 act.

2 (3) A state of emergency proclamation shall be issued by 3 the Governor if he or she finds that a disaster, emergency, or civil defense emergency has occurred or that the occurrence or threat 4 5 thereof is imminent. All proclamations issued under this subsection 6 shall indicate the nature of the disaster, emergency, or civil 7 defense emergency, the area or areas threatened, and the conditions 8 which have brought about the state of emergency. All proclamations shall be disseminated promptly by means calculated to bring the 9 contents to the attention of the general public and shall be promptly 10 filed with the Nebraska Emergency Management Agency, the Secretary of 11 12 State, and the clerks of the local governments in the area to which 13 it applies. The proclamation shall continue in effect until the 14 Governor finds that the threat or danger has passed or the disaster, 15 emergency, or civil defense emergency has been dealt with to the extent that those conditions no longer exist and terminates the 16 proclamation by letter of notice to such agency, the Secretary of 17 State, and the clerks of the local governments in the area to which 18 it applies. The Legislature by resolution may terminate a state of 19 20 emergency proclamation at any time, whereupon the Governor shall 21 terminate the proclamation by letter of notice to such agency, the Secretary of State, and the clerks of the local governments in the 22 23 area to which it applies. (4) A state of emergency proclamation shall activate 24

state, city, village, county, and interjurisdictional emergency

1 management organizations and emergency operations plans applicable to

- 2 the local government or area in question and shall be the authority
- 3 for the deployment and use of any forces to which the plan or plans
- 4 apply and for use or distribution of any supplies, equipment,
- 5 materials, and facilities assembled, stockpiled, or arranged to be
- 6 made available pursuant to the act or any other provision of law
- 7 relating to disasters, emergencies, or civil defense emergencies.
- 8 (5) During the continuance of any state of emergency, the
- 9 Governor shall be commander in chief of the organized and unorganized
- 10 militia and of all other forces available for emergency management
- 11 duty. To the greatest extent practicable, the Governor shall delegate
- 12 or assign command authority by prior arrangement embodied in
- 13 appropriate proclamations, orders, rules, and regulations, but
- 14 nothing shall restrict his or her authority to do so by orders issued
- 15 at the time of the disaster, emergency, or civil defense emergency.
- 16 (6) In addition to any other powers conferred upon the
- 17 Governor by law, he or she may:
- 18 (a) Suspend the provisions of any regulatory statute
- 19 prescribing the procedures for conduct of state business or the
- 20 orders, rules, or regulations of any state agency if strict
- 21 compliance with the provisions of any statute, order, rule, or
- 22 regulation would in any way prevent, hinder, or delay necessary
- 23 action in coping with the disaster, emergency, or civil defense
- 24 emergency;
- 25 (b) Utilize all available resources of the state

1 government and of each political subdivision of the state as are

- 2 reasonably necessary to cope with the disaster, emergency, or civil
- 3 defense emergency;
- 4 (c) Transfer the direction, personnel, or functions of
- 5 state departments and agencies or units thereof for the purpose of
- 6 performing or facilitating emergency management;
- 7 (d) Subject to any applicable requirements for
- 8 compensation under section 81-829.57, commandeer or utilize any
- 9 private property if he or she finds this necessary to cope with the
- 10 disaster, emergency, or civil defense emergency;
- 11 (e) Direct and compel the evacuation of all or part of
- 12 the population from any stricken or threatened area within the state
- 13 if he or she deems this action necessary for the preservation of life
- or other emergency management;
- 15 (f) Prescribe routes, modes of transportation, and
- 16 destinations in connection with evacuation;
- 17 (g) Control ingress and egress to and from a disaster
- 18 area, the movement of persons within the area, and the occupancy of
- 19 premises in the area;
- 20 (h) Suspend or limit the sale, dispensing, or
- 21 transportation of alcoholic beverages, firearms, explosives, and
- 22 combustibles; and
- 23 (i) Make provisions for the availability and use of
- 24 temporary emergency housing.
- 25 (7) In the event of a civil defense emergency, the

1 Governor shall assume direct operational control over all or any part

- 2 of the emergency management functions within this state.
- 3 Sec. 3. Section 81-829.42, Revised Statutes Cumulative
- 4 Supplement, 2012, is amended to read:
- 5 81-829.42 (1) The Legislature recognizes that, while
- 6 appropriations are adequate to meet the normal needs, the necessity
- 7 exists for anticipating and making advance provision to care for the
- 8 unusual and extraordinary burdens imposed on the state and its
- 9 political subdivisions by disasters, emergencies, or civil defense
- 10 emergencies. To meet such situations, it is the intention of the
- 11 Legislature to confer emergency powers on the Governor, acting
- 12 through the Adjutant General and the Nebraska Emergency Management
- 13 Agency, and to vest him or her with adequate power and authority
- 14 within the limitation of available funds appropriated to the
- 15 Governor's Emergency Program to meet any disaster, emergency, or
- 16 civil defense emergency.
- 17 (2) There is hereby established the Governor's Emergency
- 18 Program. Funds appropriated to the program shall be expended, upon
- 19 direction of the Governor, for any state of emergency. The state of
- 20 emergency proclamation shall set forth the emergency and shall state
- 21 that it requires the expenditure of public funds to furnish immediate
- 22 aid and relief. The Adjutant General shall administer the funds
- 23 appropriated to the program.
- 24 (3) It is the intent of the Legislature that the first
- 25 recourse shall be to funds regularly appropriated to state and local

agencies. If the Governor finds that the demands placed upon these funds are unreasonably great, he or she may make funds available from the Governor's Emergency Program. Expenditures may be made upon the direction of the Governor for any or all emergency management functions or to meet the intent of the state emergency operations plans as outlined in section 81-829.41. Expenditures may also be made to state and federal agencies to meet the matching requirement of any

applicable assistance programs.

9 Assistance shall be provided from the (4)appropriated to the Governor's Emergency Program to political 10 11 subdivisions of this state which have suffered from a disaster, 12 emergency, or civil defense emergency to such an extent as to impose 13 a severe financial burden exceeding the ordinary capacity of the subdivision affected. Applications for aid under this section shall 14 15 be made to the Nebraska Emergency Management Agency on such forms as shall be prescribed and furnished by the agency. The forms shall 16 require the furnishing of sufficient information to determine 17 eligibility for aid and the extent of the financial burden incurred. 18 19 The agency may call upon other agencies of the state in evaluating 20 such applications. The Adjutant General shall review each application 21 for aid under this section and recommend its approval or disapproval, in whole or in part, to the Governor. If the Governor approves, he or 22 23 she shall determine and certify to the Adjutant General the amount of aid to be furnished. The Adjutant General shall thereupon issue his 24 or her voucher to the Director of Administrative Services who shall 25

- 1 issue his or her warrants therefor to the applicant.
- 2 (5) When a state of emergency has been proclaimed by the
- 3 Governor, the Adjutant General, upon order of the Governor, shall
- 4 have authority to expend funds for purposes including, but not
- 5 limited to:
- 6 (a) The purposes of the Emergency Management Act,
- 7 including emergency management functions and the responsibilities of
- 8 the Governor as outlined in the act;
- 9 (b) Employing for the duration of the state of emergency
- 10 additional personnel and contracting or otherwise procuring all
- 11 necessary appliances, supplies, and equipment;
- 12 (c) Performing services for and furnishing materials and
- 13 supplies to state government agencies and local governments with
- 14 respect to performance of any duties enjoined by law upon such
- 15 agencies and local governments which they are unable to perform
- 16 because of extreme climatic phenomena and receiving reimbursement in
- 17 whole or in part from such agencies and local governments able to pay
- 18 therefor under such terms and conditions as may be agreed upon by the
- 19 Adjutant General and any such agency or local government;
- 20 (d) Performing services for and furnishing materials to
- 21 any individual in connection with alleviating hardship and distress
- 22 growing out of extreme climatic phenomena and receiving reimbursement
- 23 in whole or in part from such individual under such terms as may be
- 24 agreed upon by the Adjutant General and such individual;
- 25 (e) Opening up, repairing, and restoring roads and

- 1 highways;
- 2 (f) Repairing and restoring bridges;
- 3 (g) Furnishing transportation for supplies to alleviate
- 4 suffering and distress;
- 5 (h) Restoring means of communication;
- 6 (i) Furnishing medical services and supplies to prevent
- 7 the spread of disease and epidemics;
- 9 (k) Training individuals or governmental agencies for the
- 10 purpose of perfecting the performance of emergency management duties
- 11 as provided in the Nebraska emergency operations plans;
- 12 (1) Procurement and storage of special emergency supplies
- 13 or equipment, determined by the Adjutant General to be required to
- 14 provide rapid response by state government to assist local
- 15 governments in impending or actual disasters, emergencies, or civil
- 16 defense emergencies;
- 17 (m) Clearing or removing debris and wreckage which may
- 18 threaten public health or safety from publicly owned or privately
- 19 owned land or water; and
- 20 (n) Such other measures as are customarily necessary to
- 21 furnish adequate relief in cases of disaster, emergency, or civil
- 22 defense emergency.
- 23 (6) If aerial fire suppression or hazardous material
- 24 response is immediately required, the Adjutant General may make
- 25 expenditures of up to ten twenty-five thousand dollars per event

1 without a state of emergency proclamation issued by the Governor.

- 2 (7) The Governor may receive such voluntary contributions
- 3 as may be made from any nonfederal source to aid in carrying out the
- 4 purposes of this section and shall credit the same to the Governor's
- 5 Emergency Cash Fund.
- 6 (8) All obligations and expenses incurred by the Governor
- 7 in the exercise of the powers and duties vested in the Governor by
- 8 this section shall be paid by the State Treasurer out of available
- 9 funds appropriated to the Governor's Emergency Program, and the
- 10 Director of Administrative Services shall draw his or her warrants
- 11 upon the State Treasurer for the payment of such sum, or so much
- 12 thereof as may be required, upon receipt by him or her of proper
- 13 vouchers duly approved by the Adjutant General.
- 14 (9) This section shall be liberally construed in order to
- 15 accomplish the purposes of the Emergency Management Act and to permit
- 16 the Governor to adequately cope with any disaster, emergency, or
- 17 civil defense emergency which may arise, and the powers vested in the
- 18 Governor by this section shall be construed as being in addition to
- 19 all other powers presently vested in him or her and not in derogation
- 20 of any existing powers.
- 21 (10) Such funds as may be made available by the
- 22 government of the United States for the purpose of alleviating
- 23 distress from disasters, emergencies, and civil defense emergencies
- 24 may be accepted by the State Treasurer and shall be credited to a
- 25 separate and distinct fund unless otherwise specifically provided in

1 the act of Congress making such funds available or as otherwise

- 2 allowed and provided by state law.
