- A BILL FOR AN ACT relating to the Livestock Animal Welfare Act; to amend sections 54-903 and 54-909, Reissue Revised Statutes of Nebraska, and sections 54-901 and 54-902, Revised Statutes Cumulative Supplement, 2014; to redefine terms; to change criminal penalties; to provide for animal cruelty investigation agents as prescribed; to provide powers and duties for the Director of Agriculture; to provide fees; and to repeal the original sections.

1 Section 1. Section 54-901, Revised Statutes Cumulative Supplement,

- 7 54-902 For purposes of the Livestock Animal Welfare Act:
- 8 (1) Abandon means to leave a livestock animal in one's care, whether
- 9 as owner or custodian, for any length of time without making effective
- 10 provision for the livestock animal's feed, water, or other care as is
- 11 reasonably necessary for the livestock animal's health;
- 12 (2) Animal welfare practice means veterinarian practices and animal
- 13 husbandry practices common to the livestock animal industry, including
- 14 transport of livestock animals from one location to another;
- 15 (3) Bovine means a cow, an ox, or a bison;
- 16 (4) Cruelly mistreat means to knowingly and intentionally kill or
- 17 cause physical harm to a livestock animal in a manner that is not
- 18 consistent with animal welfare practices;
- 19 (5) Cruelly neglect means to fail to provide a livestock animal in
- 20 one's care, whether as owner or custodian, with feed, water, or other
- 21 care consistent with customary animal husbandry practices as is
- 22 reasonably necessary for the livestock animal's health;
- 23 (6) Equine means a horse, pony, donkey, mule, or hinny;
- 24 (7) Euthanasia means the destruction of a livestock animal by
- 25 commonly accepted veterinary practices;
- 26 (8) Law enforcement officer means any member of the Nebraska State
- 27 Patrol, any county or deputy sheriff, any member of the police force of
- 28 any city or village, or any other public official authorized by a city or
- 29 village to enforce state or local laws, rules, regulations, or
- 30 ordinances;
- 31 (9) Livestock animal means any bovine, equine, swine, sheep, goats,

- 1 domesticated cervine animals, ratite birds, llamas, or poultry;
- 2 (10) Owner or custodian means any person owning, keeping,
- 3 possessing, harboring, or knowingly permitting an animal to remain on or
- 4 about any premises owned or occupied by such person; and
- 5 (11) Serious injury or illness includes any injury or illness to any
- 6 livestock animal which creates a substantial risk of death or which
- 7 causes broken bones, prolonged impairment of health, or prolonged loss or
- 8 impairment of the function of any bodily organ.
- 9 Sec. 3. Section 54-903, Reissue Revised Statutes of Nebraska, is

- 11 54-903 (1) A person who intentionally, knowingly, or recklessly
- 12 abandons or cruelly neglects a livestock animal is guilty of a Class I
- 13 misdemeanor unless the abandonment or cruel neglect results in serious
- 14 injury or illness or death of the livestock animal, in which case it is a
- 15 Class IV felony. A person shall not be guilty of more than one offense
- 16 under this subsection for acts or omissions affecting multiple livestock
- 17 animals managed as a herd during any period of uninterrupted abandonment
- 18 or neglect.
- 19 (2) A person who cruelly mistreats a livestock animal is guilty of a
- 20 Class I misdemeanor for the first offense and a Class IV felony for any
- 21 subsequent offense.
- 22 Sec. 4. Section 54-909, Reissue Revised Statutes of Nebraska, is
- 23 amended to read:
- 24 54-909 (1) If a person is convicted of a Class IV felony under
- 25 section 54-903, the sentencing court shall order such person not to own
- 26 or possess a livestock animal for at least five years after the date of
- 27 conviction, but such time restriction shall not exceed fifteen years. Any
- 28 person violating such court order shall be guilty of a Class I
- 29 misdemeanor.
- 30 (2) If a person is convicted of a <u>second or subsequent</u> Class I
- 31 misdemeanor under section 54-903 or a second or subsequent Class III

- 1 misdemeanor under section 54-904, the sentencing court may order such
- 2 person not to own or possess any livestock animal after the date of
- 3 conviction, but such time restriction, if any, shall not exceed five
- 4 years. Any person violating such court order shall be guilty of a Class
- 5 IV misdemeanor.
- 6 (3) Any livestock animal involved in a violation of a court order
- 7 under subsection (1) or (2) of this section shall be subject to seizure
- 8 by law enforcement.
- 9 Sec. 5. (1) The Director of Agriculture may commission animal
- 10 cruelty investigation agents who shall be licensed veterinarians who have
- 11 completed training or acquired certification as specified by the
- 12 <u>director</u>. The director may determine the number and classification of
- 13 <u>commissioned agents so as to provide specialization in the various</u>
- 14 livestock species as needed and for geographic dispersal of availability
- 15 of commissioned agents. The director shall furnish or contract for
- 16 training and certification services to qualify persons for commission
- 17 under this section. Such commissioned agents shall be agents of the state
- 18 for purposes of the State Tort Claims Act when acting within the agent's
- 19 commission.
- 20 (2) Upon the request of a law enforcement agency, the director shall
- 21 assign an agent to advise and assist law enforcement officers in the
- 22 examination, assessment, care, and disposition of livestock animals
- 23 <u>inspected or seized while in the course of carrying out duties or</u>
- 24 authorities assigned to law enforcement officers pursuant to the
- 25 Livestock Animal Welfare Act, to assist in the collection and
- 26 <u>preservation of evidence under the act, and to represent the State</u>
- 27 <u>Veterinarian regarding any livestock health interests of the Department</u>
- 28 <u>of Agriculture with respect to such animals.</u>
- 29 (3) Agents assigned by the director shall be paid an advisory fee by
- 30 the law enforcement agency to whom they are assigned. The advisory fee
- 31 shall be one hundred fifty dollars per day plus reimbursement for any

- 1 costs incurred by the agent to provide care, treatment, examination, or
- 2 <u>other veterinary services requested by law enforcement officers.</u>
- 3 (4) This section shall not be construed to assign to the director or
- 4 <u>to require or authorize the director to assume any duties or</u>
- 5 <u>responsibilities for enforcement of the Livestock Animal Welfare Act or</u>
- 6 responsibility for the care and disposition of livestock animals beyond
- 7 the director's responsibility and authority relating to livestock health.
