- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 83-107.01, Revised Statutes Cumulative
- 2 Supplement, 2020, is amended to read:
- 3 83-107.01 (1) The official names of the state institutions under the
- 4 supervision of the Department of Health and Human Services shall be as
- 5 follows: (a) Beatrice State Developmental Center, (b) Lincoln Regional
- 6 Center, (c) Norfolk Regional Center, (d) Hastings Regional Center, (e)
- 7 Youth Rehabilitation and Treatment Center-Kearney, and (f) Youth
- 8 Rehabilitation and Treatment Center-Geneva.
- 9 (2)(a) This subsection applies beginning July 1, 2021.
- 10 (b) Except as provided in subdivision (2)(e) of this section, so
- 11 long as the department operates the Youth Rehabilitation and Treatment
- 12 Center-Kearney, such institution shall be used for the treatment of boys
- 13 only.
- 14 (c) Except as provided in subdivision (2)(e) of this section, so
- 15 long as the department operates the Youth Rehabilitation and Treatment
- 16 Center-Geneva, such institution shall be used for the treatment of girls
- 17 only.
- 18 (d) For any other facility operated and utilized as a youth
- 19 rehabilitation and treatment center in compliance with state law, the
- 20 department shall ensure safe and appropriate gender separation.
- 21 (e) In the event of an emergency, the department may use either the
- 22 Youth Rehabilitation and Treatment Center-Kearney or the Youth
- 23 Rehabilitation and Treatment Center-Geneva for the treatment of juveniles
- 24 of both genders for up to seven days. During any such use the department
- 25 shall ensure safe and appropriate gender separation.
- 26 (f) For purposes of this section, emergency means a public health
- 27 emergency or a situation including fire, flood, tornado, natural
- 28 disaster, or damage to the institution that renders an institution
- 29 uninhabitable. Emergency does not include inadequate staffing.
- 30 (3) It is the intent of the Legislature that no institution under
- 31 the supervision of the Department of Health and Human Services at which

- 1 the department provides inpatient or subacute substance abuse or
- 2 <u>behavioral</u> health residential treatment for juveniles under the
- 3 jurisdiction of a juvenile court shall delay such treatment to a juvenile
- 4 when such treatment has been determined necessary under subsection (2) of
- 5 <u>section 43-407 or has been ordered by a juvenile court.</u>
