- 4 Cumulative Supplement, 2016; to provide additional funding for the
- 5 Nebraska Child Abuse Prevention Fund; to provide for Choose Life
- 6 License Plates; to change provisions relating to personalized

- 9 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 43-1906, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 43-1906 (1) There is hereby established the Nebraska Child Abuse
- 4 Prevention Fund. The additional docket fee as provided in section
- 5 33-106.03, the fees for Choose Life License Plates as provided in section
- 6 9 of this act, the additional charge for supplying a certified copy of
- 7 the record of any birth as provided in sections 71-612, 71-617.15,
- 8 71-627, and 71-628, and all amounts which may be received from grants,
- 9 gifts, bequests, the federal government, or other sources granted or
- 10 given for the purposes specified in sections 43-1901 to 43-1906 shall be
- 11 remitted to the State Treasurer for credit to the Nebraska Child Abuse
- 12 Prevention Fund. The fund shall be administered and disbursed by the
- 13 department.
- 14 (2) Any money in the fund available for investment shall be invested
- 15 by the state investment officer pursuant to the Nebraska Capital
- 16 Expansion Act and the Nebraska State Funds Investment Act.
- 17 (3) In any one fiscal year, no more than twenty percent of the
- 18 annually appropriated funds shall be disbursed to any one agency,
- 19 organization, or individual.
- 20 (4) Funds allocated from the fund shall only be used for purposes
- 21 authorized under sections 43-1901 to 43-1906 and shall not be used to
- 22 supplant any existing governmental program or service. No grants may be
- 23 made to any state department or agency.
- 24 Sec. 2. Section 60-301, Revised Statutes Cumulative Supplement,
- 25 2016, is amended to read:
- 26 60-301 Sections 60-301 to 60-3,231 <u>and sections 8 and 9 of this act</u>
- 27 shall be known and may be cited as the Motor Vehicle Registration Act.
- 28 Sec. 3. Section 60-393, Revised Statutes Cumulative Supplement,
- 29 2016, is amended to read:
- 30 60-393 Any owner who has two or more motor vehicles or trailers
- 31 required to be registered under the Motor Vehicle Registration Act may

- register all such motor vehicles or trailers on a calendar-year basis or 1 2 on an annual basis for the same registration period beginning in a month chosen by the owner. When electing to establish the same registration 3 4 period for all such motor vehicles or trailers, the owner shall pay the 5 registration fee, the motor vehicle tax imposed in section 60-3,185, the motor vehicle fee imposed in section 60-3,190, and the alternative fuel 6 7 fee imposed in section 60-3,191 on each motor vehicle for the number of months necessary to extend its current registration period to the 8 9 registration period under which all such motor vehicles or trailers will be registered. Credit shall be given for registration paid on each motor 10 vehicle or trailer when the motor vehicle or trailer has a later 11 expiration date than that chosen by the owner except as otherwise 12 13 provided in sections 60-3,121, 60-3,122.02, 60-3,122.04, 60-3,224, and 60-3,227 and section 9 of this act. Thereafter all such 14 motor vehicles or trailers shall be registered on an annual basis 15 starting in the month chosen by the owner. 16
- 17 Sec. 4. Section 60-395, Revised Statutes Cumulative Supplement, 18 2016, is amended to read:
- 60-395 (1) Except as otherwise provided in subsection (2) of this 19 section and sections 60-3,121, 60-3,122.02, 60-3,122.04, 60-3,128, 20 60-3,224, and 60-3,227 and section 9 of this act, the registration shall 21 expire and the registered owner or lessee may, 22 by returning the 23 registration certificate, the license plates, and, when appropriate, the 24 validation decals and by either making application on a form prescribed 25 by the department to the county treasurer of the occurrence of an event described in subdivisions (a) through (e) of this subsection or, in the 26 27 case of a change in situs, displaying to the county treasurer the registration certificate of such other state as evidence of a change in 28 situs, receive a refund of that part of the unused fees and taxes on 29 motor vehicles or trailers based on the number of unexpired months 30 remaining in the registration period from the date of any of the 31

- 7 registered is subsequently declared by legislative act or court decision
- 8 to be illegal or ineligible to be operated or towed on the public roads
- 9 and no longer subject to registration fees, the motor vehicle tax imposed
- in section 60-3,185, the motor vehicle fee imposed in section 60-3,190,
- and the alternative fuel fee imposed in section 60-3,191;
- 12 (e) Upon a trade-in or surrender of a motor vehicle under a lease;
- 13 or
- 14 (f) In case of a change in the situs of a motor vehicle or trailer
- 15 to a location outside of this state.
- 16 (2) If the date of the event falls within the same calendar month in
- 17 which the motor vehicle or trailer is acquired, no refund shall be
- 18 allowed for such month.
- 19 (3) If the transferor or lessee acquires another motor vehicle at
- 20 the time of the transfer, trade-in, or surrender, the transferor or
- 21 lessee shall have the credit provided for in this section applied toward
- 22 payment of the motor vehicle fees and taxes then owing. Otherwise, the
- 23 transferor or lessee shall file a claim for refund with the county
- 24 treasurer upon an application form prescribed by the department.
- 25 (4) The registered owner or lessee shall make a claim for refund or
- 26 credit of the fees and taxes for the unexpired months in the registration
- 27 period within sixty days after the date of the event or shall be deemed
- 28 to have forfeited his or her right to such refund or credit.
- (5) For purposes of this section, the date of the event shall be:
- 30 (a) In the case of a transfer or loss, the date of the transfer or loss;
- 31 (b) in the case of a change in the situs, the date of registration in

- 1 another state; (c) in the case of a trade-in or surrender under a lease,
- 2 the date of trade-in or surrender; (d) in the case of a legislative act,
- 3 the effective date of the act; and (e) in the case of a court decision,
- 4 the date the decision is rendered.
- 5 (6) Application for registration or for reassignment of license
- 6 plates and, when appropriate, validation decals to another motor vehicle
- 7 or trailer shall be made within thirty days of the date of purchase.
- 8 (7) If a motor vehicle or trailer was reported stolen under section
- 9 60-178, a refund under this section shall not be reduced for a lost plate
- 10 charge and a credit under this section may be reduced for a lost plate
- 11 charge but the applicant shall not be required to pay the plate fee for
- 12 new plates.
- 13 (8) The county treasurer shall refund the motor vehicle fee and
- 14 registration fee from the fees which have not been transferred to the
- 15 State Treasurer. The county treasurer shall make payment to the claimant
- 16 from the undistributed motor vehicle taxes of the taxing unit where the
- 17 tax money was originally distributed. No refund of less than two dollars
- 18 shall be paid.

- 21 60-396 Whenever the registered owner files an application with the
- 22 county treasurer showing that a motor vehicle or trailer is disabled and
- 23 has been removed from service, the registered owner may, by returning the
- 24 registration certificate, the license plates, and, when appropriate, the
- 25 validation decals or, in the case of the unavailability of such
- 26 registration certificate or certificates, license plates, or validation
- 27 decals, then by making an affidavit to the county treasurer of such
- 28 disablement and removal from service, receive a credit for a portion of
- 29 the registration fee from the fee deposited with the State Treasurer at
- 30 the time of registration based upon the number of unexpired months
- 31 remaining in the registration year except as otherwise provided in

The owner shall also receive a credit for the unused portion of the motor vehicle tax and fee based upon the 3 4 number of unexpired months remaining in the registration year. When the 5 owner registers a replacement motor vehicle or trailer at the time of filing such affidavit, the credit may be immediately applied against the 6 registration fee and the motor vehicle tax and fee for the replacement 7 motor vehicle or trailer. When no such replacement motor vehicle or 8 9 trailer is so registered, the county treasurer shall forward the application and affidavit, if any, to the State Treasurer who shall 10 determine the amount, if any, of the allowable credit for the 11 registration fee and issue a credit certificate to the owner. For the 12 motor vehicle tax and fee, the county treasurer shall determine the 13 amount, if any, of the allowable credit and issue a credit certificate to 14 the owner. When such motor vehicle or trailer is removed from service 15 16 within the same month in which it was registered, no credits shall be allowed for such month. The credits may be applied against taxes and fees 17 for new or replacement motor vehicles or trailers incurred within one 18 year after cancellation of registration of the motor vehicle or trailer 19 for which the credits were allowed. When any such motor vehicle or 20 trailer is reregistered within the same registration year in which its 21 registration has been canceled, the taxes and fees shall be that portion 22 23 of the registration fee and the motor vehicle tax and fee for the 24 remainder of the registration year.

- 7 60-3,130.04 (1) An owner of a historical vehicle eligible for
- 8 registration under section 60-3,130 may use a license plate or plates
- 9 designed by this state in the year corresponding to the model year when
- 10 the vehicle was manufactured in lieu of the plates designed pursuant to
- 11 section 60-3,130.03 subject to the approval of the department. The
- 12 department shall inspect the plate or plates and may approve the plate or
- 13 plates if it is determined that the model-year license plate or plates
- 14 are legible and serviceable and that the license plate numbers do not
- 15 conflict with or duplicate other numbers assigned and in use. An
- 16 original-issued license plate or plates that have been restored to
- 17 original condition may be used when approved by the department.

- 4 as Choose Life License Plates. The department shall create designs
- 5 reflecting support for the protection of Nebraska's children. The design
- 6 shall be selected on the basis of limiting the manufacturing cost of each
- 7 plate to an amount less than or equal to the amount charged for license
- 8 plates pursuant to section 60-3,102. The department shall make
- 9 applications available for this type of plate beginning January 1, 2018.
- 10 The department may adopt and promulgate rules and regulations to carry
- 11 <u>out this section and section 9 of this act.</u>
- 12 (2) One type of Choose Life License Plates shall be alphanumeric
- 13 plates. The department shall:

- 21 department for Choose Life License Plates in lieu of regular license

- 24 registered under section 60-3,198. An applicant receiving a Choose Life
- 25 License Plate for a farm truck with a gross weight of over sixteen tons
- 26 <u>or a commercial truck or truck-tractor with a gross weight of five tons</u>
- 27 or over shall affix the appropriate tonnage decal to the plate. The
- 28 <u>department shall make forms available for such applications through the</u>
- 29 county treasurers. The license plates shall be issued upon payment of the

- 5 pursuant to this subdivision shall remit them to the State Treasurer. The
- 6 State Treasurer shall credit five dollars of the fee to the Nebraska
- 7 Child Abuse Prevention Fund.
- 8 (b) In addition to all other fees required for registration under
- 9 <u>the Motor Vehicle Registration Act, each application for initial issuance</u>
- 10 or renewal of personalized message Choose Life License Plates shall be
- 11 <u>accompanied by a fee of forty dollars. County treasurers collecting fees</u>
- 12 pursuant to this subdivision shall remit them to the State Treasurer. The
- 13 State Treasurer shall credit twenty-five percent of the fee for initial
- 14 issuance and renewal of such plates to the Department of Motor Vehicles

- 17 (3) When the department receives an application for Choose Life

- 26 (4) The owner of a motor vehicle or trailer bearing Choose Life
- 27 License Plates may apply to the county treasurer to have such plates

- 3 accompanied by a fee of three dollars. Fees collected pursuant to this
- 4 subsection shall be remitted to the State Treasurer for credit to the

- 6 (5) If the cost of manufacturing Choose Life License Plates at any
- 7 time exceeds the amount charged for license plates pursuant to section
- 8 60-3,102, any money to be credited to the Nebraska Child Abuse Prevention
- 9 Fund shall instead be credited first to the Highway Trust Fund in an
- 10 amount equal to the difference between the manufacturing costs of Choose
- 11 Life License Plates and the amount charged pursuant to section 60-3,102
- 12 <u>with respect to such plates and the remainder shall be credited to the</u>
- 13 <u>Nebraska Child Abuse Prevention Fund.</u>
