LEGISLATIVE BILL 461

- 1 A BILL FOR AN ACT relating to the human trafficking task force; to amend
- 2 section 81-1430, Revised Statutes Cumulative Supplement, 2020; to
- 3 require placement of human trafficking informational posters in
- 4 casinos; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 81-1430, Revised Statutes Cumulative Supplement,

- 2 2020, is amended to read:
- 3 81-1430 (1) A task force is hereby established within the Nebraska
- 4 Commission on Law Enforcement and Criminal Justice for the purposes of
- 5 investigating and studying human trafficking, the methods for advertising
- 6 human trafficking services, and the victimization of individuals coerced
- 7 to participate in human trafficking.
- 8 (2) The task force shall examine the extent to which human
- 9 trafficking is prevalent in this state, the scope of efforts being taken
- 10 to prevent human trafficking from occurring, and the services available
- 11 to victims of human trafficking in this state. The task force shall
- 12 utilize information and research available from the Innocence Lost
- 13 National Initiative. The task force shall research and recommend a model
- of rehabilitative services for victims of human trafficking that includes
- 15 input from the areas of law enforcement, social services, the legal
- 16 profession, the judiciary, mental health, and immigration. The task force
- 17 shall also investigate the limitations upon victims who wish to come
- 18 forward and seek medical attention; investigate the potential to stop
- 19 human trafficking; and investigate the potential to promote recovery, to
- 20 protect families and children who may be profoundly impacted by such
- 21 abuse, and to save lives.
- 22 (3)(a) The Department of Labor shall work with the task force to
- 23 develop or select informational posters for placement around the state.
- 24 The posters shall be in English, Spanish, and any other language deemed
- 25 appropriate by the task force. The posters shall include a toll-free
- 26 telephone number a person may call for assistance, preferably the
- 27 National Human Trafficking Resource Center Hotline (888)373-7888.
- 28 (b) Posters shall be placed in rest stops, and strip clubs, and
- 29 casinos. The task force shall work with local businesses and nonprofit
- 30 entities associated with the prevention of human trafficking to
- 31 voluntarily place additional signs in high schools, postsecondary

- 1 educational institutions, gas stations, hotels, hospitals, health care
- 2 clinics, urgent care centers, airports, train stations, bus stations, and
- 3 other locations around the state deemed appropriate by the task force.
- 4 (4) The task force shall consist of the following members:
- 5 (a) The Attorney General or his or her designee;
- 6 (b) The executive director of the Nebraska Commission on Law
- 7 Enforcement and Criminal Justice;
- 8 (c) The Superintendent of Law Enforcement and Public Safety or his
- 9 or her designee;
- 10 (d) The Director of Correctional Services or his or her designee;
- 11 (e) The chief of police or director of public safety of a city of
- 12 two hundred thousand inhabitants or more as determined by the most recent
- 13 federal decennial census or the most recent revised certified count by
- 14 the United States Bureau of the Census;
- 15 (f) The chief of police or director of public safety of a city of
- 16 less than two hundred thousand inhabitants as determined by the most
- 17 recent federal decennial census or the most recent revised certified
- 18 count by the United States Bureau of the Census;
- 19 (g) A county sheriff;
- 20 (h) A county attorney;
- 21 (i) A county commissioner;
- 22 (j) A mayor or city manager;
- 23 (k) A person involved with the control or prevention of juvenile
- 24 delinquency;
- 25 (1) A person involved with the control or prevention of child abuse;
- 26 (m) The Commissioner of Education or his or her designee;
- 27 (n) The director of the Commission on Latino-Americans or his or her
- 28 designee; and
- 29 (o) Six members, at least three of whom shall be women, from the
- 30 public at large.
- 31 (5) The Governor shall appoint the members of the task force listed

- 1 in subdivisions (4)(e) through (1) and (0) of this section for terms as
- 2 provided in subsection (6) of this section. The membership of the task
- 3 force shall represent varying geographic areas and large and small
- 4 political subdivisions. One member from the public at large shall be a
- 5 professional representing child welfare, and one member of the public at
- 6 large shall represent juvenile pretrial diversion programs.
- 7 (6) The members of the task force appointed by the Governor shall
- 8 serve six-year terms, except that of the members first appointed, four
- 9 shall serve initial two-year terms, four shall serve initial four-year
- 10 terms, and six shall serve initial six-year terms from January 1 next
- 11 succeeding their appointments. Thereafter, all members shall serve six-
- 12 year terms. A member may be reappointed at the expiration of his or her
- 13 term. Any vacancy occurring otherwise than by expiration of a term shall
- 14 be filled for the balance of the unexpired term in the same manner as the
- 15 original appointment.
- 16 (7) No member shall serve beyond the time when he or she holds the
- 17 office, employment, or status by reason of which he or she was initially
- 18 eligible for appointment. Any member of the task force appointed by the
- 19 Governor may be removed from the task force for cause upon notice and an
- 20 opportunity to be heard at a public hearing. One of the causes for
- 21 removal shall be absence from three regularly scheduled meetings of the
- 22 task force during any six-month period when the member has failed to
- 23 advise the task force in advance of such meeting that he or she will be
- 24 absent and stating a reason therefor.
- 25 (8) The chairperson of the task force shall be designated by the
- 26 Governor to serve at the pleasure of the Governor. The chairperson shall
- 27 be the chief executive officer of the task force but may delegate such of
- 28 his or her duties to other members of the task force as may be authorized
- 29 by the task force.
- 30 (9) Notwithstanding any provision of law, ordinance, or charter
- 31 provision to the contrary, membership on the task force shall not

- 1 disqualify any member from holding any other public office or employment
- 2 or cause the forfeiture thereof.
- 3 (10) The members of the task force shall serve on the task force
- 4 without compensation, but they shall be entitled to receive reimbursement
- 5 for expenses incurred incident to such service as provided in sections
- 6 81-1174 to 81-1177.
- 7 (11) Eleven members of the task force shall constitute a quorum for
- 8 the transaction of any business or the exercise of any power of the task
- 9 force. The task force shall have the power to act by a majority of the
- 10 members present at any meeting at which a quorum is in attendance.
- 11 (12) Every July 1 and December 1, the task force shall report
- 12 electronically to the Clerk of the Legislature the results of its
- 13 investigation and study and its recommendations, if any, together with
- 14 drafts of legislation necessary to carry its recommendations into effect
- 15 by filing the report with the clerk.
