- A BILL FOR AN ACT relating to health and human services; to amend sections 71-2454, 71-2455, and 71-2456, Revised Statutes Cumulative Supplement, 2014; to change provisions relating to prescription drug monitoring; to state intent relating to appropriations; to harmonize provisions; and to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 71-2454, Revised Statutes Cumulative Supplement,
- 2 2014, is amended to read:
- 3 71-2454 (1) An It is the intent of the Legislature that an entity
- 4 described in section 71-2455 shall establish a system of prescription
- 5 drug monitoring for the purposes of $(\underline{a} + 1)$ preventing the misuse of
- 6 controlled substances that are prescribed in an efficient and cost-
- 7 effective manner and $(\underline{b} \ 2)$ allowing doctors and pharmacists to monitor
- 8 the care and treatment of patients for whom such a prescription drug is
- 9 prescribed to ensure that such prescription drugs are used for medically
- 10 appropriate purposes and that the State of Nebraska remains on the
- 11 cutting edge of medical information technology.
- 12 (2) Such system of prescription drug monitoring shall be implemented
- 13 within twenty-four months after the effective date of this act and shall
- 14 <u>include</u>, but not be limited to, provisions that:
- 15 (a) Prohibit any patient from opting out of the system;
- 16 (b) Require all prescriptions of controlled substances to be entered
- 17 into the system, including those for patients paying cash for such
- 18 prescription drug or otherwise not relying on a third-party payor for
- 19 payment for the prescription drug;
- 20 (c) Allow all prescribers or dispensers of prescription drugs to
- 21 access the system at no cost to such prescriber or dispenser; and
- 22 (d) Ensure that such system includes information relating to all
- 23 payors, including, but not limited to, the medical assistance program
- 24 established pursuant to the Medical Assistance Act.
- 25 Sec. 2. Section 71-2455, Revised Statutes Cumulative Supplement,
- 26 2014, is amended to read:
- 27 71-2455 The Department of Health and Human Services, in
- 28 collaboration with the Nebraska Health Information Initiative or any
- 29 successor public-private statewide health information exchange, shall
- 30 enhance or establish technology for prescription drug monitoring to carry
- 31 out the purposes of section 71-2454. It is the intent of the Legislature

- 1 to appropriate five hundred thousand dollars for fiscal year 2015-16 to
- 2 the Department of Health and Human Services to carry out section 71-2454.
- 3 The department may use other state funds and accept grants, gifts, or
- 4 other funds in order to implement and operate the technology. The
- 5 department may adopt and promulgate rules and regulations to authorize
- 6 use of electronic health information, if necessary to carry out the
- 7 purposes of sections 71-2454 and 71-2455.
- 8 Sec. 3. Section 71-2456, Revised Statutes Cumulative Supplement,
- 9 2014, is amended to read:
- 10 71-2456 The Prescription Drug Monitoring Program Fund is created.
- 11 The Department of Health and Human Services shall administer the fund
- 12 which shall include the appropriation described in section 71-2455 and
- 13 any other state funds, grants, or gifts received by the department for
- 14 the purposes of carrying out the purposes of sections 71-2454 and
- 15 71-2455. Any money in the fund available for investment shall be invested
- 16 by the state investment officer pursuant to the Nebraska Capital
- 17 Expansion Act and the Nebraska State Funds Investment Act.
- 18 Sec. 4. Original sections 71-2454, 71-2455, and 71-2456, Revised
- 19 Statutes Cumulative Supplement, 2014, are repealed.
