A BILL

FOR AN ACT relating to public buildings; to amend sections 82-319, 85-106.01, and 85-304.01, Reissue Revised Statutes of Nebraska; to change provisions relating to use of portions of appropriated funds for works of art in new construction; and to repeal the original sections.
