Introduced by Brewer, 43; Linehan, 39. Read first time January 18, 2017 Committee:

A BILL FOR AN ACT relating to firearms; to amend sections 15-255, 17-556,
 18-1703, 28-1202, 37-708, 37-712, 60-6,342, and 69-2445, Reissue
 Revised Statutes of Nebraska, and sections 14-102 and 16-227,
 Revised Statutes Cumulative Supplement, 2016; to authorize the
 carrying of concealed handguns by qualified active and retired law
 enforcement officers as prescribed; to harmonize provisions; and to
 repeal the original sections.

8 Be it enacted by the people of the State of Nebraska,

1	Section 1. (1) An individual who is a qualified law enforcement
2	officer or a qualified retired law enforcement officer and who is
3	carrying the identification required by subsection (2) of this section
4	may carry a concealed handgun anywhere in the State of Nebraska, except
5	as prohibited by federal law or section 28-1204.04.
6	(2)(a) The identification required by this section for a qualified
7	law enforcement officer is the photographic identification issued by the
8	governmental agency which employs the individual as a law enforcement
9	officer.
10	(b) The identification required by this section for a qualified
11	retired law enforcement officer is:
12	(i) A photographic identification issued by the agency from which
13	the individual separated in good standing from service as a law
14	enforcement officer that identifies the individual as having been
15	employed as a law enforcement officer and indicates that the individual
16	has, not less recently than one year before the date the individual is
17	carrying the concealed handgun, been tested or otherwise found by the
18	agency to meet the active duty standards for qualification in handgun
19	training as established by the agency to carry a handgun of the same type
20	as the concealed handgun; or
21	<u>(ii)(A) A photographic identification issued by the agency from</u>
22	which the individual separated in good standing from service as a law
23	enforcement officer that identifies the individual as having been
24	employed as a law enforcement officer; and
25	(B) A certification issued by the individual's state of residence or
26	issued by a certified firearms instructor that is qualified to conduct a
27	handgun qualification test for active duty officers within such state
28	that indicates that the individual has, not less recently than one year
29	before the date the individual is carrying the concealed handgun, been
30	tested or otherwise found by such state or certified firearms instructor
31	<u>to have met:</u>

1	<u>(I) The active duty standards for qualification in handgun training,</u>
2	as established by such state, to carry a handgun of the same type as the
3	concealed handgun; or
4	(II) If such state has not established such standards, standards set
5	by any law enforcement agency within such state to carry a handgun of the
6	same type as the concealed handgun.
7	(3) For purposes of this section:
8	(a) Concealed handgun means the handgun is totally hidden from view.
9	If any part of the handgun is capable of being seen, it is not a
10	<u>concealed handgun;</u>
11	<u>(b) Handgun means any firearm with a barrel less than sixteen inches</u>
12	in length or any firearm designed to be held and fired by the use of a
13	single hand;
14	<u>(c) Qualified law enforcement officer means an employee of a</u>
15	governmental agency who:
16	(i) Is authorized by law to engage in or supervise the prevention,
17	detection, investigation, or prosecution of, or the incarceration of any
18	person for, any violation of law and has statutory powers of arrest;
19	(ii) Is authorized by the agency to carry a handgun;
20	(iii) Is not the subject of any disciplinary action by the agency
21	which could result in suspension or loss of police powers;
22	(iv) Meets any standards established by the agency which require the
23	employee to regularly qualify in the use of a handgun;
24	(v) Is not under the influence of alcohol or another intoxicating or
25	hallucinatory drug or substance; and
26	<u>(vi) Is not prohibited by state or federal law from possessing or</u>
27	receiving a handgun; and
28	<u>(d) Qualified retired law enforcement officer means an individual</u>
29	who:
30	<u>(i) Separated in good standing from service with a governmental</u>
31	agency as a law enforcement officer;

(ii) Before such separation, was authorized by law to engage in or
 supervise the prevention, detection, investigation, or prosecution of, or
 the incarceration of any person for, any violation of law and had
 statutory powers of arrest;
 (iii)(A) Before such separation, served as a law enforcement officer

6 for an aggregate of ten years or more; or

7 (B) Separated from service with such agency, after completing any
8 applicable probationary period of such service, due to a service9 connected disability, as determined by such agency;

10 (iv) During the most recent twelve-month period, has met, at the expense of the individual, the standards for qualification in firearms 11 training for active law enforcement officers, as determined by the former 12 13 agency of the individual or the individual's state of residence or, if such state has not established such standards, either a law enforcement 14 15 agency within such state or the standards used by a certified firearms instructor that is qualified to conduct a firearms qualification test for 16 17 active duty officers within such state;

18 (v) Has not been officially found by a qualified medical 19 professional employed by the agency to be unqualified for reasons 20 relating to mental health and as a result of this finding would not be 21 issued the photographic identification as described in subdivision (2)(b) 22 (i) of this section;

23 (vi) Has not entered into an agreement with the agency from which 24 the individual separated from service in which the individual 25 acknowledged that he or she is not qualified for reasons relating to 26 mental health and for those reasons will not receive or accept the 27 photographic identification as described in subdivision (2)(b)(i) of this 28 section;

29 (vii) Is not under the influence of alcohol or another intoxicating
 30 or hallucinatory drug or substance; and

31 <u>(viii) Is not prohibited by state or federal law from possessing or</u>

receiving a handgun. 1 2 (4) The Nebraska Commission on Law Enforcement and Criminal Justice may adopt and promulgate rules and regulations to carry out this section. 3 4 Sec. 2. Section 14-102, Revised Statutes Cumulative Supplement, 5 2016, is amended to read: 14-102 In addition to the powers granted in section 14-101, cities 6 7 of the metropolitan class shall have power by ordinance: 8 Taxes, special assessments.

9 (1) To levy any tax or special assessment authorized by law;
10 Corporate seal.

11 (2) To provide a corporate seal for the use of the city, and also 12 any official seal for the use of any officer, board, or agent of the 13 city, whose duties require an official seal to be used. Such corporate 14 seal shall be used in the execution of municipal bonds, warrants, 15 conveyances, and other instruments and proceedings as required by law;

16 Regulation of public health.

17 (3) To provide all needful rules and regulations for the protection 18 and preservation of health within the city; and for this purpose they may 19 provide for the enforcement of the use of water from public water 20 supplies when the use of water from other sources shall be deemed unsafe; 21 Appropriations for debts and expenses.

(4) To appropriate money and provide for the payment of debts and
expenses of the city;

24 Protection of strangers and travelers.

(5) To adopt all such measures as they may deem necessary for the
accommodation and protection of strangers and the traveling public in
person and property;

28 Concealed weapons, firearms, fireworks, explosives.

(6) To punish and prevent the carrying of concealed weapons, except
the carrying of a concealed handgun in compliance with the Concealed
Handgun Permit Act or section 1 of this act, and the discharge of

firearms, fireworks, or explosives of any description within the city,
 other than the discharge of firearms at a shooting range pursuant to the
 Nebraska Shooting Range Protection Act;

4 Sale of foodstuffs.

5 (7) To regulate the inspection and sale of meats, flour, poultry, 6 fish, milk, vegetables, and all other provisions or articles of food 7 exposed or offered for sale in the city;

8 Official bonds.

9 (8) To require all officers or servants elected or appointed to give 10 bond and security for the faithful performance of their duties; but no 11 officer shall become security upon the official bond of another or upon 12 any bond executed to the city;

13 Official reports of city officers.

(9) To require from any officer of the city at any time a report, in
detail, of the transactions of his or her office or any matter connected
therewith;

17 Cruelty to children and animals.

18 (10) To provide for the prevention of cruelty to children and19 animals;

20 Dogs; taxes and restrictions.

(11) To regulate, license, or prohibit the running at large of dogs and other animals within the city as well as in areas within three miles of the corporate limits of the city, to guard against injuries or annoyance from such dogs and other animals, and to authorize the destruction of the dogs and other animals when running at large contrary to the provisions of any ordinance. Any licensing provision shall comply with subsection (2) of section 54-603 for service animals;

28 Cleaning sidewalks.

(12) To provide for keeping sidewalks clean and free from obstructions and accumulations, to provide for the assessment and collection of taxes on real estate and for the sale and conveyance

thereof, and to pay the expenses of keeping the sidewalk adjacent to such real estate clean and free from obstructions and accumulations as herein provided;

4

Planting and trimming of trees; protection of birds.

5 (13) To provide for the planting and protection of shade or ornamental and useful trees upon the streets or boulevards, to assess the 6 cost thereof to the extent of benefits upon the abutting property as a 7 special assessment, and to provide for the protection of birds and 8 9 animals and their nests; to provide for the trimming of trees located upon the streets and boulevards or when the branches of trees overhang 10 the streets and boulevards when in the judgment of the mayor and council 11 such trimming is made necessary to properly light such street or 12 13 boulevard or to furnish proper police protection and to assess the cost thereof upon the abutting property as a special assessment; 14

15 Na

Naming and numbering streets and houses.

16 (14) To provide for, regulate, and require the numbering or 17 renumbering of houses along public streets or avenues; to care for and 18 control and to name and rename streets, avenues, parks, and squares 19 within the city;

20 Weeds.

(15) To require weeds and worthless vegetation growing upon any lot 21 22 or piece of ground within the city or its three-mile zoning jurisdiction to be cut and destroyed so as to abate any nuisance occasioned thereby, 23 24 to prohibit and control the throwing, depositing, or accumulation of 25 litter on any lot or piece of ground within the city or its three-mile zoning jurisdiction and to require the removal thereof so as to abate any 26 nuisance occasioned thereby, and if the owner fails to cut and destroy 27 28 weeds and worthless vegetation or remove litter, or both, after notice as required by ordinance, to assess the cost thereof upon the lots or lands 29 as a special assessment. The notice required to be given may be by 30 publication in the official newspaper of the city and may be directed in 31

1 general terms to the owners of lots and lands affected without naming 2 such owners;

3 Animals running at large.

4 (16) To prohibit and regulate the running at large or the herding or driving of domestic animals, such as hogs, cattle, horses, sheep, goats, 5 fowls, or animals of any kind or description within the corporate limits 6 7 and provide for the impounding of all animals running at large, herded, or driven contrary to such prohibition; and to provide for the forfeiture 8 9 and sale of animals impounded to pay the expense of taking up, caring 10 for, and selling such impounded animals, including the cost of advertising and fees of officers; 11

12 Use of streets.

13 (17) To regulate the transportation of articles through the streets,
14 to prevent injuries to the streets from overloaded vehicles, and to
15 regulate the width of wagon tires and tires of other vehicles;

16 Playing on streets and sidewalks.

17 (18) To prevent or regulate the rolling of hoops, playing of ball, 18 flying of kites, the riding of bicycles or tricycles, or any other 19 amusement or practice having a tendency to annoy persons passing in the 20 streets or on the sidewalks or to frighten teams or horses; to regulate 21 the use of vehicles propelled by steam, gas, electricity, or other motive 22 power, operated on the streets of the city;

23 Combustibles and explosives.

(19) To regulate or prohibit the transportation and keeping of
gunpowder, oils, and other combustible and explosive articles;

Public sale of chattels on streets.

(20) To regulate, license, or prohibit the sale of domestic animals
or of goods, wares, and merchandise at public auction on the streets,
alleys, highways, or any public ground within the city;

30 Signs and obstruction in streets.

31 (21) To regulate and prevent the use of streets, sidewalks, and

public grounds for signs, posts, awnings, awning posts, scales, or other like purposes; to regulate and prohibit the exhibition or carrying or conveying of banners, placards, advertisements, or the distribution or posting of advertisements or handbills in the streets or public grounds or upon the sidewalks;

6 Disorderly conduct.

7 (22) To provide for the punishment of persons disturbing the peace 8 and good order of the city by clamor and noise, intoxication, 9 drunkenness, fighting, or using obscene or profane language in the 10 streets or other public places or otherwise violating the public peace by 11 indecent or disorderly conduct or by lewd and lascivious behavior;

12 Vagrants and tramps.

13 (23) To provide for the punishment of vagrants, tramps, common 14 street beggars, common prostitutes, habitual disturbers of the peace, 15 pickpockets, gamblers, burglars, thieves, or persons who practice any 16 game, trick, or device with intent to swindle, persons who abuse their 17 families, and suspicious persons who can give no reasonable account of 18 themselves; and to punish trespassers upon private property;

Disorderly houses, gambling, offenses against public morals.

(24) To prohibit, restrain, and suppress tippling shops, houses of 20 prostitution, opium joints, gambling houses, prize fighting, 21 dog fighting, cock fighting, and other disorderly houses and practices, all 22 games and gambling and desecration of the Sabbath, commonly called 23 24 Sunday, and all kinds of indecencies; to regulate and license or prohibit the keeping and use of billiard tables, ten pins or ball alleys, shooting 25 galleries except as provided in the Nebraska Shooting Range Protection 26 Act, and other similar places of amusement; and to prohibit and suppress 27 28 all lotteries and gift enterprises of all kinds under whatsoever name carried on, except that nothing in this subdivision shall be construed to 29 apply to bingo, lotteries, lotteries by the sale of pickle cards, or 30 raffles conducted in accordance with the Nebraska Bingo Act, the Nebraska 31

Lottery and Raffle Act, the Nebraska Pickle Card Lottery Act, the
 Nebraska Small Lottery and Raffle Act, or the State Lottery Act;

3 Police regulation in general.

4 (25) To make and enforce all police regulations for the good government, general welfare, health, safety, and security of the city and 5 the citizens thereof in addition to the police powers expressly granted 6 7 herein; and in the exercise of the police power, to pass all needful and ordinances and impose fines, forfeitures, 8 proper penalties, and 9 imprisonment at hard labor for the violation of any ordinance, and to provide for the recovery, collection, and enforcement thereof; and in 10 default of payment to provide for confinement in the city or county 11 prison, workhouse, or other place of confinement with or without hard 12 13 labor as may be provided by ordinance;

14

Fast driving on streets.

15 (26) To prevent horseracing and immoderate driving or riding on the
16 street and to compel persons to fasten their horses or other animals
17 attached to vehicles while standing in the streets;

18 Libraries, art galleries, and museums.

19 (27) To establish and maintain public libraries, reading rooms, art 20 galleries, and museums and to provide the necessary grounds or buildings 21 therefor; to purchase books, papers, maps, manuscripts, works of art, and 22 objects of natural or of scientific curiosity, and instruction therefor; 23 to receive donations and bequests of money or property for the same in 24 trust or otherwise and to pass necessary bylaws and regulations for the 25 protection and government of the same;

26

Hospitals, workhouses, jails, firehouses, etc.; garbage disposal.

(28) To erect, designate, establish, maintain, and regulate hospitals or workhouses, houses of correction, jails, station houses, fire engine houses, asphalt repair plants, and other necessary buildings; and to erect, designate, establish, maintain, and regulate plants for the removal, disposal, or recycling of garbage and refuse or to make

contracts for garbage and refuse removal, disposal, or recycling, or all 1 of the same, and to charge equitable fees for such removal, disposal, or 2 recycling, or all of the same, except as hereinafter provided. The fees 3 collected pursuant to this subdivision shall be credited to a single fund 4 5 to be used exclusively by the city for the removal, disposal, or recycling of garbage and refuse, or all of the same, including any costs 6 incurred for collecting the fee. Before any contract for such removal, 7 disposal, or recycling is let, the city council shall make specifications 8 therefor, bids shall be advertised for as now provided by law, and the 9 contract shall be let to the lowest and best bidder, who shall furnish 10 bond to the city conditioned upon his or her carrying out the terms of 11 the contract, the bond to be approved by the city council. Nothing in 12 13 this section, and no contract or regulation made by the city council, shall be so construed as to prohibit any person, firm, or corporation 14 engaged in any business in which garbage or refuse accumulates as a 15 16 byproduct from selling, recycling, or otherwise disposing of his, her, or its garbage or refuse or hauling such garbage or refuse through the 17 streets and alleys under such uniform and reasonable regulations as the 18 19 city council may by ordinance prescribe for the removal and hauling of 20 garbage or refuse;

21 Market places.

(29) To erect and establish market houses and market places and to provide for the erection of all other useful and necessary buildings for the use of the city and for the protection and safety of all property owned by the city; and such market houses and market places and buildings aforesaid may be located on any street, alley, or public ground or on land purchased for such purpose;

28 Cemeteries, registers of births and deaths.

(30) To prohibit the establishment of additional cemeteries within
the limits of the city, to regulate the registration of births and
deaths, to direct the keeping and returning of bills of mortality, and to

1 impose penalties on physicians, sextons, and others for any default in 2 the premises;

3 Plumbing, etc., inspection.

4 (31) To provide for the inspection of steam boilers, electric light 5 appliances, pipefittings, and plumbings, to regulate their erection and 6 construction, to appoint inspectors, and to declare their powers and 7 duties, except as herein otherwise provided;

8

Fire limits and fire protection.

9 (32) To prescribe fire limits and regulate the erection of all buildings and other structures within the corporate limits; to provide 10 for the removal of any buildings or structures or additions thereto 11 erected contrary to such regulations, to provide for the removal of 12 dangerous buildings, and to provide that wooden buildings shall not be 13 erected or placed or repaired in the fire limits; but such ordinance 14 shall not be suspended or modified by resolution nor shall exceptions be 15 16 made by ordinance or resolution in favor of any person, firm, or corporation or concerning any particular lot or building; to direct that 17 all and any building within such fire limits, when the same shall have 18 been damaged by fire, decay, or otherwise, to the extent of fifty percent 19 of the value of a similar new building above the foundation, shall be 20 torn down or removed; and to prescribe the manner of ascertaining such 21 damages and to assess the cost of removal of any building erected or 22 23 existing contrary to such regulations or provisions, against the lot or 24 real estate upon which such building or structure is located or shall be 25 erected, or to collect such costs from the owner of any such building or structure and enforce such collection by civil action in any court of 26 competent jurisdiction; 27

28 Building regulations.

(33) To regulate the construction, use, and maintenance of party walls, to prescribe and regulate the thickness, strength, and manner of constructing stone, brick, wood, or other buildings and the size and

shape of brick and other material placed therein, to prescribe and 1 2 regulate the construction and arrangement of fire escapes and the placing of iron and metallic shutters and doors therein and thereon, and to 3 4 provide for the inspection of elevators and hoist-way openings to avoid accidents; to prescribe, regulate, and provide for the inspection of all 5 plumbing, pipefitting, or sewer connections in all houses or buildings 6 7 now or hereafter erected; to regulate the size, number, and manner of construction of halls, doors, stairways, seats, aisles, and passageways 8 9 of theaters, tenement houses, audience rooms, and all buildings of a public character, whether now built or hereafter to be built, so that 10 there may be convenient, safe, and speedy exit in case of fire; to 11 prevent the dangerous construction and condition of chimneys, fireplaces, 12 hearths, stoves, stovepipes, ovens, boilers, and heating appliances used 13 in or about any building or a manufactory and to cause the same to be 14 15 removed or placed in safe condition when they are considered dangerous; to regulate and prevent the carrying on of manufactures dangerous in 16 17 causing and promoting fires; to prevent the deposit of ashes in unsafe places and to cause such buildings and enclosures as may be in a 18 19 dangerous state to be put in a safe condition; to prevent the disposing of and delivery or use in any building or other structure, of soft, 20 shelly, or imperfectly burned brick or other unsuitable building material 21 22 within the city limits and provide for the inspection of the same; to provide for the abatement of dense volumes of smoke; to regulate the 23 24 construction of areaways, stairways, and vaults and to regulate partition 25 fences; to enforce proper heating and ventilation of buildings used for schools, workhouses, or shops of every class in which labor is employed 26 or large numbers of persons are liable to congregate; 27

Warehouses and street railways.

(34) To regulate levees, depots and depot grounds, and places for storing freight and goods and to provide for and regulate the laying of tracks and the passage of steam or other railways through the streets,

1 alleys, and public grounds of the city;

2

Lighting railroad property.

3 (35) To require the lighting of any railway within the city, the cars of which are propelled by steam, and to fix and determine the 4 number, size, and style of lampposts, burners, lamps, and all other 5 fixtures and apparatus necessary for such lighting and the points of 6 7 location for such lampposts; and in case any company owning or operating such railways shall fail to comply with such requirements, the council 8 9 may cause the same to be done and may assess the expense thereof against such company, and the same shall constitute a lien upon any real estate 10 belonging to such company and lying within such city and may be collected 11 in the same manner as taxes for general purposes; 12

13 City publicity.

14 (36) To provide for necessary publicity and to appropriate money for
 15 the purpose of advertising the resources and advantages of the city;

16 Offstreet parking.

17 (37) To erect, establish, and maintain offstreet parking areas on 18 publicly owned property located beneath any elevated segment of the 19 National System of Interstate and Defense Highways or portion thereof, or 20 public property title to which is in the city on May 12, 1971, or 21 property owned by the city and used in conjunction with and incidental to 22 city-operated facilities, and to regulate parking thereon by time 23 limitation devises or by lease;

24 Public passenger transportation systems.

25 (38) To acquire, by the exercise of the power of eminent domain or otherwise, lease, purchase, construct, maintain, 26 own, operate, or contract for the operation of public passenger transportation systems, 27 28 excluding taxicabs and railroad systems, including all property and facilities required therefor, within and without the limits of the city, 29 to redeem such property from prior encumbrance in order to protect or 30 preserve the interest of the city therein, to exercise all powers granted 31

by the Constitution of Nebraska and laws of the State of Nebraska or 1 2 exercised by or pursuant to a home rule charter adopted pursuant thereto, but not limited to, receiving and accepting from the 3 including, 4 government of the United States or any agency thereof, from the State of Nebraska or any subdivision thereof, and from any person or corporation 5 donations, devises, gifts, bequests, loans, or grants for or in aid of 6 the acquisition, operation, and maintenance of such public passenger 7 transportation systems and to administer, hold, use, and apply the same 8 9 for the purposes for which such donations, devises, gifts, bequests, loans, or grants may have been made, to negotiate with employees and 10 enter into contracts of employment, to employ by contract or otherwise 11 individuals singularly or collectively, to enter into agreements 12 13 authorized under the Interlocal Cooperation Act or the Joint Public Agency Act, to contract with an operating and management company for the 14 purpose of operating, servicing, and maintaining any public passenger 15 transportation systems any city of the metropolitan class shall acquire, 16 17 and to exercise such other and further powers as may be necessary, incident, or appropriate to the powers of such city; and 18

19 Regulation of air quality.

(39) In addition to powers conferred elsewhere in the laws of the 20 state and notwithstanding any other law of the state, to implement and 21 enforce an air pollution control program within the corporate limits of 22 the city under subdivision (23) of section 81-1504 or subsection (1) of 23 24 section 81-1528, which program shall be consistent with the federal Clean Air Act, as amended, 42 U.S.C. 7401 et seq. Such powers shall include 25 without limitation those involving injunctive relief, civil penalties, 26 criminal fines, and burden of proof. Nothing in this section shall 27 28 preclude the control of air pollution by resolution, ordinance, or regulation not in actual conflict with the state air pollution control 29 regulations. 30

2 15-255 A city of the primary class may prohibit riots, routs, noise, or disorderly assemblies; prevent use of firearms, rockets, powder, 3 fireworks, or other dangerous and combustible material; prohibit carrying 4 5 of concealed weapons, except the carrying of a concealed handgun in compliance with the Concealed Handgun Permit Act or section 1 of this 6 act; arrest, punish, fine, or set at work on streets or elsewhere 7 vagrants and persons found without visible means of support or legitimate 8 9 business; regulate and prevent the transportation of gunpowder or combustible articles, tar, pitch, resin, coal oil, benzine, turpentine, 10 hemp, cotton, nitroglycerine, dynamite, petroleum or its products, or 11 other explosives or inflammables; regulate the use of lights in stables, 12 shops, or other places and building of bonfires; and regulate and 13 14 prohibit the piling of building material or any excavation or obstruction of the streets. 15
