- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 25-21,299, Reissue Revised Statutes of Nebraska,
- 2 is amended to read:
- 3 25-21,299 (1) Any trafficking victim or his or her parent or legal
- 4 guardian who suffered or continues to suffer personal or psychological
- 5 injury as a result of such human trafficking may bring a civil action
- 6 against any person who knowingly (a) engaged in human trafficking of such
- 7 victim within this state or (b) aided or assisted with the human
- 8 trafficking of such victim within this state.
- 9 (2) A plaintiff who prevails in a civil action brought pursuant to
- 10 the Human Trafficking Victims Civil Remedy Act may recover his or her
- 11 actual damages plus any and all attorney's fees and costs reasonably
- 12 associated with the civil action. The court may, in its discretion,
- 13 increase the award of damages to an amount which bears a reasonable
- 14 <u>relation to the actual damages which have been sustained and which</u>
- 15 <u>damages</u> are not susceptible of measurement by ordinary pecuniary
- 16 standards. In addition to all other remedies available under the act, the
- 17 court may also award temporary, preliminary, and permanent injunctive
- 18 relief as the court deems necessary and appropriate.
- 19 (3) Actual damages to be awarded pursuant to subsection (2) of this
- 20 <u>section may include, but are not limited to, the following:</u>
- 21 (a) Costs of medical and psychological treatment, past, present, and
- 22 <u>future;</u>
- 23 (b) Costs of necessary transportation, temporary housing, and child
- 24 care;
- 25 (c) The greater of (i) the value of the human trafficking victim's
- 26 labor as quaranteed under the minimum wage and overtime provisions of the
- 27 <u>federal Fair Labor Standards Act of 1938; or (ii) the gross income or</u>
- 28 <u>value to the defendant of the victim's labor servitude or sexual</u>
- 29 <u>servitude engaged in by the victim while in the sex trafficking</u>
- 30 situation;
- 31 (d) Return of property, cost of damage to property, or full value of

- 1 property, if destroyed or damaged beyond repair;
- 2 <u>(e) Expenses incurred by a victim and any household member or other</u>
- 3 <u>family member in relocating away from the defendant or his or her</u>
- 4 associates, including, but not limited to, deposits for utilities and
- 5 <u>telephone service</u>, <u>deposits</u> for rental housing, temporary lodging and
- 6 <u>food expenses, clothing, and personal items;</u>
- 7 (f) In the case of an offense resulting in death or bodily injury
- 8 that results in death, the costs and expenses of necessary funeral and
- 9 related services;
- 10 (g) Costs and expenses incurred that are related to participation in
- 11 the investigation or prosecution of the offense or attendance at
- 12 proceedings related to the offense; and
- 13 (h) Any and all other losses suffered as a victim of human
- 14 trafficking and any and all other damages otherwise recoverable by a
- 15 victim under the law.
