## Committee:

- 1 A BILL FOR AN ACT relating to county government; to amend sections 2 23-2501, 23-2502, 23-2505, 23-2508, 23-2509, 23-2511, 23-2512, 3 23-2513, 23-2515, and 23-2516, Reissue Revised Statutes of Nebraska, 4 and sections 23-2503, 23-2504, 23-2506, 23-2510, and 23-2514, Revised Statutes Cumulative Supplement, 2018; to name the County 5 6 Civil Service Commission Act; to change provisions relating to the 7 purpose of the act and commission membership; to eliminate a 8 provision providing commission duties; to provide for appointment of 9 and prescribe duties for a human resources director; to harmonize provisions; to repeal the original sections; and to outright repeal 10 section 23-2507, Revised Statutes Cumulative Supplement, 2018. 11
- 12 Be it enacted by the people of the State of Nebraska,

1 Section 1. Sections 1 to 17 of this act shall be known and may be

- 2 <u>cited as the County Civil Service Commission Act.</u>
- 3 Sec. 2. Section 23-2501, Reissue Revised Statutes of Nebraska, is

- 5 23-2501 The purpose of the County Civil Service Commission Act
- 6 sections 23-2501 to 23-2516 is to guarantee to all citizens a fair and
- 7 equal opportunity for employment in the county offices governed by the
- 8 act and sections 23-2501 to 23-2516, to establish conditions of
- 9 employment and to promote economy and efficiency in such offices. <u>In</u>
- 10 addition, the purpose of the act is to establish a system of personnel
- 11 administration that meets the social, economic, and program needs of
- 12 <u>county offices</u>. Such system shall provide the means to recruit, select,
- 13 <u>develop</u>, and maintain an effective and responsive workforce and shall
- 14 <u>include policies and procedures for employee hiring and advancement,</u>
- 15 training and career development, position classification, salary
- 16 administration, benefits, discipline, discharge, and other related
- 17 matters. All appointments and promotions under the act shall be made
- 18 based on merit and fitness.

- 21 <u>23-2502</u> As used in <u>the County Civil Service Commission Act</u> <u>sections</u>

- 23 (1) Employees shall mean all county employees of the county. The
- 24 term employees shall not include part-time employees, employees subject
- 25 to the state personnel service, court-appointed employees, employees of
- 26 the county attorney's office, employees of the public defender's office,
- 27 dentists, physicians, practicing attorneys, deputy sheriffs, officers
- 28 appointed by the Governor, or elected officers or the chief deputy of
- 29 each office or the deputy of each office if there is not more than one

- 15 <u>Commission Act sections 23-2501 to 23-2516</u>. A county shall comply with
- 16 this section within six months after a determination that the population
- 17 has reached four hundred thousand inhabitants or more as determined by
- 18 the most recent federal decennial census.

The four members of 7 the commission shall then select the public member. The commission shall 8 9 establish employee election procedures which shall provide that all county employees subject to the County Civil Service Commission Act 10 sections 23-2501 to 23-2516 may vote and, if not less than twenty-one 11 years of age, be candidates for a member of the commission. One employee 12 13 member of the commission shall be a Democrat elected by the Democratregistered employees subject to the County Civil Service Commission Act 14 sections 23-2501 to 23-2516 and one employee member of the commission 15 shall be a Republican elected by the Republican-registered employees 16 17 subject to the County Civil Service Commission Act sections 23-2501 to 23-2516. An employee otherwise eligible to vote and be a candidate for 18 the office of employee member of the commission, but who is not 19 registered as either a Democrat or a Republican, may become eligible to 20 vote, and become a candidate for the office of employee member of the 21 commission by making a declaration that he or she desires to vote for 22 such a member of the commission, or be a candidate for such office, and, 23 24 in the same declaration, designating the party, Democrat or Republican, with which he or she desires to be affiliated for this purpose. After 25 making such declaration, that employee shall have the same right to vote 26 for a candidate, and be a candidate for the office of employee member of 27 28 the commission as if the employee were a registered member of the party so designated in the declaration. The manner, form, and contents of such 29 declaration shall be initially established by the two elected officials 30 referred to in subdivision (2)(a) of this section, subject 31

- 1 modification by the commission after it has been fully formed.
- 2 (3) The initial term of office of (a) the two elected officers shall
- 3 be three years from May 21, 1971; (b) the initial term of office of the
- 4 county employees shall be two years from May 21, 1971; and (c) the
- 5 initial term of the public member shall be three years from May 21, 1971.
- 6 <u>(4)</u> At the expiration of the initial term of office, a successor
- 7 member shall be elected or appointed as provided in the County Civil

- 10 the resignation of any member or at such time as the member no longer

- 8 authority to affirm, modify, or revoke the order appealed from, and the

- 18 governed by the County Civil Service Commission Act; (c) a system of
- 19 personnel records containing general data on all employees and standards
- 20 for the development and maintenance of personnel records to be maintained
- 21 within the offices governed by the County Civil Service Commission Act;
- 22 (d) regulations governing such matters as hours of work, promotions,
- 23 transfers, demotions, probation, terminations, and reductions in force;
- 24 and (e) regulations for use by all offices governed by the County Civil
- 25 Service Commission Act relating to such matters as employee benefits,
- 26 vacation, sick leave, and holidays.

- 28 provide sufficient criteria to enable the commission to properly conduct
- 29 employment examinations, and shall require department heads to supply to
- 30 the commission position classification plans, job descriptions, and job
- 31 specifications.
