- 8 (2) It is the intent of the Legislature to create an additional
- 9 level of caregiving for youth in foster care and to implement treatment

- 12 43-4217.
- 13 (3) The Legislature finds that (a) there is a need for consistency
- 14 in the implementation of a fourth tier of caregiving across the state,
- 15 (b) the fourth tier of caregiving and reimbursement exists in the
- 16 continuum of foster care services available in Nebraska, however, there
- 17 <u>is a variation in the rates, implementation and outcomes, (c) the use of</u>
- 18 <u>a fourth tier of rates outside of the established rate structure can</u>
- 19 create barriers to permanency for children entering adoption and
- 20 guardianship, and (d) the fourth tier of caregiving should be utilized to
- 21 support the exceptional caregiving needs of children outside the first
- 22 three tiers of caregiving.
- 23 (4) The Legislature further finds that (a) additional treatment
- 24 <u>services are needed to support the behavioral and mental health needs of</u>
- 25 youth who are at risk of, or stepping down from, congregate treatment
- 26 placement, and (b) treatment family care services uses blended funding to
- 27 <u>support caregivers and prevent placement disruption.</u>
- 28 (5) On or before July 1, 2021, the Division of Children and Family
- 29 Services of the Nebraska Department of Health and Human Services shall
- 30 implement a fourth tier of caregiving statewide as the specialized level
- 31 of care, with standardized rates for foster parents and child placing

- 1 agencies as reported to the Legislature by the Foster Care Reimbursement
- 2 Rate Committee in the June 22, 2020, committee report pursuant to section
- 3 43-4217.
- 4 (6) On or before July 1, 2021, the Division of Children and Family
- 5 Services of the Nebraska Department of Health and Human Services shall
- 6 implement the reimbursement rate recommendation of the Foster Care
- 7 Reimbursement Rate Committee for treatment family care as reported to the
- 8 Legislature in the June 22, 2020, committee report pursuant to section
- 9 43-4217.
- 10 (7)(a) (2)(a) On or before July 1, 2013, the Division of Children
- 11 and Family Services of the Department of Health and Human Services shall
- 12 develop a pilot project as provided in this subsection to implement the
- 13 standardized level of care assessment tools recommended by the Foster
- 14 Care Reimbursement Rate Committee as reported to the Legislature pursuant
- 15 to section 43-4212 as such section existed before June 5, 2013.
- 16 (b)(i) The pilot project shall comprise two groups: One in an urban
- 17 area and one in a rural area. The size of each group shall be determined
- 18 by the division to ensure an accurate estimate of the effectiveness and
- 19 cost of implementing such tools statewide.
- 20 (ii) The Nebraska Children's Commission shall review and provide a
- 21 progress report on the pilot project by October 1, 2013, to the
- 22 department and electronically to the Health and Human Services Committee
- 23 of the Legislature; shall provide to the department and electronically to
- 24 the committee by December 1, 2013, a report including recommendations and
- 25 any legislation necessary, including appropriations, to adopt the
- 26 recommendations, regarding the adaptation or continuation of the
- 27 implementation of a statewide standardized level of care assessment; and
- 28 shall provide to the department and electronically to the committee by
- 29 February 1, 2014, a final report and final recommendations of the
