- 1 A BILL FOR AN ACT relating to the Motor Vehicle Operator's License Act;
- 2 to amend section 60-4,118.06, Revised Statutes Cumulative
- 3 Supplement, 2018; to authorize the issuance of ignition interlock
- 4 permits to persons who proximately caused serious bodily injury
- 5 while driving under the influence of alcoholic liquor or drugs; and
- 6 to repeal the original section.
- 7 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 60-4,118.06, Revised Statutes Cumulative
- 2 Supplement, 2018, is amended to read:
- 3 60-4,118.06 (1) Upon receipt by the director of (a) a certified copy
- 4 of a court order issued pursuant to section 60-6,211.05, a certified copy
- 5 of an order for installation of an ignition interlock device and issuance
- 6 of an ignition interlock permit pursuant to section 60-6,197.03, or a
- 7 copy of an order from the Board of Pardons pursuant to section
- 8 83-1,127.02, (b) sufficient evidence that the person has surrendered his
- 9 or her operator's license to the department and installed an approved
- 10 ignition interlock device in accordance with such order, and (c) payment
- of the fee provided in section 60-4,115, such person may apply for an
- 12 ignition interlock permit. A person subject to administrative license
- 13 revocation under sections 60-498.01 to 60-498.04 shall be eligible for an
- 14 ignition interlock permit as provided in such sections. The director
- 15 shall issue an ignition interlock permit only for the operation of a
- 16 motor vehicle equipped with an ignition interlock device. All permits
- 17 issued pursuant to this subsection shall indicate that the permit is not
- 18 valid for the operation of any commercial motor vehicle.
- 19 (2) Upon expiration of the revocation period or upon expiration of
- 20 an order issued by the Board of Pardons pursuant to section 83-1,127.02,
- 21 a person may apply to the department in writing for issuance of an
- 22 operator's license. Regardless of whether the license surrendered by such
- 23 person under subsection (1) of this section has expired, the person shall
- 24 apply for a new operator's license pursuant to the Motor Vehicle
- 25 Operator's License Act.
- 26 (3)(a) An ignition interlock permit shall not be issued under this
- 27 section or sections 60-498.01 to 60-498.04 to any person except in cases
- 28 of a violation of subdivision (3)(b) or (c) of section 28-306,
- 29 subdivision (3)(b) or (c) of section 28-394, or section 28-1254,
- 30 60-6,196, 60-6,197, or 60-6,197.06, or 60-6,198.
- 31 (b) An ignition interlock permit shall only be available to a holder

- 1 of a Class M or O operator's license.
- 2 (4) The director shall revoke a person's ignition interlock permit
- 3 issued under this section or sections 60-498.01 to 60-498.04 upon receipt
- 4 of an (a) abstract of conviction indicating that the person had his or
- 5 her operating privileges revoked or canceled or (b) administrative order
- 6 revoking or canceling the person's operating privileges, if such
- 7 conviction or order resulted from an incident other than the incident
- 8 which resulted in the application for the ignition interlock permit.
