1 Section 1. Section 21-118, Reissue Revised Statutes of Nebraska, is

- 3 21-118 (ULLCA 202) (a) A certificate of organization may be amended
- 4 or restated at any time.
- 5 (b) To amend its certificate of organization, a limited liability
- 6 company must deliver to the Secretary of State for filing an amendment
- 7 stating:
- 8 (1) the name of the company;
- 9 (2) the date of filing of its certificate of organization; and
- 10 (3) the changes the amendment makes to the certificate as most
- 11 recently amended or restated.
- 12 (c) To restate its certificate of organization, a limited liability
- 13 company must deliver to the Secretary of State for filing a restatement,
- 14 designated as such in its heading, stating:
- 15 (1) in the heading or an introductory paragraph, the company's
- 16 present name and the date of the filing of the company's initial
- 17 certificate of organization;
- 18 (2) if the company's name has been changed at any time since the
- 19 company's formation, each of the company's former names; and
- 20 (3) the changes the restatement makes to the certificate as most
- 21 recently amended or restated.
- 22 (d) Subject to subsection (c) of section 21-112 and subsection (c)
- 23 of section 21-121, an amendment to or restatement of a certificate of
- 24 organization is effective when filed by the Secretary of State.
- (e) If a member of a member-managed limited liability company, or a
- 26 manager of a manager-managed limited liability company, knows that any
- 27 information in a filed certificate of organization was inaccurate when
- 28 the certificate was filed or has become inaccurate owing to changed
- 29 circumstances, the member or manager shall promptly:
- 30 (1) cause the certificate to be amended; or
- 31 (2) if appropriate, deliver to the Secretary of State for filing a

1 statement of change under section 21-114 or a statement of correction

- 2 under section 21-122.
- 3 (f) A limited liability company that seeks tax benefits under a tax
- 4 credit, tax abatement, or tax incentive plan offered under the laws of
- 5 this state shall, prior to applying for such tax benefits, file an
- 6 amended certificate of organization. Such amended certificate of
- 7 organization shall state: (1) The name of the limited liability company;
- 8 (2) the date of filing of its certificate of organization; and (3) the
- 9 <u>names of the members of the limited liability company.</u>
