- 9 Burlington addition in Furnas, Garden, Garfield, Gosper, Grant,
- 10 Greeley, all of lots 1, 7, and 8 in block 48 in original town of
- 11 Grand Island, and all of the southeast quarter lying south of the
- 12 Union Pacific Railroad Company's right-of-way in section 24, township
- 13 11 north, range 10, in Hall, Harlan, Hayes, Hitchcock, Holt, Hooker,
- 14 Howard, Kearney, Keith, Keya Paha, Kimball, all of Knox except
- 15 Eastern, Dolphin, Dowling, Columbia, Morton, Peoria, Addison,
- 16 Herrick, Frankfort, and Lincoln townships, Lincoln, Logan, Loup,
- 17 McPherson, Morrill, Perkins, Phelps, Red Willow, Rock, Scotts Bluff,
- 18 Sheridan, Sherman, Sioux, Thomas, Valley, the existing livestock
- 19 auction markets in Blue Hill, all of lots 1 to 6, and lots 7 and 8,
- 20 except twenty-two feet of the east side of lot 8, all in block 6,
- 21 original town of Blue Hill, and Red Cloud, part of lot A, Roats
- 22 subdivision to Red Cloud, lots 1 and 2 and the south one-half of
