- 1 A BILL FOR AN ACT relating to highways; to amend section 39-201.01,
- 2 Reissue Revised Statutes of Nebraska, and sections 39-202 and
- 3 39-206, Revised Statutes Cumulative Supplement, 2018; to authorize
- 4 the display of signs along roadways memorializing persons killed on
- 5 Nebraska roadways as prescribed; to harmonize provisions; and to
- 6 repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 39-201.01, Reissue Revised Statutes of Nebraska,

- 2 is amended to read:
- 3 39-201.01 For purposes of sections 39-202 to 39-226 and section 4 of
- 4 this act:
- 5 (1) Highway Beautification Control System means the National System
- 6 of Interstate and Defense Highways, the system of federal-aid primary
- 7 roads as they existed on June 1, 1991, any additional highway or road
- 8 which is designated as a part of the National Highway System under the
- 9 federal Intermodal Surface Transportation Efficiency Act, and scenic
- 10 byways. A map of the Highway Beautification Control System shall be
- 11 maintained as provided in section 39-1311;
- 12 (2) Scenic byway means a road, highway, or connecting link
- 13 designated as a scenic byway pursuant to section 39-217. A map of the
- 14 scenic byways shall be maintained as provided in section 39-1311; and
- 15 (3) Visible, in reference to advertising signs, displays, or
- 16 devices, means the message or advertising content of such sign, display,
- 17 or device is capable of being seen without visual aid by a person of
- 18 normal visual acuity. A sign is considered visible even though the
- 19 message or advertising content can be seen but not read.
- Sec. 2. Section 39-202, Revised Statutes Cumulative Supplement,
- 21 2018, is amended to read:
- 22 39-202 (1) Except as provided in sections 39-202 to 39-205, 39-215,
- 23 39-216, and 39-220, the erection or maintenance of any advertising sign,
- 24 display, or device beyond six hundred sixty feet of the right-of-way of
- 25 the National System of Interstate and Defense Highways and visible from
- the main-traveled way of such highway system is prohibited.
- 27 (2) The following signs shall be permitted:
- 28 (a) Directional and official signs to include, but not be limited
- 29 to, signs and notices pertaining to natural wonders, scenic attractions,
- 30 and historical attractions. Such signs shall comply with standards and
- 31 criteria established by regulations of the Department of Transportation

- 1 as promulgated from time to time;
- 2 (b) Signs, displays, and devices advertising the sale or lease of
- 3 property upon which such media are located;
- 4 (c) Signs, displays, and devices advertising activities conducted on
- 5 the property on which such media are located;—and
- 6 (d) Signs in existence in accordance with sections 39-212 to 39-222,
- 7 to include landmark signs, signs on farm structures, markers, and plagues
- 8 of historical or artistic significance; and -
- 9 <u>(e) Signs to memorialize persons killed on Nebraska roadways as set</u>
- 10 forth in section 4 of this act.
- 11 (3) For purposes of this section, visible shall mean the message or
- 12 advertising content of an advertising sign, display, or device is capable
- 13 of being seen without visual aid by a person of normal visual acuity. A
- 14 sign shall be considered visible even though the message or advertising
- 15 content may be seen but not read.
- 16 Sec. 3. Section 39-206, Revised Statutes Cumulative Supplement,
- 17 2018, is amended to read:
- 18 39-206 It is the intent of sections 39-204 and 39-205 and section 4
- 19 of this act to allow the erection of specific information sign panels on
- 20 the right-of-way of the state highways under the following conditions:
- 21 (1) No state funds shall be used for the erection, maintenance, or
- 22 servicing of such signs;
- 23 (2) Such signs shall be erected in accordance with federal standards
- 24 and the rules and regulations adopted and promulgated by the Department
- 25 of Transportation;
- 26 (3) Such signs may be erected by the department or by a contractor
- 27 selected through the competitive bidding process; and
- 28 (4) The department shall charge an annual fee in an amount equal to
- 29 the fair market rental value of the sign site and any other cost to the
- 30 state associated with the erection, maintenance, or servicing of specific
- 31 information sign panels. If such sign is erected by a contractor, the

1 annual fee shall be limited to the fair market rental value of the sign

- 2 site.
- 3 Sec. 4. (1) Signs giving specific information regarding persons
- 4 killed on Nebraska roadways may be erected by or at the direction of the
- 5 Department of Transportation and maintained within the right-of-way at
- 6 appropriate distances from interchanges on the National System of
- 7 Interstate and Defense Highways and from roads of the state primary
- 8 system as shall conform with the rules and regulations adopted and
- 9 promulgated by the department to carry out this section. Such rules and
- 10 regulations shall be consistent with national standards promulgated from
- 11 <u>time to time by the appropriate authority of the federal government</u>
- 12 pursuant to 23 U.S.C. 131(f) as such section existed on January 1, 2019.
- 13 (2) Such signs shall:
- 14 (a) Memorialize and commemorate the deceased person or persons;
- 15 (b) Be colored blue, triangular in shape, and no larger than two
- 16 hundred twenty-five square inches;
- 17 <u>(c) Contain the name or names of the deceased person or persons and</u>
- 18 may include a photographic image of the deceased person or persons;
- 19 (d) Contain one of the following messages: Please Drive Safely; Seat
- 20 Belts Save Lives; Watch for Bicyclists; or Don't Drink and Drive; and
- 21 (e) Be posted for ten years. After such time, application may be
- 22 made again for posting for an additional ten years.
- 23 (3) No signs shall be allowed under this section for a deceased
- 24 person who died as a result of a motor vehicle collision, who was the
- 25 operator of the motor vehicle, and who had a blood alcohol content level
- 26 <u>at or above the limit stated in section 60-6,196 or 60-6,211.01, as</u>
- 27 <u>applicable.</u>
- 28 Sec. 5. Original section 39-201.01, Reissue Revised Statutes of
- 29 Nebraska, and sections 39-202 and 39-206, Revised Statutes Cumulative
- 30 Supplement, 2018, are repealed.
