Committee:

- 1 A BILL FOR AN ACT relating to elections; to amend sections 32-512 and
- 2 70-611, Reissue Revised Statutes of Nebraska; to change provisions
- 3 relating to qualified voters in certain public power district
- 4 elections; to harmonize provisions; and to repeal the original
- 5 sections.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 32-512, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 32-512 (1) After the selection of the original board of directors of
- 4 a public power district as provided for in sections 70-803 and 70-805 or
- 5 a district as provided for in sections 70-604 and 70-609, their
- 6 successors shall be nominated and elected on the nonpartisan ballot,
- 7 except that in districts receiving annual gross revenue of less than
- 8 forty million dollars, the candidates for the board of directors shall
- 9 not appear on the ballot in the primary election. The term of each
- 10 elected director shall be not more than six years or until his or her
- 11 successor is elected and qualified. Candidates for the board of directors
- shall meet the qualifications found in sections 70-610 and 70-619.
- 13 (2) A registered voter (a) Registered voters residing within the
- 14 chartered territory, (b) residing within the incorporated or
- 15 <u>unincorporated area of a county that includes a city of the metropolitan</u>
- 16 class or a city of the primary class and in which county any portion of
- 17 <u>the chartered territory of a district with an annual gross revenue of one</u>
- 18 <u>hundred fifty million dollars or more is included, or (c)</u> and registered
- 19 voters duly certified in accordance with section 70-604.03 shall be
- 20 qualified to vote in the district as certified pursuant to section
- 21 70-611.
- 22 (3) The registered voters of a subdivision created under subsection
- 23 (1) of section 70-612 may only cast their ballots for candidates for
- 24 directors to be elected from such subdivision and for candidates for
- 25 directors to be elected at large from the whole district. The registered
- 26 voters of a subdivision created under subsection (2) or (3) of section
- 27 70-612 may only cast their ballots for candidates for directors to be
- 28 elected from such subdivision.
- 29 Sec. 2. Section 70-611, Reissue Revised Statutes of Nebraska, is
- 30 amended to read:
- 31 70-611 (1) Not later than January 5 in each even-numbered year, the

1 secretary of the district in districts grossing forty million dollars or

- 2 more annually shall certify to the Secretary of State on forms prescribed
- 3 by the Secretary of State the names of the counties in which all
- 4 registered voters are eligible to vote for public power district
- 5 candidates and for other counties the names of the election precincts
- 6 within each county, including those municipalities in which voters are
- 7 eligible to vote as provided in subsection (2) of section 32-512 and
- 8 excluding the municipalities in which voters are not eligible to vote on
- 9 public power district candidates. The secretary shall also certify the
- 10 number of directors to be elected and the length of terms for which each
- 11 is to be elected.
- 12 (2) Districts grossing less than forty million dollars annually
- 13 shall prepare the same type of certification as districts grossing over
- 14 forty million dollars annually and file such certification with the
- 15 Secretary of State not later than July 1 of each even-numbered year.
- 16 (3) The secretary of each district shall, at the time of filing the
- 17 certification, cause to be published once in a newspaper or newspapers of
- 18 general circulation within the district a list of the incumbent directors
- 19 and naming the counties or election precincts, including those
- 20 <u>municipalities in which voters are eligible to vote as provided in</u>
- 21 <u>subsection (2) of section 32-512 and</u> excluding those municipalities in
- 22 which voters are not eligible to vote for public power district
- 23 candidates, in the same general form as the certification filed with the
- 24 Secretary of State. A certified copy of the published notice shall be
- 25 filed with the Secretary of State within ten days after such publication.

- 27 Statutes of Nebraska, are repealed.
