1 A BILL FOR AN ACT relating to government regulation; to amend sections 2 59-1401, 59-1403, 59-1404, 59-1405, and 59-1406, Reissue Revised 3 Statutes of Nebraska, and sections 53-101, 53-103, 53-123.01, 4 53-123.14, 53-123.15, 53-124.11, 53-134.01, 53-164.01, 53-186.01, 53-1,100, and 53-1,104, Revised Statutes Cumulative Supplement, 5 6 2016; to define bottle club; to require licensure of bottle clubs as 7 prescribed; to require annual reports by third-party shippers as change provisions relating to 8 prescribed; to manufacturers' licenses, craft brewery licenses, and special designated licenses as 9 prescribed; to change requirements for the sale of beer by certain 10 licensees; to change provisions relating to taxation of beer; to 11 prohibit consumption of alcoholic liquor at bottle clubs 12 13 prescribed; to change penalty provisions of the Nebraska Liquor 14 Control Act; to name the Music Licensing Agency Act; to define and 15 redefine terms; to eliminate obsolete references; to provide duties; to require music licensing agencies to register with the Secretary 16 of State; to change penalties; to harmonize provisions; and to 17 18 repeal the original sections.

Section 1. Section 53-101, Revised Statutes Cumulative Supplement, 1

- shall be known and may be cited as the Nebraska Liquor Control Act. 4
- Sec. 2. Section 53-103, Revised Statutes Cumulative Supplement, 5
- 6 2016, is amended to read:
- 7 53-103 For purposes of the Nebraska Liquor Control Act, the
- definitions found in sections 53-103.01 to 53-103.46 and section 3 of 8
- 9 this act apply.
- 10 Sec. 3. Bottle club means an operation, whether formally organized
- as a club having a regular membership list, dues, officers, and meetings 11
- or not, keeping and maintaining premises where persons who have made 12
- their own purchases of alcoholic liquor congregate for the express 13
- purpose of consuming such alcoholic liquor upon the payment of a fee or 14
- 15 other consideration, including, but not limited to, other services such
- as the sale of food, ice, mixes, or other fluids for alcoholic drinks and 16
- 17 the maintenance of the space for consumption.
- A person operating a bottle club shall obtain the 18
- appropriate classification of retail license based on the type of 19
- beverages consumed. Such operation may be conducted by a club, an 20
- 21 individual, a partnership, a limited liability company, or a corporation.
- 22 An accurate and current membership list shall be maintained upon the
- premises which contains the names and residences of the members. 23
- Sec. 5. Section 53-123.01, Revised Statutes Cumulative Supplement, 24
- 25 2016, is amended to read:
- 53-123.01 (1) A manufacturer's license shall allow the manufacture, 26
- storage, and sale of alcoholic liquor to wholesale licensees in this 27
- state and to such persons outside the state as may be permitted by law, 28
- except that nothing in the Nebraska Liquor Control Act shall prohibit a 29
- manufacturer of beer from distributing tax-paid samples of beer at the 30
- premises of a licensed manufacturer for consumption on the premises. A 31

1 manufacturer's license issued pursuant to this section shall be the only

2 license required by the Nebraska Liquor Control Act for the manufacture

3 and retail sale of beer manufactured on the licensed premises for

4 consumption on the licensed premises. All alcoholic beverages purchased

5 for resale in this state prior to being resold at retail shall physically

6 <u>come into the possession of a licensed wholesaler and be unloaded into</u>

and distributed from the licensed wholesaler's warehouse located in this

8 state.

9 (2)(a) A licensee who or which first obtains a craft brewery license 10 pursuant to section 53-123.14, holds such license for not less than three years, and operates a brewpub or microbrewery on the licensed premises of 11 such craft brewery license shall obtain a manufacturer's license when the 12 13 manufacture of beer on the licensed premises exceeds twenty thousand The manufacturer's license shall authorize the 14 barrels per year. continued retail sale of beer for consumption on or off the premises but 15 only to the extent the premises were previously licensed as a craft 16 17 brewery. The sale of any beer other than beer manufactured by the licensee, wine, or alcoholic liquor for consumption on the licensed 18 19 premises shall require the appropriate retail license. Notwithstanding section 53-123.14, if the holder of a craft brewery license or 20 manufacturer's license, or any person owning an interest in such license, 21 owned an <u>interest in a retail license located off the craft brewery's or</u> 22 23 manufacturer's licensed premises or off the licensed premises of a 24 brewpub owned by the craft brewery as of January 1, 2017, such holder or 25 owner of such interest in such license may continue to own an interest in such off-site retail license but may not acquire an interest in any 26 additional off-site retail licenses. Notwithstanding subsection (1) of 27 28 this section, the holder of such craft brewery license or manufacturer's license may sell and directly deliver, to any retail location that it 29 wholly owns, any beer manufactured by such craft brewery or manufacturer 30 31 on its licensed premises The holder of such manufacturer's license may

- 1 continue to operate up to five retail locations which are in operation at
- 2 the time such manufacturer's license is issued and shall divest itself
- 3 from retail locations in excess of five locations. The licensee shall not
- 4 begin operation at any new retail location even if the licensee's
- 5 production is reduced below twenty thousand barrels per year.

- 7 catering license pursuant to section 53-124.12, a special designated

- 10 Sec. 6. Section 53-123.14, Revised Statutes Cumulative Supplement,
- 11 2016, is amended to read:
- 12 53-123.14 Any person who operates a craft brewery shall obtain a
- 13 license pursuant to the Nebraska Liquor Control Act. A license to operate
- 14 a craft brewery shall permit the production of a maximum of twenty
- 15 thousand barrels of beer per year in the aggregate from all physical
- 16 locations comprising the licensed premises. For purposes of this section,
- 17 <u>licensed premises may include up to five separate craft brewery or</u>
- 18 <u>brewpub premises.</u> A craft brewery may also sell to beer wholesalers for
- 19 sale and distribution to licensed retailers, and, except as provided in
- 20 this section and section 53-123.01, a craft brewery or any person owning
- 21 <u>an interest in a craft brewery is prohibited from owning or selling</u>
- 22 <u>directly to licensed retailers</u>. A craft brewery license issued pursuant

- 6 53-123.15 (1) No person shall order or receive alcoholic liquor in
- 7 this state which has been shipped directly to him or her from outside
- 8 this state by any person other than a holder of a shipping license issued
- 9 by the commission, except that a licensed wholesaler may receive not more
- 10 than three gallons of wine in any calendar year from any person who is
- 11 not a holder of a shipping license.
- 12 (2) The commission may issue a shipping license to a manufacturer.
- 13 Such license shall allow the licensee to ship alcoholic liquor only to a
- 14 licensed wholesaler. A person who receives a license pursuant to this
- 15 subsection shall pay the fee required in sections 53-124 and 53-124.01

- 24 purposes of distributing vintage wines, a licensed shipper must utilize a
- 25 designated wholesaler if the manufacturer has a designated wholesaler.
- 26 For purposes of this section, vintage wine shall mean a wine verified to
- 27 be ten years of age or older and not available from a primary American
- 28 source of supply. A person who receives a license pursuant to this
- 29 subsection shall pay the fee required in sections 53-124 and 53-124.01
- 30 for a vintage wine dealer's shipping license. Such fee shall be collected
- 31 by the commission and be remitted to the State Treasurer for credit to

1 the General Fund.

- 2 (4) The commission may issue a shipping license to any manufacturer who sells and ships alcoholic liquor from another state directly to a 3 consumer in this state if the manufacturer satisfies the requirements of 4 subsections (7) through (9) of this section. A manufacturer who receives 5 a license pursuant to this subsection shall pay the fee required in 6 sections 53-124 and 53-124.01 for a manufacture direct sales shipping 7 license. Such fee shall be collected by the commission and remitted to 8 9 the State Treasurer for credit to the Winery and Grape Producers Promotional Fund. 10
- (5) The commission may issue a shipping license to any retailer who 11 is licensed within or outside Nebraska, who is authorized to sell 12 alcoholic liquor at retail in the state of domicile of the retailer, and 13 who is not a manufacturer if such retailer satisfies the requirements of 14 subsections (7) through (9) of this section to ship alcoholic liquor from 15 16 another state directly to a consumer in this state. A retailer who receives a license pursuant to this subsection shall pay the fee required 17 in sections 53-124 and 53-124.01 for a retail direct sales shipping 18 license. Such fee shall be collected by the commission and remitted to 19 the State Treasurer for credit to the Winery and Grape Producers 20 Promotional Fund. 21
- (6) The application for a shipping license under subsection (2) or
 (3) of this section shall be in such form as the commission prescribes.

 The application shall contain all provisions the commission deems proper
 and necessary to effectuate the purpose of any section of the act and the
 rules and regulations of the commission that apply to manufacturers and
 shall include, but not be limited to, provisions that the applicant, in
 consideration of the issuance of such shipping license, agrees:
- 29 (a) To comply with and be bound by sections 53-162 and 53-164.01 in 30 making and filing reports, paying taxes, penalties, and interest, and 31 keeping records;

- 1 (b) To permit and be subject to all of the powers granted by section
- 2 53-164.01 to the commission or its duly authorized employees or agents
- 3 for inspection and examination of the applicant's premises and records
- 4 and to pay the actual expenses, excluding salary, reasonably attributable
- 5 to such inspections and examinations made by duly authorized employees of
- 6 the commission if within the United States; and
- 7 (c) That if the applicant violates any of the provisions of the
- 8 application or the license, any section of the act, or any of the rules
- 9 and regulations of the commission that apply to manufacturers, the
- 10 commission may suspend, cancel, or revoke such shipping license for such
- 11 period of time as it may determine.
- 12 (7) The application for a shipping license under subsection (4) or
- 13 (5) of this section shall be in such form as the commission prescribes.
- 14 The application shall require an applicant which is a manufacturer, a
- 15 craft brewery, a craft distillery, or a farm winery to identify the
- 16 brands of alcoholic liquor that the applicant is requesting the authority
- 17 to ship either into or within Nebraska. For all applicants, unless
- 18 otherwise provided in this section, the application shall contain all
- 19 provisions the commission deems proper and necessary to effectuate the
- 20 purpose of any section of the act and the rules and regulations of the
- 21 commission that apply to manufacturers or retailers and shall include,
- 22 but not be limited to, provisions that the applicant, in consideration of
- 23 the issuance of such shipping license, agrees:
- 24 (a) To comply with and be bound by sections 53-162 and 53-164.01 in

- 5 retailers, the commission may suspend, cancel, or revoke such shipping
- 6 license for such period of time as it may determine;
- 7 (d) That the applicant agrees to notify the commission of any
- 8 violations in the state in which he or she is domiciled and any
- 9 violations of the direct shipping laws of any other states. Failure to
- 10 notify the commission within thirty days after such a violation may
- 11 result in a hearing before the commission pursuant to which the license
- 12 may be suspended, canceled, or revoked; and
- 13 (e) That the applicant, if a manufacturer, craft brewery, craft
- 14 distillery, or farm winery, agrees to notify any wholesaler licensed in
- 15 Nebraska that has been authorized to distribute such brands that the
- 16 application has been filed for a shipping license. The notice shall be in
- 17 writing and in a form prescribed by the commission. The commission may
- 18 adopt and promulgate rules and regulations as it reasonably deems
- 19 necessary to implement this subdivision, including rules and regulations
- 20 that permit the holder of a shipping license under this subdivision to
- 21 amend the shipping license by, among other things, adding or deleting any
- 22 brands of alcoholic liquor identified in the shipping license.
- 23 (8) Any manufacturer or retailer who is granted a shipping license
- 24 under subsection (4) or (5) of this section shall:
- (a) Only ship the brands of alcoholic liquor identified on the
- 26 application;
- 27 (b) Only ship alcoholic liquor that is owned by the holder of the
- 28 shipping license;
- 29 (c) Only ship alcoholic liquor that is properly registered with the
- 30 Alcohol and Tobacco Tax and Trade Bureau of the United States Department
- 31 of the Treasury;

- 1 (d) Not ship any alcoholic liquor products that the manufacturers or 2 wholesalers licensed in Nebraska have voluntarily agreed not to bring 3 into Nebraska at the request of the commission;
- (e) Not ship more than nine liters of alcoholic liquor per month to any person in Nebraska to whom alcoholic beverages may be lawfully sold.

 All such sales and shipments shall be for personal consumption only and not for resale; and
- 8 (f) Cause the direct shipment of alcoholic liquor to be by approved 9 common carrier only. The commission shall adopt and promulgate rules and regulations pursuant to which common carriers may apply for approval to 10 provide common carriage of alcoholic liquor shipped by a holder of a 11 shipping license issued pursuant to subsection (4) or (5) of this 12 section. The rules and regulations shall include provisions that require 13 (i) the recipient to demonstrate, upon delivery, that he or she is at 14 least twenty-one years of age, (ii) the recipient to sign an electronic 15 16 or paper form or other acknowledgment of receipt as approved by the 17 commission, and (iii) the commission-approved common carrier to submit to the commission such information as the commission may prescribe. The 18 19 commission-approved common carrier shall refuse delivery when proposed recipient appears to be under the age of twenty-one years and 20 refuses to present valid identification. All holders of shipping licenses 21 shipping alcoholic liquor pursuant to this subdivision shall affix a 22 23 conspicuous notice in sixteen-point type or larger to the outside of each 24 package of alcoholic liquor shipped within or into the State of Nebraska, 25 in a conspicuous location, stating: CONTAINS ALCOHOLIC BEVERAGES; SIGNATURE OF PERSON AT LEAST 21 YEARS OF AGE REQUIRED FOR DELIVERY. Any 26 delivery of alcoholic beverages to a minor by a common carrier shall 27 28 constitute a violation by the common carrier. The common carrier and the holder of the shipping license shall be liable only for their independent 29 30 acts.
- 31 (9) For purposes of sections 53-160, 77-2703, and 77-27,142, each

- 1 shipment of alcoholic liquor by the holder of a shipping license under
- 2 subsection (3), (4), or (5) of this section shall constitute a sale in
- 3 Nebraska by establishing a nexus in the state. The holder of the shipping
- 4 license shall collect all the taxes due to the State of Nebraska and any
- 5 political subdivision and remit any excise taxes monthly to the
- 6 commission and any sales taxes to the Department of Revenue.
- 7 (10) A third-party shipper shall file an annual report with the
- 8 commission, in the form and manner prescribed by the commission,
- 9 regarding shipments of alcohol the third-party shipper has made into the
- 10 state By July 1, 2014, the commission shall report to the General Affairs
- 11 Committee of the Legislature the number of shipping licenses issued for
- 12 <u>license years 2013-14 and 2014-15. The report shall be made</u>
- 13 electronically.
- 14 Sec. 8. Section 53-124.11, Revised Statutes Cumulative Supplement,
- 15 2016, is amended to read:
- 16 53-124.11 (1) The commission may issue a special designated license
- 17 for sale or consumption of alcoholic liquor at a designated location to a
- 18 retail licensee, a craft brewery licensee, a microdistillery licensee, a
- 19 farm winery licensee, the holder of a manufacturer's license issued
- 20 pursuant to subsection (2) of section 53-123.01, a municipal corporation,
- 21 a fine arts museum incorporated as a nonprofit corporation, a religious
- 22 nonprofit corporation which has been exempted from the payment of federal
- 23 income taxes, a political organization which has been exempted from the
- 24 payment of federal income taxes, or any other nonprofit corporation the
- 25 purpose of which is fraternal, charitable, or public service and which
- 26 has been exempted from the payment of federal income taxes, under
- 27 conditions specified in this section. The applicant shall demonstrate
- 28 meeting the requirements of this subsection.
- 29 (2) No retail licensee, craft brewery licensee, microdistillery
- 30 licensee, farm winery licensee, holder of a manufacturer's license issued
- 31 pursuant to subsection (2) of section 53-123.01, organization, or

1 corporation enumerated in subsection (1) of this section may be issued a

- 2 special designated license under this section for more than six calendar
- 3 days in any one calendar year, and not more than twelve special
- 4 designated licenses shall be issued to any licensee in any calendar year.
- 5 Only one special designated license shall be required for any application
- 6 for two or more consecutive days. This subsection shall not apply to any
- 7 holder of a catering license.
- 8 (3) Except for any special designated license issued to a holder of a catering license, there shall be a fee of forty dollars for each day 9 identified in the special designated license. Such fee shall be submitted 10 with the application for the special designated license, collected by the 11 commission, and remitted to the State Treasurer for credit to the General 12 13 Fund. The applicant shall be exempt from the provisions of the Nebraska Liquor Control Act requiring an application or renewal fee and the 14 provisions of the act requiring the expiration of forty-five days from 15 the time the application is received by the commission prior to the 16 17 issuance of a license, if granted by the commission. The retail licensees, craft brewery licensees, microdistillery licensees, farm 18 winery licensees, holders of manufacturer's licenses issued pursuant to 19 subsection (2) of section 53-123.01, municipal 20 corporations, organizations, and nonprofit corporations enumerated in subsection (1) of 21 this section seeking a special designated license shall file an 22 application on such forms as the commission may prescribe. Such forms 23 24 shall contain, along with other information as required by the commission, (a) the name of the applicant, (b) the premises for which a 25 special designated license is requested, identified by street and number 26 if practicable and, if not, by some other appropriate description which 27 definitely locates the premises, (c) the name of the owner or lessee of 28 the premises for which the special designated license is requested, (d) 29 sufficient evidence that the holder of the special designated license, if 30 issued, will carry on the activities and business authorized by the 31

- license for himself, herself, or itself and not as the agent of any other person, group, organization, or corporation, for profit or not for profit, (e) a statement of the type of activity to be carried on during the time period for which a special designated license is requested, and
- 5 (f) sufficient evidence that the activity will be supervised by persons 6 or managers who are agents of and directly responsible to the holder of
- 7 the special designated license.
- 8 (4) No special designated license provided for by this section shall be issued by the commission without the approval of the local governing 9 body. The local governing body may establish criteria for approving or 10 denying a special designated license. The local governing body may 11 designate an agent to determine whether a special designated license is 12 to be approved or denied. Such agent shall follow criteria established by 13 the local governing body in making his or her determination. The 14 determination of the agent shall be considered the determination of the 15 16 local governing body unless otherwise provided by the local governing body. For purposes of this section, the local governing body shall be the 17 city or village within which the premises for which the special 18 designated license is requested are located or, if such premises are not 19 within the corporate limits of a city or village, then the local 20 governing body shall be the county within which the premises for which 21 the special designated license is requested are located. 22
- (5) If the applicant meets the requirements of this section, a 23 24 special designated license shall be granted and issued by the commission for use by the holder of the special designated license. All statutory 25 provisions and rules and regulations of the commission that apply to a 26 retail licensee shall apply to the holder of a special designated license 27 with the exception of such statutory provisions and rules and regulations 28 of the commission so designated by the commission and stated upon the 29 issued special designated license, except that the commission may not 30 designate exemption of sections <u>53-123.01</u> to <u>53-123.03</u>, <u>53-123.14</u>, 31

- 1 53-169, and 53-180 to 53-180.07. The commission shall not designate
- 2 <u>exemption of statutes, rules, and regulations except upon a showing of</u>
- 3 substantial need and undue hardship. The decision of the commission shall
- 4 be final. If the applicant does not qualify for a special designated

- 6 (6) A special designated license issued by the commission shall be
- 7 mailed or delivered to the city, village, or county clerk who shall
- 8 deliver such license to the licensee upon receipt of any fee or tax
- 9 imposed by such city, village, or county.

- 11 2016, is amended to read:
- 12 53-134.01 (1) The holder of a Class C license may obtain a limited
- 13 bottling endorsement for such license as prescribed in this section. The
- 14 endorsement shall be issued for the same period and may be renewed in the
- 15 same manner as the Class C license. A limited bottling endorsement may
- 16 not be used in conjunction with a special designated license.
- 17 (2) A licensee desiring to obtain a limited bottling endorsement for
- 18 a license shall file with the commission an application upon such forms
- 19 as the commission prescribes and a fee of three hundred dollars payable
- 20 to the commission.
- 21 (3) The holder of a limited bottling endorsement may sell beer for
- 22 consumption off the licensed premises in sealed containers filled as

- 2 is visibly apparent whether the sealed container has been tampered with
- 3 or opened or seals the container and places the container in a bag
- 4 designed so that it is visibly apparent whether the sealed container has
- 5 been tampered with or opened; and
- 6 (d) The licensee provides a dated receipt to the customer and
- 7 attaches a copy of the dated receipt to the sealed container or, if the
- 8 sealed container is placed in a bag, to the bag.

- 10 2016, is amended to read:
- 11 53-164.01 Payment of the tax provided for in section 53-160 on
- 12 alcoholic liquor shall be paid by the manufacturer or wholesaler as
- 13 follows:
- 14 (1)(a) All manufacturers or wholesalers, except farm winery
- 15 producers, whether inside or outside this state shall, on or before the
- 16 twenty-fifth day of each calendar month following the month in which
- 17 shipments were made, submit a report to the commission upon forms
- 18 furnished by the commission showing the total amount of alcoholic liquor
- 19 in gallons or fractional parts thereof shipped by such manufacturer or
- 20 wholesaler, whether inside or outside this state, during the preceding
- 21 calendar month;
- 22 (b) All beer wholesalers shall, on or before the twenty-fifth day of
