# **LEGISLATIVE BILL 644**

Introduced by McDonnell, 5.

Read first time January 18, 2023

### Committee:

- A BILL FOR AN ACT relating to the Site and Building Development Fund; to
  amend sections 81-12,146, 81-12,147, 81-12,148, 81-12,150, and
  84-612, Revised Statutes Cumulative Supplement, 2022; to provide for
  a transfer of funds; to change provisions related to use of the Site
  and Building Development Fund; to provide powers and duties for the
  Department of Economic Development for certain projects; to repeal
  the original sections; and to declare an emergency.
- 8 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 81-12,146, Revised Statutes Cumulative
- 2 Supplement, 2022, is amended to read:
- 3 81-12,146 (1) The Site and Building Development Fund is created. The
- 4 fund shall receive money pursuant to section 76-903 and may include
- 5 revenue from transfers by the Legislature, grants, private contributions,
- 6 repayment of loans, and all other sources. The Department of Economic
- 7 Development, as part of its comprehensive business development strategy,
- 8 shall administer the fund. Any money in the fund available for investment
- 9 shall be invested by the state investment officer pursuant to the
- 10 Nebraska Capital Expansion Act and the Nebraska State Funds Investment
- 11 Act.
- 12 (2) It is the intent of the Legislature to transfer five million
- 13 dollars from the General Fund to the Site and Building Development Fund
- 14 for fiscal year 2022-23 and five million dollars from the General Fund to
- 15 the Site and Building Development Fund for fiscal year 2023-24. Such
- 16 money shall be placed in a subaccount of the Site and Building
- 17 Development Fund and earmarked for use to fund large shovel-ready
- 18 commercial and industrial sites developed under the Municipal Inland Port
- 19 Authority Act.
- 20 (3) It is the intent of the Legislature to transfer eighty million
- 21 <u>dollars from the Cash Reserve Fund to the Site and Building Development</u>
- 22 Fund for fiscal year 2023-24 and eighty million dollars from the Cash
- 23 Reserve Fund to the Site and Building Development Fund for fiscal year
- 24 2024-25. Such money shall be placed in a subaccount of the Site and
- 25 Building Development Fund and earmarked for use to support identifying,
- 26 <u>evaluating</u>, and <u>developing large commercial and industrial sites and</u>
- 27 building infrastructure to attract major investment and employment
- 28 opportunities for advanced manufacturing, processing, trade, technology,
- 29 <u>aerospace</u>, <u>automotive</u>, <u>clean energy</u>, <u>life science industries</u>, <u>and other</u>
- 30 <u>transformational industries in Nebraska.</u>
- 31 Sec. 2. Section 81-12,147, Revised Statutes Cumulative Supplement,

- 1 2022, is amended to read:
- 2 81-12,147 (1) Except as provided in subsection (2) or (3) of this
- 3 section, the Department of Economic Development shall use the Site and
- 4 Building Development Fund to finance loans, grants, subsidies, credit
- 5 enhancements, and other financial assistance for industrial site and
- 6 building development and for expenses of the department as appropriated
- 7 by the Legislature for administering the fund. The following activities
- 8 are eligible for assistance from the fund:
- 9 (a) Grants or zero-interest loans to villages, cities, or counties
- 10 to acquire land, infuse infrastructure, or otherwise make large sites and
- 11 buildings ready for industrial development;
- 12 (b) Matching funds for new construction, rehabilitation, or
- 13 acquisition of land and buildings to assist villages, cities, and
- 14 counties;
- 15 (c) Technical assistance, design and finance services, and
- 16 consultation for villages, cities, and counties for the preparation and
- 17 creation of industrial-ready sites and buildings;
- 18 (d) Loan guarantees for eligible projects;
- 19 (e) Projects making industrial-ready sites and buildings more
- 20 accessible to business and industry;
- 21 (f) Infrastructure projects necessary for the development of
- 22 industrial-ready sites and buildings;
- 23 (g) Projects that mitigate the economic impact of a closure or
- 24 downsizing of a private-sector entity by making necessary improvements to
- 25 buildings and infrastructure;
- 26 (h) Public and private sector initiatives that will improve the
- 27 military value of military installations by making necessary improvements
- 28 to buildings and infrastructure, including, but not limited to, a grant
- 29 for the establishment of the United States Strategic Command Nuclear
- 30 Command, Control, and Communications public-private-partnership facility;
- 31 and

- 1 (i) Grants to any city of the second class which partners with 2 public power utilities for purposes of expanding electrical system
- 3 capacities and enhancing redundancy and resilience.
- 4 (2) The Department of Economic Development shall use the subaccount 5 of the Site and Building Development Fund described in subsection (2) of
- 6 section 81-12,146 to provide financial assistance to any inland port
- 7 authority created under the Municipal Inland Port Authority Act to help
- 8 finance large shovel-ready commercial and industrial sites developed
- 9 under such act.
- 10 (3)(a) The Department of Economic Development shall use the
- 11 <u>subaccount of the Site and Building Development Fund described in</u>
- 12 <u>subsection (3) of section 81-12,146 to support identifying, evaluating,</u>
- 13 and developing large commercial and industrial sites and building
- 14 infrastructure to attract major investment and employment opportunities
- 15 for advanced manufacturing, processing, trade, technology, aerospace,
- 16 <u>automotive</u>, <u>clean energy</u>, <u>life science industries</u>, <u>and other</u>
- 17 <u>transformational industries in Nebraska.</u>
- 18 (b) Large commercial and industrial sites and building
- 19 <u>infrastructure should be capable of supporting businesses and business</u>
- 20 <u>development that at a minimum meets the requirements of subdivision (1)</u>
- 21 (b) of section 77-6831.
- 22 (c) The department may use the funds from the Site and Building
- 23 <u>Development Fund subaccount described in subsection (3) of section</u>
- 24 81-12,146 to provide the following assistance to support, identify,
- 25 evaluate, and develop large commercial and industrial sites and building
- 26 infrastructure: Finance loans, provide grants, subsidies, or credit
- 27 <u>enhancements</u>, and provide other financial assistance to eligible
- 28 entities.
- 29 <u>(d) The following entities are eligible for assistance from the</u>
- 30 subaccount described in subsection (3) of section 81-12,146: Political
- 31 subdivisions, inland port authorities created under the Municipal Inland

1 Port Authority Act, nonprofit economic development organizations, or

- 2 <u>other nonprofit organizations.</u>
- 3 (e) It is the intent of Legislature that the Department of Economic
- 4 Development provide assistance from the subaccount described in
- 5 subsection (3) of section 81-12,146 to eliqible entities in support of
- 6 developing large commercial and industrial sites and building
- 7 infrastructure. Eligible entities shall apply to the Department of
- 8 Economic Development in a form and manner developed by the Director of
- 9 <u>Economic Development</u>. The <u>Department of Economic Development shall</u>
- 10 evaluate the merits off applications from eligible entities.
- 11 (f) Up to five million dollars in FY2023-24 and up to five million
- 12 <u>dollars in FY2024-25 transferred to the subaccount of the Site and</u>
- 13 Building Development Fund described in subsection (3) of section
- 14 <u>81-12,146 may be used by the Department of Economic Development to hire</u>
- 15 additional staff, make expenditures for travel, partner with political

- 21 five million dollars in FY2024-25 transferred to the subaccount of the
- 22 Site and Building Development Fund described in subsection (3) of section
- 23 81-12,146 may be used by the Department of Economic Development to
- 24 support projects pursuant to subsection (1) of section 81-12,147.
- 25 Sec. 3. Section 81-12,148, Revised Statutes Cumulative Supplement,
- 26 2022, is amended to read:
- 27 81-12,148 (1) Governmental subdivisions and Nebraska nonprofit
- 28 organizations are eligible to receive assistance under the Site and
- 29 Building Development Act. Any entity receiving assistance under
- 30 subsection (1) of section 81-12,147 shall provide, or cause to be
- 31 provided, matching funds for the eligible activity in an amount

- 1 determined by the Department of Economic Development, which amount shall
- 2 be at least equal to one hundred percent of the amount of assistance
- 3 provided by the Site and Building Development Fund. Nothing in the act
- 4 shall be construed to allow individuals or businesses to receive direct

- 24 Nebraska Capital Construction Fund on or after July 1, 2022, but before
- 25 June 15, 2023, on such dates and in such amounts as directed by the
- 26 budget administrator of the budget division of the Department of
- 27 Administrative Services.
- 28 (6) The State Treasurer shall transfer fifty-three million five
- 29 hundred thousand dollars from the Cash Reserve Fund to the Perkins County
- 30 Canal Project Fund on or before June 30, 2023, on such dates and in such
- 31 amounts as directed by the budget administrator of the budget division of

- 1 the Department of Administrative Services.
- 2 (7) No funds shall be transferred from the Cash Reserve Fund to
- 3 fulfill the obligations created under the Nebraska Property Tax Incentive
- 4 Act unless the balance in the Cash Reserve Fund after such transfer will
- 5 be at least equal to five hundred million dollars.
- 6 (8) The State Treasurer shall transfer thirty million dollars from
- 7 the Cash Reserve Fund to the Military Base Development and Support Fund
- 8 on or before June 30, 2023, but not before July 1, 2022, on such dates
- 9 and in such amounts as directed by the budget administrator of the budget
- 10 division of the Department of Administrative Services.
- 11 (9) The State Treasurer shall transfer eight million three hundred
- 12 thousand dollars from the Cash Reserve Fund to the Trail Development and
- 13 Maintenance Fund on or after July 1, 2022, but before July 30, 2022, on
- 14 such dates and in such amounts as directed by the budget administrator of
- 15 the budget division of the Department of Administrative Services.
- 16 (10) The State Treasurer shall transfer fifty million dollars from
- 17 the Cash Reserve Fund to the Nebraska Rural Projects Fund on or after
- 18 July 1, 2022, but before July 15, 2023, on such dates and in such amounts
- 19 as directed by the budget administrator of the budget division of the
- 20 Department of Administrative Services.
- 21 (11) The State Treasurer shall transfer thirty million dollars from
- 22 the Cash Reserve Fund to the Rural Workforce Housing Investment Fund on
- 23 or after July 1, 2022, but before July 15, 2023, on such dates and in
- 24 such amounts as directed by the budget administrator of the budget
- 25 division of the Department of Administrative Services.
- 26 (12) The State Treasurer shall transfer twenty million dollars from
- 27 the Cash Reserve Fund to the Intern Nebraska Cash Fund on or after July
- 28 1, 2022, but before June 15, 2023, on such dates and in such amounts as
- 29 directed by the budget administrator of the budget division of the
- 30 Department of Administrative Services.
- 31 (13) The State Treasurer shall transfer twenty million dollars from

- 1 the Cash Reserve Fund to the Middle Income Workforce Housing Investment
- 2 Fund on July 15, 2022, or as soon thereafter as administratively
- 3 possible, and in such amounts as directed by the budget administrator of
- 4 the budget division of the Department of Administrative Services.
- 5 (14) The State Treasurer shall transfer eighty million dollars from
- 6 the Cash Reserve Fund to the Jobs and Economic Development Initiative
- 7 Fund on or after July 1, 2022, but before July 15, 2023, on such dates
- 8 and in such amounts as directed by the budget administrator of the budget
- 9 division of the Department of Administrative Services.
- 10 (15) The State Treasurer shall transfer twenty million dollars from
- 11 the Cash Reserve Fund to the Site and Building Development Fund on July
- 12 15, 2022, or as soon thereafter as administratively possible, and in such
- 13 amounts as directed by the budget administrator of the budget division of
- 14 the Department of Administrative Services.
- 15 (16) The State Treasurer shall transfer fifty million dollars from
- 16 the Cash Reserve Fund to the Surface Water Irrigation Infrastructure Fund
- 17 on or after July 15, 2022, but before January 1, 2023, on such dates and
- 18 in such amounts as directed by the budget administrator of the budget
- 19 division of the Department of Administrative Services.
- 20 (17) The State Treasurer shall transfer fifteen million dollars from
- 21 the Cash Reserve Fund to the Site and Building Development Fund on or
- 22 before June 30, 2022, on such dates and in such amounts as directed by
- 23 the budget administrator of the budget division of the Department of
- 24 Administrative Services.
- 25 (18) The State Treasurer shall transfer fifty-five million dollars
- 26 from the Cash Reserve Fund to the Economic Recovery Contingency Fund on
- 27 or before June 30, 2022, on such dates and in such amounts as directed by
- 28 the budget administrator of the budget division of the Department of
- 29 Administrative Services.
- 30 (19) The State Treasurer shall transfer one hundred sixty million
- 31 dollars from the Cash Reserve Fund to the Site and Building Development

- 1 Fund on or after July 15, 2023, on such dates and in such amounts as
- 2 <u>directed by the budget administrator of the budget division of the</u>
- 3 <u>Department of Administrative Services.</u>
- 4 Sec. 6. Original sections 81-12,146, 81-12,147, 81-12,148,
- 5 81-12,150, and 84-612, Revised Statutes Cumulative Supplement, 2022, are
- 6 repealed.
