1	A BILL FOR AN ACT relating to the Disabled Persons and Family Support
2	Act; to amend sections 68-1502, 68-1504, 68-1505, 68-1506, 68-1508,
3	68-1509, 68-1510, 68-1511, 68-1512, 68-1513, 68-1515, 68-1516, and
4	68-1519, Reissue Revised Statutes of Nebraska, and section 68-1518,
5	Revised Statutes Cumulative Supplement, 2014; to provide financial
6	compensation for care given by families at home as prescribed; to
7	harmonize provisions; and to repeal the original sections.

8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 68-1502, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 68-1502 The Legislature finds and declares that:
- 4 (1) The family is vital to the fundamental development of each
- 5 person in the State of Nebraska;
- 6 (2) A growing number of families are searching for ways to provide
- 7 for disabled family members in the home rather than placing them in state
- 8 or private institutional or residential facilities;
- 9 (3) Employable disabled persons should be encouraged to engage in
- 10 employment and ultimately become self-supporting;
- 11 (4) Necessary services <u>and financial compensation for caregiving</u>
- 12 should be available to families caring for a disabled family member so
- 13 that disabled persons may remain in the home, obtain employment if
- 14 possible, and maintain a more independent form of living;
- 15 (5) The State of Nebraska should make every effort to preserve the
- 16 family unit, to insure that decisions of providing for a disabled person
- 17 are based on the best interests of the disabled person and the family,
- 18 and to provide services to disabled persons which promote independent
- 19 living and employability; and
- 20 (6) The State of Nebraska should promote cost-effective health care
- 21 alternatives for disabled persons.
- 22 Sec. 2. Section 68-1504, Reissue Revised Statutes of Nebraska, is
- 23 amended to read:
- 24 68-1504 The department may provide support to families providing for
- 25 a disabled member in the home and to disabled persons in independent
- 26 living situations. Such support may be made available to compensate for
- 27 present and future expenses, including, but not limited to:
- 28 (1) The purchase or lease of special equipment or architectural
- 29 modifications of a home made to improve or facilitate the care,
- 30 treatment, therapy, general living conditions, or access of the disabled
- 31 person;

- 1 (2) Medical, surgical, therapeutic, diagnostic, and other health 2 services related to the disability or disabilities of the disabled 3 person;
- 4 (3) Counseling or training programs which assist the family in 5 providing proper care for the disabled family member or assist the 6 disabled person in an independent living situation and which provide for 7 the special needs of the family or disabled person;
- 8 (4) Attendant care, respite care, home health aid services,
 9 homemaker services, and chore services which provide assistance with
 10 training, routine body functions, dressing, preparation, consumption of
 11 food, and ambulation as well as providing respite assistance to the
 12 family;
- 13 (5) Transportation services for the disabled person; and
- (6) Transportation, room, and board costs incurred by the family or disabled person during evaluations or treatment of the disabled family member which receive prior approval from the department; and -
- 17 <u>(7) Financial compensation for care given by families at home to a</u>
 18 <u>disabled family member when eligible under section 68-1505.</u>
- 19 Sec. 3. Section 68-1505, Reissue Revised Statutes of Nebraska, is 20 amended to read:
- 68-1505 Families may be eligible to receive support or financial 21 22 compensation for caregiving pursuant to the Disabled Persons and Family Support Act sections 68-1501 to 68-1519 if the family (1) resides in the 23 24 State of Nebraska, (2) has a family member who is disabled and is (a) 25 living at home or (b) residing in a state or private institutional or residential facility but could return home under the act sections 68-1501 26 27 to 68-1519, and (3)(a) has insufficient income to provide for the total 28 cost of care for the disabled family member, (b) an out-of-home placement has been attempted and failed and care at home is possible, or (c) the 29 cost of care by the family at home will be less than the cost to the 30 state for institutional care. The caregiver shall receive financial 31

- 1 compensation at an equal or higher rate than a salaried state employee
- 2 <u>receives for similar work done at a state facility. The caregiver and his</u>
- 3 or her family shall be eligible for health insurance as if the caregiver
- 4 is a full-time state employee.
- 5 Sec. 4. Section 68-1506, Reissue Revised Statutes of Nebraska, is
- 6 amended to read:
- 7 68-1506 A disabled person in an independent living situation may be
- 8 eligible to receive support pursuant to the Disabled Persons and Family
- 9 Support Act sections 68-1501 to 68-1519 if the person (1) is a resident
- 10 of the State of Nebraska, (2) requires care to remain within an
- 11 independent living situation, and (3) has insufficient income to provide
- 12 for the total cost of such care.
- 13 Sec. 5. Section 68-1508, Reissue Revised Statutes of Nebraska, is
- 14 amended to read:
- 15 68-1508 The department may allocate costs for programs and services
- 16 between the department and the family or the disabled person in an
- 17 independent living situation. Such cost allocation shall be based on the
- 18 need for support pursuant to the Disabled Persons and Family Support Act
- 19 sections 68-1501 to 68-1519 and shall not be based on income guidelines
- 20 or fee schedules established for other programs administered by the
- 21 department.
- 22 Sec. 6. Section 68-1509, Reissue Revised Statutes of Nebraska, is
- 23 amended to read:
- 24 68-1509 The department, in considering the needs and eligibility
- 25 criteria of families and disabled persons, shall consider various
- 26 factors, including, but not limited to:
- 27 (1) Total family income, except that the amount which the spouse may
- 28 designate as provided in section 68-922 shall be excluded in determining
- 29 total family income per month;
- 30 (2) The cost of providing supplemental services to the family or the
- 31 disabled person;

1 (3) The need for each program or service received by the family or

- 2 the disabled person;
- 3 (4) The eligibility of the family or the disabled person for other
- 4 support programs;
- 5 (5) The costs of providing for the family or the disabled person in
- 6 an independent living situation, notwithstanding the special
- 7 circumstances of providing for a disabled person;
- 8 (6) The number of persons in the family;—and
- 9 (7) The availability of insurance to cover the cost of needed
- 10 programs and services; and -
- 11 (8) The most economical care that is in the best interests of the
- 12 <u>disabled person, including financial compensation for care given by</u>
- 13 <u>families to a disabled family member at home.</u>
- 14 If assets have been designated for an individual in accordance with
- 15 section 68-922, such assets shall not be considered in determining the
- 16 eligibility for support of the individual's disabled spouse.
- 17 Sec. 7. Section 68-1510, Reissue Revised Statutes of Nebraska, is
- 18 amended to read:
- 19 68-1510 The support and financial compensation for caregiving
- 20 available under the Disabled Persons and Family Support Act sections
- 21 68-1501 to 68-1519 shall be supplemental to other support programs for
- 22 which the family or disabled person is eligible and is not intended to
- 23 reduce the responsibility for the provision of services and support by
- 24 such other programs. The department shall (1) determine whether any
- 25 request under the act sections 68-1501 to 68-1519 is appropriate to and
- 26 available from other support programs, (2) deny any request if the
- 27 requested assistance is appropriate to and available from other support
- 28 programs and such assistance is in the best interests of the disabled
- 29 person, and (3) provide information and referral to all families and
- 30 disabled persons whose request for assistance was denied pursuant to this
- 31 section on the procedure for applying for other appropriate and available

- 1 support programs.
- 2 Sec. 8. Section 68-1511, Reissue Revised Statutes of Nebraska, is
- 3 amended to read:
- 4 68-1511 The department may, by agreement with the head of the family
- 5 or disabled person, provide support pursuant to the Disabled Persons and
- 6 Family Support Act sections 68-1501 to 68-1519 (1) directly to the family
- 7 or the disabled person, or (2) directly to qualified programs and
- 8 services. The department shall assist each family or disabled person
- 9 receiving support under the act sections 68-1501 to 68-1519 in locating
- 10 qualified programs and services. The family or the disabled person may be
- 11 required to be responsible for contracting for those programs and
- 12 services which the department approves and shall furnish the department a
- 13 copy of each contract. The family or the disabled person may compensate
- 14 the providers of such programs and services directly. Providers of
- 15 programs and services shall be required to comply with all standards
- 16 established by the department for participation pursuant to the act
- 17 sections 68-1501 to 68-1519.
- 18 Sec. 9. Section 68-1512, Reissue Revised Statutes of Nebraska, is
- 19 amended to read:
- 20 68-1512 (1) Except as provided in subsection (2) of this section,
- 21 <u>the</u> The maximum support allowable under <u>the Disabled Persons and Family</u>
- 22 Support Act sections 68-1501 to 68-1519 shall be $(\underline{a} \ 1)$ three hundred
- 23 dollars per month per disabled person averaged over any one-year period
- 24 or $(\underline{b} \ 2)$ three hundred dollars per month per family averaged over any
- 25 one-year period for the first disabled family member plus one hundred
- 26 fifty dollars per month averaged over any one-year period for each
- 27 additional disabled family member. The department shall not provide
- 28 support, pursuant to the act sections 68-1501 to 68-1519, to any family
- 29 or disabled person whose gross income less the cost of medical or other
- 30 care specifically related to the disability exceeds the median family
- 31 income for a family of four in Nebraska, except that the department shall

- 1 make adjustments for the actual size of the family.
- 2 (2) The limitations in subsection (1) of this section do not apply
- 3 <u>to financial compensation for care given by families at home to a</u>
- 4 disabled family member eligible under section 68-1505.
- 5 Sec. 10. Section 68-1513, Reissue Revised Statutes of Nebraska, is
- 6 amended to read:
- 7 68-1513 The department shall review the needs of each family or
- 8 disabled person receiving support under the Disabled Persons and Family
- 9 Support Act sections 68-1501 to 68-1519 on a regular basis, as
- 10 established by the department, or upon the showing of a change of
- 11 circumstances by the head of the family.
- 12 Sec. 11. Section 68-1515, Reissue Revised Statutes of Nebraska, is
- 13 amended to read:
- 14 68-1515 The department shall adopt and promulgate rules and
- 15 regulations, as necessary, to implement the Disabled Persons and Family
- 16 Support Act sections 68-1501 to 68-1519, including:
- 17 (1) Standards and procedures for determining approval of qualified
- 18 programs and services to participate under the act sections 68-1501 to
- 19 68-1519;
- 20 (2) Identification of the need for programs and services of families
- 21 providing for a disabled family member in the home or of disabled persons
- 22 in an independent living situation;
- 23 (3) Identification of the need for support to families and disabled
- 24 persons or for financial compensation for care given by families at home
- 25 to a disabled family member and procedures for the provision of such
- 26 <u>support or financial compensation</u> support under the act sections 68-1501
- 27 to 68-1519;
- 28 (4) Procedures for review of each family or disabled person
- 29 receiving support under the act sections 68-1501 to 68-1519;
- 30 (5) Procedures and guidelines for determining priorities,
- 31 eligibility standards, and eligibility criteria for the selection of

- 3 (6) Procedures and guidelines for determining when support pursuant
- 4 to the act sections 68-1501 to 68-1519 would be a duplication of support
- 5 from other support programs or would result in excessive support to a
- 6 family or disabled person; and
- 7 (7) When applicable, an An annual determination of the family income
- 8 guidelines necessary to carry out the provisions of section 68-1512. Such
- 9 guidelines shall be based on population, per capita income, and other
- 10 data provided by the United States Department of Commerce, Bureau of the
- 11 Census.
- 12 Sec. 12. Section 68-1516, Reissue Revised Statutes of Nebraska, is
- 13 amended to read:
- 14 68-1516 The department shall begin providing support pursuant to
- 15 sections 68-1501 to 68-1519 on July 1, 1982. From July 1, 1982, to July
- 16 1, 1986, the department shall provide support on a priority basis to
- 17 families and disabled persons eligible to receive support pursuant to
- 18 sections 68-1501 to 68-1519. The department shall give priority to those
- 19 families providing for a severely or multiple disabled family member and
- 20 to severely or multiple disabled persons in independent living
- 21 situations. Priority shall also be given to those families and disabled
- 22 persons (1) with the greatest need for support and financial compensation
- 23 <u>for caregiving</u> to maintain the disabled person in the family home or
- 24 independent living situation, (2) who have the greatest possibility of
- 25 maintaining the disabled person in the home or independent living
- 26 situation on a continual basis, and (3) who demonstrate that support
- 27 pursuant to the <u>Disabled Persons and Family Support Act</u> sections 68-1501
- 28 to 68-1519 will provide the most cost-effective form of care for the
- 29 disabled person.
- 30 Sec. 13. Section 68-1518, Revised Statutes Cumulative Supplement,
- 31 2014, is amended to read:

- 1 68-1518 The department shall file an annual report with the Governor
- 2 and the Clerk of the Legislature on or before January 1 of each year
- 3 beginning January 1, 1983. The report submitted to the Clerk of the
- 4 Legislature shall be submitted electronically. Such report shall include:
- 5 (1) The number of families and disabled persons applying for
- 6 support, including financial compensation for caregiving, pursuant to the
- 7 Disabled Persons and Family Support Act and the number of families and
- 8 disabled persons receiving support pursuant to the act;
- 9 (2) The types of services and programs being applied for and those
- 10 being provided through the act;
- 11 (3) The effects of the support, including financial compensation for
- 12 <u>caregiving</u>, provided under the act on the disabled and their families;
- 13 and
- 14 (4) Any proposals for amendment of the act.

- 17 68-1519 Any person who by means of a willfully false statement or
- 18 representation, or by impersonation or other device, obtains or attempts
- 19 to obtain, or who aids or abets any other person in obtaining support
- 20 under the Disabled Persons and Family Support Act sections 68-1501 to
- 21 68-1519 shall, upon conviction thereof, be punished pursuant to section
- 22 68-1017.
