- 4 Be it enacted by the people of the State of Nebraska,

Section 1. Section 79-807, Revised Statutes Cumulative Supplement,
 2020, is amended to read:

3 79-807 For purposes of sections 79-806 to 79-815, unless the context
4 otherwise requires:

5 (1) Basic skills competency means either:

6 (a) <u>Proficiency proficiency</u> in (i) the written use of the English 7 language, (ii) reading, comprehending, and interpreting professional 8 writing and other written materials, and (iii) working with fundamental 9 mathematical computations as demonstrated by successful completion of an 10 examination <u>or coursework</u> designated by the board; or

(b) <u>Successful</u> successful employment experiences;

(2) Board means the State Board of Education;

(3) Certificate means an authorization issued by the commissioner to
an individual who meets the qualifications to engage in teaching,
providing special services, or administering in prekindergarten through
grade twelve in the elementary and secondary schools in this state;

(4) Commissioner means the Commissioner of Education;

(5) Department means the State Department of Education;

(6) Human relations training means course work or employment 19 experiences that lead to (a) an awareness and understanding of the 20 values, lifestyles, contributions, and history of a pluralistic society, 21 22 (b) the ability to recognize and deal with dehumanizing biases, limited to, sexism, racism, 23 including, but not prejudice, and 24 discrimination, and an awareness of the impact such biases have on interpersonal relations, (c) the ability to translate knowledge of human 25 relations into attitudes, skills, and techniques which result 26 in favorable experiences for students, (d) the ability to recognize the ways 27 28 in which dehumanizing biases may be reflected in instructional materials, (e) respect for human dignity and individual rights, and (f) the ability 29 to relate effectively to other individuals and to groups in a pluralistic 30 society other than the applicant's own; 31

1 (7) Special education training means course work or employment experiences that provide an individual with the knowledge of (a) the 2 exceptional needs of the disabilities defined under the Special Education 3 Act, (b) the major characteristics of each disability in order to 4 recognize its existence in children, (c) the various alternatives for 5 least restrictive environment for children 6 providing the with disabilities, (d) methods of teaching children with disabilities in the 7 regular classroom, and (e) prereferral alternatives, referral systems, 8 9 multidisciplinary team responsibilities, the individualized education plan process, and the placement process; 10

(8) Special services means supportive services provided to students that do not primarily involve teaching, including, but not limited to, (a) audiology, psychology, and physical or occupational therapy, (b) the coaching of extracurricular activities, and (c) subject areas for which endorsement programs are not offered by a standard institution of higher education; and

(9) Standard institution of higher education means any college or university, the teacher education programs of which are fully approved by the board or approved in another state pursuant to standards which are comparable and equivalent to those set by the board.
